Dofflemyer: This is Captain Nikki Dofflemyer with the Department of Public

Protection's Internal Affairs Unit. Ah today's date is the 6th of October, 2011 the time is approximately 1015 hours. We're conducting this interview with Captain Rich Gardner. We're at the ah Volusia County Beach Safety headquarters located in Daytona Beach Florida. This is a taped interview statement with Captain Gardner. Ah Captain Gardner was given written notice of the intent to interview and appear today to provide a sworn statement. He is the subject of this investigation. He is currently on duty and has been released from service to participate in this interview. Captain Gardner was also provided a copy of the Officer Bill of Rights and a copy of his Advisement Garrity Advisement of Garrity prior to this interview. Ahm Captain Gardner, can you identify yourself for the

record, please?

Gardner: Volusia County

Dofflemyer: And how long you been with Volusia County?

Gardner: Since ahm May of 1984.

Dofflemyer: Ok and you are currently a supervisory status?

Gardner: I am.

taped interview statement your statement will be given under oath... ahm and also I'm gonna advise you please not to discuss any part of this interview until the case comes to closure with anybody other

than than your attorney. Ok

with us for ahm maybe a year or two in ahm a Lifeguard capacity;

real recently ah promoted to Senior Lifeguard.

Dofflemyer: Ok do you know when she became a Sr Lifeguard? And that Sr.

Lifeguard for the record is actually a sworn law enforcement

officer?

Gardner: Correct and I don't know.

Dofflemyer: Ok. So do you know when she b gained employment with Volusia

County?

Gardner: I don't.

Dofflemyer: Ok but she became a law enforcement officer recently?

Gardner: Yes Ma'am

Dofflemyer: Ok. Do you know if she's currently on probation?

Gardner: Ah she would be, yes.

Dofflemyer: Ok and how would you know this?

Gardner: I believe it's a year ah...

Gardner: probation from your your swear in. Maybe two...ahm...probably two

years.

Cara or not but you did not nominate her.

Dofflemyer: For what reason would Officer Gittner come to the parking garage?

Gardner:

She was...trying to gain information about how to become a police officer she was very interested in what I did. She ahm would come and I would show her different ah...computer techniques different systems ahm that that we used, how to use them and just some of my contacts cheat sheets just information on how to better herself.

Dofflemyer:

Were you involved in a romantic relationship with her during that

time that she would visit you at the parking garage?

Gardner:

Not initially...

Dofflemyer: Ok

Gardner:

but - yes.

Dofflemyer:

Tell me the time frame from when she started visiting you till you

became in a romantic relationship.

Gardner: It would've been early 2009 maybe sometime in the January

February range to (sigh) May June of 2009 where it developed into

that, yes.

Dofflemyer: Ok did you invite her to come see you at the parking garage?

Gardner: No

Dofflemyer: How did it come about that she would come

Gardner: Sh she would call and ask

Dofflemyer: How did she know that you were there?

Gardner: She knows everything. She - she's a schedule follower.

Dofflemyer: So if you were working - that's an overtime detail, correct?

Gardner: It is.

Dofflemyer: So it's overtime – how was that posted?

Gardner: How's it paid?

Dofflemyer: It or how's it how is the the schedule posted when it's overtime?

Gardner: Ahm it will indicate ahm your normal position on the schedule in a

box and then usually there's a ahm slash and it'll say PG for

Parking Garage right under that on that same day.

Dofflemyer: And is everybody's schedule posted?

Gardner: It's

Dofflemyer: Where one person could get to it?

Gardner: Yes. Anybody can get to it.

Dofflemyer: Where's it posted at?

Gardner: It's not really posted it's just there're schedules throughout the

building...paper schedules.

Dofflemyer: During those visits, did you have any type of physical or sexual

contact with with Officer Gittner?

Dofflemyer: Were your supervisors aware that she was visiting you there while

you were on duty?

Gardner:

No.

Dofflemyer: Any reason you didn't notify a supervisor that you were...

Gardner:

No

Dofflemyer: (papers) At any time did you access ah Officer Gittner's Facebook

account without her permission?

Gardner:

No

Dofflemyer: Did you have her password?

Gardner:

No (pause) no.

Dofflemyer: No you didn't have her password?

Gardner:

No

Dofflemyer:

Did she...did she ever file a complaint with Beach Safety al alleging

that you had gotten into her Facebook without her permission?

Gardner:

No

Dofflemyer:

Why would she say in her sworn testimony that you did access her

Facebook account?

Gardner:

I think she assumed that because during her...relationship with ah

Daytona Officer Joe Sellix ahm it was pretty much common

knowledge and I had set helped her set up other things such as a ahm account called Mobile Me in which she shared that password with me. So I think she assumed that I was into her Facebook

account.

Dofflemyer: What is Mobile Me? I never heard of that site.

Gardner:

It's ahm it's an Apple ah...it's an Apple based program that ah is essentially an email account that allows you to have a certain amount of storage to store pictures, photos, things like that.

Dofflemyer: Did she ever...talk to you about you entering her Facebook without

her permission?

Gardner: Yes

Dofflemyer: Ok tell me about that.

Gardner: She it was during an argument she accused me of gaining

knowledge about her relationship with Joe through Facebook

and...I told her that I had not.

Dofflemyer: Did you know about her relationship with Joe Sellix?

Gardner: Yes

Dofflemyer: How did you become aware of that?

Gardner: She told me.

Dofflemyer: Ok did you ever access ah Officer Gittner's bank account without

her permission?

Gardner: No

Dofflemyer: Did she ever ah talk to you about that?

Gardner: No

Dofflemyer: Anybody ever talk to you about that?

Gardner: No

Dofflemyer: Have you ever ahm nominated Officer Gittner for a commendation

or attempted to influence a promotion or award due to your

relationship?

Gardner: No

Dofflemyer: Was she vying for an investigator position?

Gardner: Yes.

promotion or any special assignment based upon your relationship?

weapon due to her mental status?

Dofflemyer: Ok. Have you ever had to secure Officer Gittner's service weapon?

Well it was one o'clock in the morning, she was upset ahm I think deep inside I believed it was a ploy just to get me over there so that we could discuss the relationship...and ahm I was...less than happy about it so I simply at her request went to her residence for about ten minutes, took her weapons and retained them...she contacted me the next morning and advised she wished to resume her

employment and I returned them.

Dofflemyer:

Did she give you any type of letter saying she was resigning when

you went to her house that evening?

Gardner:

No

Dofflemyer: Didn't try to give any other equipment to you?

Gardner:

She did not

Dofflemyer: Did you take her service weapon?

Yes

Dofflemyer: Did you take any personal weapon from her?

Gardner:

Yes.

Dofflemyer: Why'd you take the personal weapon?

Gardner:

She asked me to.

Dofflemyer: Did she indicate that she wanted to hurt herself? Why would she

ask you to take that that personal weapon?

Gardner:

I think she was just looking for the attention. Ahm I think she

wanted me to come over and discuss the relationship and...she told

me she was going to guit her job.

Dofflemyer: Let's go back. Is there any reason that you did not...recommend her or redirect her to go through the proper channels to resign her

position?

Gardner:

It was one in the morning ahm...the next day she sent a message advising that she wanted her weapons back and wanted to resume

her position. I mean p

Dofflemyer: How did she send

Gardner:

people people say they want to quit everyday but you know you don't go and report that everyday just cause somebody wants to quit you know people talk about it every day. Ahm...your question

was how did she say that?

Dofflemyer:

Was there is there a reason that you didn't get the phone call at one in the morning and say if you want to resign your position the proper channels are...you know tomorrow to come and put your resignation in -?

Gardner:

No I don't know there was no reason I I didn't do that no

Dofflemyer:

(pause) Why would she think that ah during her testimony she said

that she believed that you thought that she was gonna harm

herself. Why do you think Cara would say that?

Gardner:

Because I asked her.

Dofflemyer: And what did you ask her, exactly?

I said...(pause)...I think I asked her if she planned to hurt herself

and do I need to Baker Act her...and she said no.

M.O. is attention and...you know I think she was just looking for the

attention.

Dofflemyer: Who'd you report this incident to once - the next day? Did you

report it the next day?

Gardner:

Nobody.

Dofflemyer:

So you reported...you reported none of the information to anybody

in your chain of command?

Correct.

Dofflemyer: Director Sweat was not aware of it?

He was not.

Dofflemyer: Scott Petersohn?

He was not.

Well I mean it was simply ah her...sayin that she wanted to guit and

she changed her mind; I didn't want to embarrass her.

Dofflemyer: Has this ever happened in the...in during your career that an

employee called you to say come get my weapon or I wanna quit

and you went and picked up their weapon?

No

Dofflemyer:

Ok. Go back have you did you report this information either

formally or informally to anybody in your chain of command?

Gardner:

No

Dofflemyer: Have you ever attempted to cover up a crime involving a Beach

Safety employee?

Gardner: No

Dofflemyer: Have you ever attempted to cover up a policy violation committed

by a Beach employee?

Gardner: No

Dofflemyer: Do you have any knowledge about the anonymous letter that was

written? Any idea who sent it?

Gardner: No

Dofflemyer: Did ah Officer Winters or Officer Gittner discuss this incident this

investigation with you prior to this interview?

that...you know I didn't view it as a true bona fide mental health issue I viewed it more of a an attention getter...I just ahm...yeah she said she wanted to quit her job and I know that she's been back and forth with leaving this department...and at her request I took

her weapons.

Dofflemyer: Did she give you any reasons why she wanted to leave ah Beach

Safety?

Gardner: Advancement, a lack of

Dofflemyer: And once again please explain to me why you took the personal

weapon as well as the service weapon.

Gardner: She asked me to.

Dofflemyer: Did she indicate or imply in any way that she wanted to harm

herself?

Gardner: No. Never once.

Dofflemyer: Was she upset when you arrived?

Gardner: Yes

Dofflemyer: Why was she upset?

Gardner: Because there was no relationship and I think she wanted to

continue the relationship.

Dofflemyer: Had you broke off the relationship prior to that evening?

Gardner: There was no relationship during that time. It was just one of those

in the midst calls where we had discussed and she wanted me to

come over and I told her I would not. And...

Dofflemyer: Did I'm sorry

Gardner: and ahm...she told me she was gonna quit. And to come get her

weapons.

Dofflemyer: Did she call you?

Gardner: We go back and forth. I don't know. I don't remember.

Dofflemyer: Do you remember exactly when that was?

Gardner: Ahm yeah. It was ahm...(pause)...August 7th.

Dofflemyer: Captain, were you on duty on August 7th?

Gardner: No

Dofflemyer: Were you Acting Deputy Director that weekend?

Gardner: Ah it was my- it was my weekend to be Deputy Chief, yes, during

the day.

Dofflemyer: During the day?

Gardner: During the day shift, yes

Dofflemyer: Ok

Gardner: I mean I'm always on call. I'm on call 24 hours as the investigator
