## Mindy Greene, Witness Interview IA 2011-09-297

Dofflemyer: This is Captain Dofflemyer with the Department of Public

Protection's Internal Affairs Unit. Today's date is October 3<sup>rd</sup>, 2011. The time is 1441 hours. We're conducting this interview today with Captain Mindy Greene from Volusia County Beach Safety Division. Ahm we're doing this interview at the Volusia County Branch Jail located in Daytona Beach Florida. This is a taped interview statement with Captain Greene. She was given notice of the interview

statement with Captain Greene. She was given notice of the intent to interview and appeared today and provide this sworn statement. Captain Greene is not the subject of this investigation and she is currently on duty and has been released from service to participate in this interview. Ahm Captain Greene, can you identify yourself for

the record, please?

Greene: Captain Mindy Greene

Dofflemyer: And you are currently employed by Volusia County?

Greene: Yes

Dofflemyer: Ok. How long you been with Volusia County?

Greene: Since 1998 I think

Dofflemyer: Ok and how long you been in a supervisory role?

Greene: Three months

Dofflemyer: Ok. Is there a contact phone number that you can be reached at?

Ah my work one is

Dofflemyer: And you are a certified law enforcement officer?

Greene:

Yes

Dofflemyer: Ah prior to the start of this interview were you provided a copy of

your Garrity Advisement?

Greene:

Yes

Dofflemyer:

Ok also be advised this is an active and open Internal Affairs investigation. I'm directing you not to discuss any part of this investigation with anyone until the case comes to closure. Do you also understand this is gonna be a sworn statement given under

oath?

Greene:

Yes

Dofflemyer: Do you understand that this is a taped interview statement?

Greene:

Yes

Dofflemyer:

Ok in accordance with Merit Rules and Regulations and the Officer Bill of Rights you have the right to have representation present during this interview. Do you elect to have any representation at

this time?

Greene:

Ok at any time during this interview if you wish to seek representation just advise and we'll stop the interview so that you can find a representative to sit with you. Ok raise your right hand for me. Do you solemnly swear or affirm the statement you're about to give is the truth, the whole truth and nothing but the truth,

so help you God?

Yes

Dofflemyer: Ok, very good. Ah you said you started ah with Volusia County

what year again, please?

Greene:

1998

Dofflemyer:

1998 and did you start your career as a a law enforcement officer

there?

No. I was a lifeguard.

Dofflemyer: Ok. When did your LEO career start?

Greene:

2001, I think?

Dofflemyer: Ahm do you know a Captain Rich Gardner?

Greene:

Yes

Dofflemyer: Ok how do you know Captain Gardner?

Greene:

Co worker he does the investigations

Dofflemyer: Ok is he currently your supervisor?

Greene:

No not directly

Dofflemyer: Ok

Greene:

I mean he...until I just got promoted he was at any time ah but now

my direct supervisor is ah Deputy Chief Scott Petersohn.

Dofflemyer:

Ok ahm do you know ah a Beach Safety Officer by the name of

Cara Gittner?

Greene:

Yes

Dofflemyer: How do you know her?

Greene:

Ahm co-worker

Dofflemyer: Ok

Greene:

and friend

Dofflemyer: Is she a friend of yours outside of work also?

Greene:

Yes

Dofflemyer:

Ok ahm do you currently or have you ever associated with Captain

Gardner outside the workplace?

Greene:

No

Dofflemyer: Do you associate with Cara outside the workplace?

Greene: We used to.

Dofflemyer: Not any more?

Greene: No

Dofflemyer: How long has it been since you guys have associated outside the

workplace?

Greene: Ahhmm...we don't we've never like really gone out but we used to

train together for competitions and stuff.

Dofflemyer: So it's been awhile since you've done that with her?

Greene: Yes

Dofflemyer: Ok about how long?

Greene: A couple months

Dofflemyer: Ok...is there any reason why you don't associate outside the

workplace anymore?

Greene: Ahm...

Dofflemyer: Or train together anymore?

Greene: Not really just...she does her thing, I do mine (laughs)

Dofflemyer: Ok. Are you aware of ahm any romantic or personal relationship

involving Officer Gittner and ah Captain Gardner?

Greene: Ah I'm aware that there used to be one

Dofflemyer: Ok

Greene: Yes

Dofflemyer: How long ago did there used to be one?

Greene: Ahm... I can't give you an exact date but... I know that a few months

back that Cara came to me when the relationship was done so more as to confide in me as a friend, you know when it was over with so that was a few months I can't give you an exact date. Dofflemyer: Ok but over the summer?

Greene: Yes

Dofflemyer: Did she...tell you during that conversation there was any ahm

problems with you know Captain Gardner givin her a hard time in

any way upon the breakup? Anything related to work?

Greene: The only time that there was ever an issue it was I'd say a month

ago. Ahm Cara we were both workin the same shifts and Cara texted me on my personal cell phone and said that she felt she was being treated unfairly by Captain Gardner. And I responded er I

said I'm sorry I missed it it was a radio transmission

Dofflemyer: M hm

Greene: and I didn't hear it and ah...she...responded and said will you have

a meeting? Now I'm...I don't even consider myself equal to Rich

cause he's been you know

Dofflemyer: M hm

Greene: a captain forever but ah and I said no I said if you want a meeting,

you need to have it with Scott Petersohn. I said I'll be there if you want me to be there, but it's not gonna be and ah and she asked if I'd speak with her later about it and I said yes and that was the end of it it was never brought up again. So what I did is I went to Scott

two days later and I said I got put in a funky position

Dofflemyer: M hm

Greene: you know and ahm I said I didn't witness anything I didn't hear

anything but I kind of felt like Cara was taking advantage of me and my position cause I had just been promoted and you know she wanted me to go in there as a supervisor and you know talk to her and Rich because she felt she was being treated unfairly where

that's not standard routine no matter what, so.

Dofflemyer: Did she indicate how she thought she was being treated unfairly?

Greene: Ahm she said that I guess he was rude to her over the radio and

like I said I didn't hear it and ah Rich can be very curt on the radio he's been rude to all of us but that's just...you know we're not out

there to be friends, so...

Dofflemyer: M hm and tell me again when was that?

Greene: Ah I would say a month ago

Dofflemyer: Ok and you made Scott aware of it Petersohn?

Greene: Yes yeah I had a meeting with him

Dofflemyer: And you never heard anything else after that, right?

Greene: No

Dofflemyer: So you traveled up the flagpole yourself

Greene: Right and Scott just said he'd keep his ears open for anything and I

told him the same thing that I didn't hear anything or see anything.

Dofflemyer: Did Cara ever bring anything up to you again?

Greene: That was the end of it.

Dofflemyer: Are you aware of any circumstances involving Cara and Rich and

ahm...with them involved in conducting a romantic or intimate

relationship while on duty?

Greene: No

Dofflemyer: Any rumor of them doing anything on duty that you'd ever heard?

Greene: No

Dofflemyer: Ok. Do you know if Rich gave Cara any kind of special duties,

assignments or shifts ahm due to their romantic involvement?

Greene: No

Dofflemyer: Anybody ever complain to you that they thought that was goin on?

Greene: Not to me...you hear people talking you know and ahm Cara and

Rich had a very e a obviously a very close friendship

Dofflemyer: M hm

Greene: and ahm and her interest is in investigations so she worked with

him on that and people - obviously there's rumors - they're gonna

say oh well it's just cause you know they like each other or whatever but...

Dofflemyer: Is Cara currently an investigator?

Greene:

No

Dofflemyer: Did she ever get an investigator position?

Greene:

No she hasn't put her time in.

Dofflemyer:

So would you say other other employees at the Beach were aware of the relationship the romantic and intimate relationship they were having?

Greene:

Ahm everybody saw their friendship. As far as the romantic no because nothing was ever...you know done at work or even I mean socially I never saw the two of them out together or anything like that.

Dofflemyer:

Anybody ever come to you and say ah they were out socially acting

as if they were romantically involved

Greene:

No

Dofflemyer:

or together...ok. Did ah Cara ever confide in you about an incident

involving Rich accessing her Facebook account without her

permission?

Greene:

Yes

Dofflemyer: Ok. Tell me about that.

Greene:

Ah...I couldn't tell how long ago it was...but just that he hacked into her Facebook account and it was over one of her guy friends, Tom Roland and I guess she was sleeping with him and he got into her account I don't know how he did it I don't know anything about it but

Dofflemyer: Ok

Greene:

just that he did it

Dofflemyer: But ah what she said to you was that she wasn't aware it was

taking place he did it on his own?

Greene:

Correct

Dofflemyer: She ever say to you she thought he did it at work?

Greene: No

Dofflemyer: Do you remember approximately how long it was?

Greene: It was either the beginning of the summer or earlier than that.

Dofflemyer: Ok. Did she tell you call you on the phone and tell you? Did you

meet up someplace?

Greene: Ahm...I don't know

Dofflemyer: Did she give you any of the circumstances involving that?

Greene: No

Dofflemyer: Do you know if she reported that to any supervisor at the Beach...

Greene: I don't believe so.

Dofflemyer: as a complaint?

Greene: No

Dofflemyer: Ok did you feel that you needed to report it to anybody

Greene: Not at all

Dofflemyer: as a complaint? Did she seem concerned when she was sharing

this information with you?

Greene: Ahm just more annoyed just...I mean nobody wants anybody hackin

into their stuff.

Dofflemyer: Understood. Did ah Cara ever confide in you about an incident

involving Rich ahm accessing her bank account without her

permission?

Greene: No

Dofflemyer: Ok. How about a situation where Cara was very upset ahm called

Rich and Rich went to her house and secured her service weapon?

Greene: Ah yes I was made aware of that.

Greene: Ahm Cara actually told me about that ahm I don't know who

her...we were at work and it was after probably a couple weeks

after the fact

Dofflemyer: Ok

Greene: Ahm and she told me that it was after one of their falling outs and

she had him...he was mad at her because she called him to her house off duty I guess he was the deputy chief that weekend and ah she was real upset and she had him secure her gun and that's what he was mad about. I don't know any of the rest of the details

but

Dofflemyer: Do you remember when you talked to her about this? About what

time frame?

Greene: I am so bad with time frames ahm...two months, maybe?

Dofflemyer: Ok

Greene: Maybe not that long

Dofflemyer: But it was a couple weeks after the incident took place?

Greene: Yeah it wasn't immediately after.

Dofflemyer: Did she ever tell you that she was...that he secured her weapon

because she thought she was gonna harm herself

Greene: No

Dofflemyer: or he thought she was goin to

Greene: No just that she she was upset and...I I believe she told me that she

told him to take it. So but

Dofflemyer: Was he on duty at that time was that why she called him?

Greene: Ahm...

Dofflemyer: Or on call

I guess he would probably be on call. He covers night shift, so if

anything happens at night, that's who you would call.

Dofflemyer: And who did Rich report this situation to, do you know?

Greene:

I don't know.

Dofflemyer: Ok

Greene:

I don't know that it was reported.

Dofflemyer:

Ok ahm did you report it to anybody?

Greene:

No

Dofflemyer:

Ok

Greene:

It was after the fact when I heard of it.

Dofflemyer:

Ok. Do you know if Kevin Sweat knew about it at all?

Greene:

1

Dofflemyer: Ever hear any mention about it after that?

Greene:

No. That was the only time I heard about it.

Dofflemyer:

And Cara never - wasn't telling it was cause of she was wanting to

harm herself?

Greene:

No and like I said it she just said that it was...that's why Rich was

angry with her. So...because she called him there at night.

Dofflemyer: To get the weapon.

Greene:

Right.

Dofflemyer: And...did she tell you what she told Rich why to come get the

weapon?

Greene:

No she downplayed it very

Ok

Dofflemyer: Do you know if anybody ever asked her did she...when did she get

her weapon back? Did she tell you?

Greene:

Ah she never missed a day at work so it had to have been the next

morning.

Dofflemyer: Did she tell you how she got her weapon back? (pause) Did Rich

Gardner ever discuss this incident with you?

Greene:

No

Do you have any knowledge about the anonymous letter that was

written and sent to Beach Safety, Mr. Coffin and ah information

was placed that it may be sent to a news agency?

Greene:

No

Have you ever heard any rumor that somebody sent out an

anonymous letter with allegations?

Greene:

I didn't know until I came here that anything was goin on! (laughs)

Dofflemyer: Did you write or send a letter?

Greene:

Do you know of anyone that would have issue with the Beach that

would send out an anonymous letter with allegations against

different personnel?

Greene:

Ok. Were you contacted by Rich Gardner prior to this interview?

weapon is what Cara told you?

Greene:

Dofflemyer:

Did she say she got her weapon back because her and Rich have a

relationship?

Greene:

No I don't...I don't know how she got her weapon back.

All right, Captain I don't have any other questions. Anything you'd

like to add before we go off the record?

Greene:

No

Dofflemyer:

All right let's see it's ah same the same date and we are still at the

Branch Jail and it is currently ah 1455 hours and we are gonna

officially go off the record.
