police officer

Winters: Don't know

Dofflemyer: Assigned by Captain Gardner?

Winters: No

Dofflemyer: All right Paige, I don't have any other questions. Is there anything

that you would like to add prior to ending this interview?

Winters: Ahm... yes. I I think that Captain Gardner has handled himself very

professionally. He's always been professional and he's always put his work first. I've never felt in an uncomfortable position with him at work even outside of work he handles himself very well and very

professionally and appropriately. Ahm can't speak that of

somebody else and I believe that's the person who's ahm had sent in the the anonymous letter. They have not been professional or

appropriate.

Dofflemyer: Ahm one more thing. Ah the relationship that you had with Captain

Gardner. At anytime did you feel that you were forced to be part of

that relationship?

Winters: Not at all.

Dofflemyer: Did you feel that you were forced to be part of that relationship ahm

in order to maintain employment?

Winters: Not at all.

the twenty third of September. We are still at Beach Safety and the time is 1504 hours and we're going to go off the record.
