After further review of the documents that Mr. Byron supplied yesterday and after him confirming several times that he sent everything yesterday (9 pages - see attached)...allow me to focus in on what we are looking for.

We are looking for the TWO IA closure letters attached to the TWO IAs that Gittner was being investigated for (IA-2011-9-297 and IA-2011-12-302)

Clearly in Mr. Pozzo's December 20, 2011 letter to Gittner, she is STILL being investigated regarding IA-2011-09-297. Although, we do have an December 28, 2011 letter from Mr. Pozzo instructing Dofflemeyer to close IA-2011-12-302, we do NOT have Dofflemeyer's memo doing such.

So, without ANY type of closure letter on IA-2011-09-297, are we left to assume that Officer Gittner left employment with an on going internal affairs investigation?

Surely, Mr. Byron can not be holding the position that Officer Gittner's closure letter is exempt from disclosure.
