Per CFA Std. 27.04, B. Member photographs; C. Lineups; and D. Financial Disclosure Statements can be used in *internal affairs investigations*. According to this Commission for Florida Law Enforcement Accreditation Standard, cell phone records do not fall within one of the prescribed forms of evidence which can be requested.
