**NOTICE OF REPRESENTATION, REQUEST FOR INVESTIGATIVE FILE
REQUEST FOR CONTINUANCE OF INTERVIEW**

Dear Captain Vanis:

As you are aware this office represents Mr. Michael Snipes ("Mr. Snipes") regarding the referenced matter. The following correspondence is being sent via telefax in order to confirm receipt. Since Mr. Snipes has retained legal counsel please do not attempt to contact him except through this office.

Mr. Snipes was notified, in writing, approximately six (6) days ago, that the Department of Public Protection, Internal Affairs Unit had been ordered to conduct an investigation into alleged violations of unprofessional conduct. Further, Mr. Snipes was to be provided an opportunity to review all documents prior to the interview.

As we previously discussed, I will be unavailable to attend the interview scheduled for Thursday, July 23, 2013, due to an out-of-state funeral. However, I am available the following Monday, July 29, 2013, before 2 p.m. and Tuesday, July 30, 2013. Mr. Snipes would suffer a great prejudice if your office denied him the opportunity to attend without legal counsel, as well as, not being provided an opportunity to review the documents associated with the investigation.

In accordance with Chapter 120, Florida Statutes, and the applicable Florida Administrative Code (F.A.C.) Rules, we are specifically requesting a copy of the report of investigation and the entire investigation file for this matter. The copy of the file should include, but not be limited to: summaries of interviews and witnesses, witness statements, receipts, investigator's notes, internal correspondence and memoranda, all notes, expert reviews, external correspondence sent or received, and anything and everything else that may be included in the file.
