On January 5, 2018, at approximately 1755 hours, I responded to 1585 South Carpenter Rd, Titusville, Brevard County, Florida in reference to a drowning.

Upon arrival, I made contact with deputies on scene who relayed that a three (3) year old child identified as Raul Reyna Sanchez (victim), had been found unresponsive in a swimming pool at the residence. The owner of the residence, identified as Marvin Quezada, relayed to deputies that the child who was his nephew had gone missing for approximately thirty (30) minutes before being found in the swimming pool. Mr. Quezada advised that his wife, identified as Candy Quezada, began CPR contacted emergency services.

Raul Sanchez had been transported to located at located

Agent Deavers of the Major Crimes Unit was notified and briefed of the incident. This concludes my involvement in this case.

Section 2: Crime Scene

The crime scene consisted of the swimming pool located on the north side of the residence at 1585 South Carpenter Rd, Titusville, Brevard County, Florida.
