NARRATIVE

Section 1: Narrative

On January 5, 2018, at approximately 1755 hours, I responded to 1585 South Carpenter Rd, Titusville, Brevard County, Florida in reference to a drowning.

Upon arrival, I made contact with deputies on scene who relayed that a three (3) year old child identified as Raul Reyna Sanchez (victim), had been found unresponsive in a swimming pool at the residence. The owner of the residence, identified as Marvin Quezada, relayed to deputies that the child who was his nephew had gone missing for approximately thirty (30) minutes before being found in the swimming pool. Mr. Quezada advised that his wife, identified as Candy Quezada, began CPR [REDACTED] contacted emergency services.

Raul Sanchez had been transported to [REDACTED] located at [REDACTED] Titusville prior to my arrival. I began a crime scene log prior to my departure. The last known condition of the victim was alive; however, listed as in critical condition.

Agent Deavers of the Major Crimes Unit was notified and briefed of the incident. This concludes my involvement in this case.

Section 2: Crime Scene

The crime scene consisted of the swimming pool located on the north side of the residence at 1585 South Carpenter Rd, Titusville, Brevard County, Florida.

Photographs were taken of the crime scene which were uploaded to BCSO3 media.

There were no further crime scenes to be processed.

Section 3: Disposition

This case will be remain open/active and referred to Agent Deavers with the Major Crimes Unit per his request.
