personally came the Affiant, Agent Alex Sorokin, of the Brevard County Sheriff's office, in Brevard County, Florida, who being duly sworn deposes and says that he is a citizen of Brevard County, Florida and has probable cause to believe, that Stephen Thomas Norman, a white male, approximately 6'1" tall, 160 pounds, sandy hair, green eyes, date of birth 4/4/1949, social security number Florida DL N655-798-49-124-0 with a last known address of 140 Oyster Place, Rockledge, Brevard County, Florida 32955, has committed a violation of Florida Statutes to wit: Possession of Child Pornography (10 Counts,) contrary to section, Florida Statutes 827.071(5).

The facts that establish the grounds for this application and probable cause of Your Affiant for believing that such facts exist are as follows:

On February 1, 2017, the Brevard County Sheriff's Office received a Cybertip (#16024103,) regarding the upload of suspected child pornography. Information was provided in said Cybertip from the submitter, Yahoo! Inc, with regards to multiple images of apparent child pornography had been uploaded via IP address, 97.103.13.87, between 9/20/2016 through 12/14/2016, utilizing Yahoo messenger. Yahoo! Inc provided the following information regarding the user or person being reported:

Once receiving the complaint, I viewed the images in question that were provided with the Cybertip, which I reviewed. One image provided depicted a prepubescent female (approximately 4-7 years old) lying on her back while an adult male penetrated her vagina with his penis. Based on these facts I requested a subpoena (#17-159) be executed to Bright House Networks for target IP, 97.103.133.87, between 9/20/2016 at 16:38 UTC through 12/14/2016 at 21:48 UTC.

I received a subpoena response from Subsentio, which revealed the following information:

Through investigative research, I located a Facebook profile, "Sean Thomas," which utilized the email address, "xfeedandbreedux@yahoo.com." While utilizing DAVID (Driver and Vehicle Information Database) I located a resident, Mr. Stephen Thomas Norman, who currently resided at 140 Oyster Place, Rockledge, Florida. It should be noted the profile picture for Facebook profile, "Sean Thomas," appeared to resemble Mr. Stephen Thomas Norman after viewing his image on DAVID.

On Friday, November 3, 2017, Agent Spadafora and I responded to 140 Oyster Place, Rockledge, Brevard County, Florida, in an attempt to make contact with Mr. Stephen in reference to conducting a non-custodial interview with him. Thomas Norman. Contact was made with Mr. Norman who stated the following: He has resided at 140 Oyster Place, Rockledge, Florida since 1989. He has internet via Spectrum (Bright House Networks,) and has password protected Wi-Fi at his residence. He had used Yahoo messenger late 2016 through early 2017. He identified the Facebook profile, "Sean Thomas," as one he had used in the past. Mr. Norman also stated he did use email address, "xfeedandbreedux@yahoo.com," in the past as well, which he utilized when creating the "Sean Thomas" Facebook profile.

I showed Mr. Norman an image of child pornography I had received via the Cybertip. I showed Mr. Norman the image depicting a prepubescent female (Approximately 4-7 years old) lying on her back while an adult male penetrated her vagina with his penis. Mr. Norman admitted to knowingly receiving said image via Yahoo messenger, and distributing the image to other individuals via the internet utilizing his computer. Mr. Norman stated he had approximately thirty (30) images located on his computer, which he identified as similar to the child pornography image I had shown him. Mr. Norman stated he downloaded these images for fantasy purposes only, and that he would masturbate to them. Mr. Norman stated he utilizes his own user profile on his computer, which is password protected. Mr. Norman stated he is the only person that utilizes his profile on his computer.

At this point Mr. Norman granted us consent to enter his home and seize his computer to allow us the ability to forensically examine it. Mr. Norman identified his Lenovo All-In-One computer (SN# VS80551435, Model# C440,) which was sitting on a desk within a large room, as the computer he utilized to viewing, possessing, and distributing images of child pornography. It should be noted the computer was located in a large, open room, which could freely be accessed by people. There was no door affixed at the entrance of the room preventing individuals from entering. The room was identified as a common area within the residence.

Based on the statements made by Mr. Stephen Thomas Norman, and the belief that said digital device contains data pertaining to evidence of a crime, to wit: F.S. 827.071(5,) Possession of Child Pornography, it was seized fur further forensic examination.

Based on the aforementioned facts I requested for a search warrant for Mr. Norman's computer, which was signed and approved by Honorable Judge Christina Serrano on November 8, 2017.

On November 9, 2017, Digital Forensic Agent Mary Adams conducted a forensic examination of Mr. Norman's computer. After completing the forensic examination on Mr. Norman's computer, Agent Adams stated she located multiple images of suspected child pornography, which were found in user "Stephen" documents in a folder named "My Stuff." I reviewed ten (10) images within Agent Mary's forensic extraction report, which were identified as the following:

It should be noted that filename, "download (51).jpg," (Count3) was one of the images provided via the Cybertip complaint. It should be noted that user account "Stephen" was a password protected user account, which Mr. Norman stated he was the

only one that had access to. Based on the foregoing facts and evidence, Mr. Norman's statements that he had approximately thirty (30) images or more of child pornography on his computer, and approximately ten (10) or more images of child pornography were recovered forensically, your Affiant believes that probable cause exists to charge Stephen Thomas Norman with ten (10) counts of violation of F.S. 827.017(5), possession of child pornography. It should also be noted in furtherance of violation of F.S. 827.071(5), possession of child pornography, this violation shall be reclassified to the next higher degree as provided in F.S. 775.0847(2)(a)(b) due to Mr. Norman possessing ten (10) or more images of any form of child pornography regardless of content, the content of at least one image contained a child who is younger than the age of five (5), sexual battery involving a child.

Your Affiant is a certified Law Enforcement Officer in the State of Florida and has been employed with the Brevard County Sheriff's Office since 2009. Your Affiant has served in the capacity of Deputy Sheriff, GAME OVER Task Force Agent, Special Victim's Agent, and currently assigned as an Agent with the North Florida Internet Crimes against Children (I.C.A.C.) Task Force.

Whereas, your Affiant makes this Affidavit and prays the issuance of an Arrest Warrant with authority to enter any premises to effect said arrest, in due form for the arrest of Stephen Thomas Norman for the offense of Florida Statute 827.071(5), Possession of Child Pornography (10 Counts,) thereof subject to the order of this Honorable Court by duly constituted officers of the law.
