## **OPEN LETTER TO 18TH CIRCUIT STATE ATTORNEY**

Good Afternoon Mr. Brown:

As you should remember, and as mentioned within our published "open letter" (see below link) - your office was NOT able to provide us with the SAO's "decline to prosecute letter" attached to a November 2018 child drowning incident (Altamonte Springs, Florida).

Your office responded (in part):

"Unfortunately the only identifying information you've provided is the ASPD case number. I searched our system for both 2018CJ019844 (as it appears in the report) and 2018-73991 (as you provided), but found no matching records. If you can provide a defendant or victim name, or the name of the prosecutor who drafted the letter, I will try again."

Obviously, since the "identifying information" you (Brown) requested is redacted from the DCF report (see below link to DCF document) – we (VolusiaExposed.Com) can not provide this requested information – something we suspect, you are well aware of – and have taken full advantage of.

According to the Orlando Sentinel article - the letter was written in early December 2017 by Chief Assistant Stacey Straub Salmons (Sanford Office) regarding the State Attorney Office's refusal to prosecute then Seminole Tax Collector Joel Greenberg.
