### NARRATIVE

#### Section 1: Narrative

On Saturday, May 11<sup>th</sup>, 2019, at 1243 hours, Sgt. L. Smith (ID #0079) and Deputies Lewis (ID #4388), Bennett (ID #0205), Fitzgerald (ID #4513), and I responded to 3582 Twelve Oaks Circle, Merritt Island, Brevard County, Florida, 32953, in reference to an apparent drowning involving a three year old male juvenile.

Upon arrival I observed the front door open to the residence and Mrs. Amber Fowler (Complainant) and Sgt. Smith in the enclosed pool area of the back of the residence. When I made my way to the pool area I observed the male juvenile, Mr. Riley Fowler (Involved), laying supine on his back with Mrs. Fowler doing cardio-pulmonary resuscitation (CPR). I then immediately approach Riley and Mrs. Fowler and took over CPR from her. It should be noted that all of Riley's extremities, including his fingers, lips, and toes, were a bluish color, indicating that he had not received oxygen for some time.

I would continue CPR, for approximately the next four minutes until Brevard County Fire Rescue Unit #41 arrived on scene, who subsequently took over life-saving efforts from myself. BCFR would eventually transport the juvenile, by ambulance, to [REDACTED].

While Deputy Fitzgerald and I tended to Riley, Deputy Lewis immediately began conducting an investigation into the circumstances. Refer to Deputy Lewis' primary case report for complete information regarding his involvement in this investigation.

#### Section 2: Crime Scene

As stated above the incident occurred on the enclosed pool deck of the residence of 3582 Twelve Oaks Circle, Merritt Island, Brevard County, Florida, 32952, and the person of Mr. Riley Fowler.

Riley was located supine on his back and his extremities, which included his fingers, toes, and lips were blue in color. Riley also had fresh vomit on the right side of his face which was caused when his mother, Mrs. Amber Fowler began CPR on him. Riley was also moist which was consistent with him just being pulled from the water.

#### Section 3: Disposition

This case is pending and referred to MCU Agent Kersey (ID 0284) for further investigation.
