en by DHO within the 7-day period per VCDC Discipline policy standards. Inmate agreed to inmate J attend the Disciplinary Hearing on 11/22/2022. The 24-hour Delay is noted. Inmate has been given sufficient time to prepare for disciplinary boards. As per the investigation officers report, Inmate was interviewed and given notification of the rule violations on 11/17/2022 by Inv Lemons DHO explained the inmate due process rights

During the disciplinary hearing, the following was recorded by DHO

Charge #7AA. Indecent exposure / masturbation -intentional acts towards staff – Charge amended to # 5A. Charge #5A: Engaging in sexual acts with self-others including masturbation. Denies the allegations.

Charge #27A Refusing to obey. Denies the allegations.

Charge #33B Conduct which disrupts- Denies the allegations

Inmate a was alert and oriented and able to speak to DHO at her cell door. Inmate never gave her any warnings about the use of her laptop or using the camera. Inmate states Adenies all allegations and claims staff admits to having a "lil fun" and does not cures"! Inmate appears Jovial as states "That's what the camera is for; to take pictures"! Inmate feel she did anything wrong. Inmate she is expressing herself and is adamant that she is not guilty stating "The punishment is just too much"!

DHO notes that per staff's report when checking inmate school laptop for class work, the teacher discovered sexual and vulgar in nature pictures. It is noted that several passwords were changed locking the instructor Mrs. Williams out of the system. Inmate actions were inappropriate. Inmate admitted to taking several nude photos of another inmate as well as explicit

DHO finds inmate guilty of charge #27A, #33B, and #5A based on the preponderance of evidence, Inmate admitted to using the tablet inappropriately but feels she did nothing wrong.
