
### Volusia County Corrections Officer Detained on Felony and Misdemeanor Charges

VOLUSIA COUNTY, FLORIDA – The Volusia Sheriff's Office arrested Volusia County Corrections Lt. Jonathan Harding at approximately 1:00 p.m. today. He was detained on five charges, including felony Sexual Misconduct Employee/Inmate, felony Unlawful Use of a Two-way Communication Device, two Felony Introduction of Contraband to County Detention Facility charges, and a misdemeanor Introduction of Contraband to County Detention Facility charge.

Harding was secured without incident, immediately booked into the Volusia County Jail, and detained in Administrative segregation. Harding's first court appearance is scheduled for 8:30 a.m. tomorrow, May 16. Should he remain in or return to custody, he will be transferred to a correctional facility outside of Volusia County for the duration of his pretrial detainment or until a bond is posted.

Volusia County corrections officers became aware of suspicious activity involving Harding earlier this month and reported it to Internal Affairs, which immediately began an investigation. Once sufficient evidence was discovered, Harding was reassigned to duties outside the Corrections Division, and the investigation was transferred to the Volusia Sheriff's Office. He is now on unpaid administrative leave pending the outcome of a trial.


Harding began his career with Volusia County Corrections on Feb. 28, 2011, and had received no disciplinary actions prior to his arrest. Volusia County Corrections Administration and Internal Affairs cooperated fully with the Volusia Sheriff's Office and District Attorney's Office for the duration of the investigation and will continue to do so.

VE	Captain Smothers informed Detective Teske he was provided a jail report authored by Lieutenant Talamo, that expressed allegations of an inappropriate relationship between jail Lieutenant Jonathan Harding and inmate.  It was documented in the jail report that Lieutenant Harding was observed by other inmates bringing inmate of the county in the shift, as well as allowing her to use his personal cellular phone. The jail initiated an investigation into these claims, ultimately verifying the allegations were in fact correct. Lieutenant Talamo noted "there was a lot of suspicious/questionable activity that appears to be happening regarding Lt.
