ON 12-18-06 AT APPROXIMATELY 2155 HOURS, I CAME TO UNIT 1 TO CONDUCTED SEG. CHECKS. I DID NOT DO A WALK THROUGH OF ALL BLOCKS. I CHECKED ON THE LOCKDOWNS THAT I HAD ON THE UNIT AT THE TIME. I HAD NO LOCKDOWNS IN C-BLOCK. ONE OF THE LOCKDOWNS WAS IN THE HALLWAY. (AN INMATE BY THE NAME OF HOGAN, R. 662395). HE WAS THEN HOUSED IN A-BLOCK. I THEN WENT INTO D-BLOCK AND CONDUCTED THE REMAINDER OF THE SEG. CHECKS. I LEFT UNIT 1 AT APPROXIMATELY 2230, WHEN I MOVED INMATE VINCENT, J. 658417 TO UNIT 12. I RETURNED TO UNIT 1 AT APPROXIMATELY 0045 HOURS. I ASSISTED WITH 0100 ROUNDS BY LETTING OFFICER COFFIN IN AND OUT OF THE BLOCKS TO CONDUCT ROUNDS AS WELL AS SUPERVISE THE SHOWER CLEANERS. ROUNDS IN C-BLOCK WERE COMPLETED AT APPROXIMATELY 0115. I DID NOT NOTICE ANYTHING UNUSUAL DURING THIS TIME. I REMAINED ON UNIT 1 UNTIL APPROXIMATELY 0240. ROUNDS WERE NOT COMPLETED AT 0200 WITH THE INTENTION OF STAGGARING THE ROUNDS SO THAT THEY COULD NOT BE TIMED BY THE INMATES. WE LOST TRACK OF TIME HOWEVER AND BY THE TIME I NOTICED THE CLOCK, IT WAS ALREADY CLOSING IN ON THE 0300 HEADCOUNT ROUND. THIS WAS AT APPROXIMATELY 0240 HOURS. I DID NOT RETURN TO UNIT 1 UNTIL APPROXIMATELY 0730 HOURS TO SIGN OFF ON THE VDC 500B AND CHECK ANY POSSIBLE REMAINING PAPERWORK. I WAS OCCUPIED THROUGH THE HOURS OF 0300 AND 0600 WITH A PROBLEM THAT OCCURRED ON ONE OF THE OTHER UNITS THAT I WAS SUPERVISING WHICH INCLUDED BEING INVOLVED IN A CELL EXTRACTION.
