Martinez, Ofc. Moore, Ofc. Talamo, Nurse Jack Ross, and Medic Mike Wisemore. Ofc. Hawkins received all keys from arriving staff and controlled the lockbox. Lt. Sophie and Medic Wisemore began CPR at 2218. At 2233 Head Nurse Alan arrived on N/W and entered H block. At 2234 the following fire services arrived on the wing and entered H block: Norm, Froman, Fosterling, McKay. David Aiken and Brook Tuohy arrived on the wing at 2242 from EVAC. At 2244 Lt. Smith and Deputy Conyers arrived on N/W and entered the block. I/M Comeau was pronounced dead at 2245 by Dr. McMahon thru EVAC Aiken. At 2248 fire services and EVAC exited N/W. At 2250 statements were being taken from the block. Capt. Prince arrived on N/W at 2252 and the cell was secured with Ofc. Bauer standing outside of the cell. VCDC 721s completed on all I/Ms in H block. At 2306 Capt. Prince and Deputy Conyers entered H

Bauer resumed her post in H block at 0013. Capt. Modzelewski on wing at 0014. Investigator Dewees arrived on the wing at 0017 and entered H11 at 0018 with Capt. Dofflemeyer and Capt. Modzelewski. Investigator Blair arrived on the wing at 0023 and entered H block. At 0035 Medical Examiner Negrete in H block. At 0042 Capt. Dofflemeyer, Nurse Jack Ross, Inv. Agistinis, Medical Examiner Negrete, and Inv. Dewees entered H block with items for I/M Comeau. At 0046 on 09-28-07 I/M Comeau was removed from the cell. Sgt. On 092707 at approximately 2219 hours I responded to a code white on North Wing. Upon my arrival to H11 I found Sgt. Painter, RN Ross and Medic Weismore in the cell moving inmate Comeau, Murieo 685491 from the bunk to the floor. It appeared that Comeau had a shoe lace tied around her neck. I removed my 911 tool from my belt and was going to cut the lace but found that RN Ross had already cut it with his scissors. Inmate Comeau was placed on the floor and CPR was started by RN Ross and Medic Weismore. I directed Sgt. Isler to report to the control room and start the ICS call down list. I then instructed Ofc. Bauer to keep track of all personnel entering or exiting the cell block. Medic Weismore placed a combitube into the inmate's mouth to open her airway then attached a resuscitator bag to supply air during the CPR. RN Ross began chest compression and Sgt. Painter maintained the resuscitator bag, squeezing it to provide the air. Medic Weismore then retrieved to AED which was then attached to the inmate. CPR was continued as well as following the instructions of the AED. Medic Weismore then started an IV on the inmate's right arm. I had Sgt. Isler double check to ensure that EVAC had been notified and was on their way. After several minutes of CPR I relieved RN Ross and took over the chest compressions to give him a break. A few minutes later Medic Weismore relieved me and started chest compressions until Fire Rescue amived and took over. Once the EVAC staff took over, the AED was removed and the inmate was hooked up to one of their monitors. The information from their monitor was transmitted to HMC. Once all of the information was obtained at HMC, Dr. McMahon pronounced inmate Comeau "signal 7" dead at 2245 hours. At that time EVAC departed. RN Ross and Medic Weismore removed their medical equipment from the cell. Inmate Comeau's body was covered with her blanket. Nothing else in the cell was disturbed. The cell door was then secured. Ofc. Bauer remained posted at the cell door and was instructed not to let anyone into the cell unless directed by the VCSO as it was now a death investigation.

At approximately 2245 hours the VCSO investigators began to arrive at VCCF. The Medical Examiner was notified at approximately 2300 hours. Luis Negrete arrived at VCCF at approximately 2325 hours. Capt. Prince, Warden Neel, Warden Pronovost, Director Clifford, Capt. Dofflemeyer and Capt. Modzelewski all responded to VCCF. The PHS Medical Director and Mental Health Doctor was contacted Rita Jorgensen responded to VCCF and provided grief counseling for staff who needed it.

The VCSO conducted their investigation and cleared the Medical Examiner to remove inmate Comeau's body. The body was removed from the block at 0046 hours then taken to ID/Rec and loaded into the Medical Examiner's vehicle and transported to the morgue. The cell was cleared by Investigator Blair for Sgt. Painter to search the cell. No suicide note or anything unusual was found in the cell. The cell was then cleared by Investigator Blair to clean at approximately 0100 hours. The cell was then thoroughly cleaned by a wing trusty using PH25.

A code white packet was started. All responding staff were directed to document their involvement and/or observations on a VCDC 402. Statements were taken from all inmates assigned to H-blk. A copy of the H-blk roster was made. A copy of North Wing's log book for Bravo Shift was made. VCDC 721's were filed on all inmates assigned to H-blk and each inmate was spoken to by medical staff. Mental Health staff was directed to talk to all of the inmates to provide grief counseling. A copy of inmate Comeau's medical records were made. Since inmate was booked in on 092607 she had not been to orientation yet and there was no Case Management file. The file from her previous incarceration was found and attached. Inmate had no one listed on her visitation card but a copy was made. Inmate had no funds in her account. A copy of her booking card was obtained from Booking. Pictures were taken of the scene. Inmate's family was notified through the Flagier County Sheriffs Office.

Inmate Comeau's personal property was pulled in ID/Rec. An inventory was completed and a VCDC 401 along with a copy of the VCDC 213 attached. The property was placed into the Warden's office.

On 09 27 07 at approximately 2046 I made rounds in H block and spoke to all the segregated inmates while I conducted my HUS checks for this date. I spoke with Inmate Comeau who appeared to be in what I would call a normal mood for her. At this time we spoke of her lock down status and she appeared to be happy that she was no longer on a mental health watch and pending being released from disciplinary confinement due to a prior incident in which occurred prior to her being released on 09 19 07. Inmate Comeau also spoke to me about her INA of (2 officer full restraint) status being removed. I then explained to Inmate Comeau that due to her prior assault history that she was to remain on the (2 officer full restraint) status until reviewed by Case Management and or the SCC board to determine her lock down status. Inmate Comeau started to become agitated yet smiling stating that she did not think that it was fair the she is still (2 officer full restraint). I explained to her that due to her assaultive history that the INA would remain in effect until released by the Warden or his designee. I ended my conversation with Inmate Comeau as she was standing at her door with no further complaint other than she was not happy with her present status. I completed my rounds in H block and continued with rounds in other blocks and wings. At approximately 2218 hours I was on the NW when I heard the radio and control announcement (code white H block). I handed over my keys to Officer Hawkins and responded to H block. At that time both medical staff on duty Mike Weismore and Jack Ross and myself responded to H block. Upon arrival Officer Bauer was present in the block standing by cell H11 waiting for the arrival of staff. I checked the cell and found Inmate Comeau with what appeared to be a shoe lace tied around her neck and to the bunk. I then immediately turned to inform the NW staff to open her cell door. At that time Officer Hawkins was at the window and opened the cell door. Upon doing so medical staff Jack Ross used a pair of surgical scissors to cut the shoe lace while medical staff Mike Weismore and myself lowered Inmate Comeau to the floor. At that time CPR was started by the medical staff. After medical staff Weismore placed the combitube into Inmate Comeau's mouth to open her airway I maintained rescue breathes by using the resuscitator bag while medical staff Jack Ross, Lt. Sophie and medical staff Mike Weismore maintained chest compressions relieving each other as needed. I continued to follow the orders as given by the medical staff until releived by EMS. Inmate Comeau was pronounced deceased by the EMS per Doctor McMahon at HMC. I then spoke to the Inmates in H block regarding their knowledge and or thoughts on this incident. The Inmate's in the block appeared to be shocked but dealing with the incident. I requested that all the inmates in the block write statements of their knowledge to aide in the forthcoming investigation. At this time I supervised the activity of the staff that was coming on to and leaving the North Wing. I attempted to keep the wing running as smoothing and efficiently as possible keeping up with the normal schedule of events. I assisted Lt. Sophie and followed all instructions as given to support the investigation that was now underway due to Inmate Comeau's suicide attempt being successful. After the Medical Examiner removed the body from the cell and Investigator Blair cleared the cell I searched the cell for any possible signs and or notes that may have been left behind by Inmate Comeau. At this time I did not find anything other that normal issued items in her cell. After I completed the search of the cell I instructed Officer Bauer to decontaminate the cell. I followed up with Officer Hutton to make sure that the cell was cleaned and decontaminated.
