Case Summary:

On 9/27/07 I was advised by Lt Davis from the Volusia County Jail of the apparent suicide of MS COMEAU. Scene response was requested. Upon arrival at the jail I was escorted into the north block, to cell H11. The body of MS COMEAU is seen supine on the floor. EVAC had attempted CPR and intubated her. A black shoestring is lying under her body. Photos were taken of the body. A closer examination revealed no trauma to the body. Two marks consistent with the shoestring are seen around her neck.

Per LE, MS COMEAU was last seen alive during rotation checks at 2046. At 2218 during a medical pass (giving medication to inmates) she was found hanging in a semi knelling from the top bunk bed. She had apparently two shoestrings together through on of the holes on the top portion of the bed and eased forward. The RN who found her advised that she had wrapped the string twice around her neck, which would account for the two marks.

LE advised that MS COMEAU suffers from depression. Today she had made a suicidal threat on the phone to a family member who advised the Jail. MS COMEAU was placed in suicide watch but later released. She was alone in her cell at the time of her death.

The body was placed in a black transport pouch and taken to MEO where it was tagged and refrigerated at 0120. NOTE: Contact Inv Blair from VCSO for autopsy time. LN
