2 Investigator Burke was advised to contact Sergeant Wingard regarding a sexual battery that occurred at the Volusia County Branch Jail. Investigator					
3 Burke contacted Sergeant Wingard, via telephone. Investigator Burke was informed the victim was currently incarcerated at the Volusia County					
4 Branch Jail and he advised he had been sexually battered by another inmate on 07/27/12. Investigator Burke contacted the victim's advocate and					
5 notified her of the incident. Investigator Burke also notified SART personnel of the incident. Investigator Burke responded to the Volusia County					
6 Branch Jail and made contact with Deputy Gray, who reported the following:					
7					
8 On 07/29/2012, at 1816 hours, Deputy Gray responded to the Volusia County Branch Jail, located at 1300 Red John Dr., Daytona Beach, in					
9 reference to a reported sexual battery between inmates. Upon arrival, Deputy Gray made contact with VCBJ Captain Reinhart (R1) who stated the					
10 following information:					
11					
12 Captain Reinhart advised on the above date, he was contacted by jail staff in reference to an alleged sexual battery that occurred between inmates,					
13 XXXXXXXX (Victim), and Steven A. Allen (Defendant). Captain Reinhart stated he made contact with XXXXXXXX who advised he was sexually					
14 battered by Allen on 07/27/2012 shortly after 2300 hrs. in the cell they both share. Captain Reinhart stated after learning about the incident he and					
15 staff immediately locked down the cell and also the entire unit. Captain Reinhart furthermore stated he transported Allen to segregations until the

16 investigation was complete. Captain Reinhart also indicated he made contact with Inmate, Sebaydan Rizvan (O1), who's cell is located next to
17 XXXXXX and Allen's cell. Captain Reinhart said Rizvan advised him that he heard a lot of noise coming from XXXXXX and Allen's cell around the
18 time of the alleged incident. Captain Reinhart stated Rizvan described the noise to sound like a bed squeaking.
19
20 Deputy Gray then met with XXXXXXXX who advised the following: XXXXXXXX explained on 07/27/2012 at approximately 2300 hrs., he was laying in his
21 bed when he was confronted by Allen. XXXXXXXX indicated that Allen grabbed under his back and lower leg and pulled him out of bed. XXXXXXXX said
22 during that time, Allen was able to pull his shorts and boxer briefs down. XXXXXXXX stated once his pants were down, Allen put him in a bear hug from
23 behind and proceeded to put his penis inside of his anus. XXXXXXXX advised once Allen's penis was inside his anus, he began to thrust in a back and
24 forth motion. XXXXXXXX stated the incident occurred for approximately five minutes until Allen ejaculated in his anus. XXXXXXXX stated during the
25 incident, he repeatedly told Allen to leave him alone, to which Allen refused to do so. XXXXXXXX advised after the altercation, he and Allen returned to
26 their beds and went to sleep. XXXXXXXX further indicated that the next night as he was laying in bed, Allen started rubbing his chest. XXXXXXXX stated
27 he immediately pushed Allen away, which caused Allen to become upset. XXXXXXXX said Allen then raised his right hand as if he was going to strike
28 him but never did so. XXXXXXXX said after which, Allen stopped his advancements towards him and went to sleep. It should be noted that XXXXXXXX
29 could not advise what was said to him by Allen during the two incidents.
30
31 During the investigation, it was learned XXXXXXXX was still wearing the same shorts and boxer briefs that he was wearing during the incident. Deputy
32 Gray informed Sgt. Wingard of the information gathered to which Sgt Wingard in return, contacted VCISO Investigator C. Burke. Investigator Burke
33 later responded to the scene and took over the investigation.
34
35 Deputy Gray took no further action in regards to the incident.
36
37 After speaking with Deputy Gray, Investigator Burke made contact with Lieutenant Gray inside the jail.
38
39 At approximately 2039 hours, Investigator Burke made contact with the victim, XXXXXXXXXXXX (V1). XXXXXXXX stated on 07/27/12 between
40 approximately 2300 and 2330 hours, his cellmate, identified as Steven Allen (Defendant), pulled him off his top bunk and then proceeded to pull his
41 shorts down. XXXXXXXX stated Allen did not have on any clothing when he pulled him off his bunk. XXXXXXXX stated he did tell Allen, "No", "Get away
42 from me". XXXXXXXX advised when Allen pulled him off his bunk he tried to push him away. XXXXXXXX stated he finally got away from Allen and got
43 near the door, but Allen began pulling him away. XXXXXXXX stated Allen grabbed him around his arms, like a "bear hug" and then proceeded to put
44 his penis in his anus, which occurred against a wall near the bunks. XXXXXXXX advised he could not move his arms when Allen was holding him.
45 XXXXXXXX stated he told Allen to get off of him and to leave him alone. XXXXXXXX advised Allen did tell him it would take him five (5) minutes.
46 XXXXXXXX further stated Allen did ejaculate inside him.
47
48 XXXXXXXX stated on 07/28/12 Allen began touching him again, but he told Allen to get off of him. XXXXXXXX advised Allen brought his hand back, as if
49 he was going to hit him. XXXXXXXX stated he did not report the incident sooner because he was scared to report it. XXXXXXXX stated he wished to
50 pursue criminal charges and wished to have a medical exam completed. XXXXXXXX raised his right hand and swore to the statements he provided to
51 Investigator Burke.
52
53 It should be noted during the interview with XXXXXXXX he also advised Allen kept telling him to take a shower. XXXXXXXX did inform the SANE nurse he
54 had a learning disability. During the interview with XXXXXXXX, it appeared he had some sort of cognitive disability.
55
56 Corrections staff later transported XXXXXXXX to Halifax Hospital, located in Daytona Beach. A SART medical exam was initiated at approximately
57 2150 hours and was completed at approximately 0021 hours. It should be noted Investigator Burke heard XXXXXXXX advise the SANE nurse, Allen did
58 use lubricant during the incident. The SANE nurse turned over the FDLE Sexual Assault Evidence Kit, along with the victim's underwear, and the
59 victim's pair of green shorts, to Investigator Burke. XXXXXXXX was transported back to the Volusia County Branch Jail by Corrections.
60
61 Investigator Burke responded back to the Volusia County Branch Jail. Investigator Burke made contact with Lieutenant Gray. Investigator Burke was
62 informed by Lieutenant Gray, Allen asked a staff member for bleach on 07/29/12.
63
64 Investigator Burke then interviewed Rizvan. Rizvan stated his cell was next to XXXXXXXX's and Allen's (AKA Miami) cell. Rizvan advised he sleeps on
65 the top bunk in his cell. Rizvan stated on 07/27/12 between approximately 0000 hours and 0100 hours, his bunk kept moving. Rizvan advised their
66 bunks are actually bolted together. Rizvan stated he heard a commotion in the cell next to him, but he could not decipher exactly what was going on.

67 Rizvan stated XXXXXXX and Allen would be the only two people in the cell at that time. Rizvan raised his right hand and swore to the statements he
68 provided to Investigator Burke.
69
70 Investigator Burke then interviewed Allen. Investigator Burke read Allen his Miranda Warnings from a pre-printed department issued card. Allen
71 stated he understood his rights and wished to speak with Investigator Burke.
72
73 Allen stated he was in cell number XX with XXXXX. Allen advised XXXXXXX moved into the cell with him on Friday, 07/27/12. Allen advised he slept
74 on the bottom bunk and XXXXXXX slept on the top bunk. Allen stated he asked XXXXXXX to take a shower and to clean-up after himself, due to him
75 being sick. Allen advised XXXXXXX appeared to be "slow". Investigator Burke asked Allen if he and XXXXXXX were involved in any sexual activities
76 and he denied being involved in sexual activities with XXXXXXX. Allen continued to say he never did anything to or with XXXXXXX.
77
78 When Investigator Burke asked Allen if he and XXXXXXX were involved in sexual activities, he continued to deny any involvement. When Allen was
79 made aware of the allegations, Allen continued to state he did not do anything against XXXXXXX's will. When Investigator Burke asked Allen if he and
80 XXXXXXX had sexual intercourse, he would deflect the question and become defensive. Allen continued to state he did not do anything against
81 XXXXXXX's will. Allen also stated as inmates they are not allowed be involved in sexual activities as they can get into trouble. Allen further advised
82 his DNA would not be located inside XXXXXXX. Allen further stated he never went that far with XXXXXXX. Allen kept telling Investigator Burke he did
83 not do anything against XXXXXXX's will.
84
85 Allen later advised he did have sexual intercourse with XXXXXXX. Allen stated he did not take XXXXXXX's clothes off nor did XXXXXXX take his own
86 clothes off. Allen advised he and XXXXXXX were standing up near the window when he penetrated XXXXXXX's anus with his penis. Allen stated he
87 had sexual intercourse with XXXXXXX for approximately two (2) minutes. Allen stated nothing else took place. Allen advised he did use a lubricant,
88 which was cocoa butter. Allen stated he did ejaculate, but not inside of XXXXXXX. Allen further stated he did not take anything from XXXXXXX.
89
90 Also during the interview with Allen, he stated he cleaned his cell everyday. Allen advised he did ask a Sergeant for chemicals for the showers,
91 however he stated someone else cleans the showers, possibly trustees. Allen stated he was just trying to get the Sergeant to bring him the
92 chemicals. Allen advised he would have cleaned his cell or the bathrooms with the chemicals. Allen raised his right hand and swore to the
93 statements he provided to Investigator Burke.
94
95 Investigator Burke asked Lieutenant Gray if they located cocoa butter in the cell. Lieutenant Gray looked through Allen's property and located a
96 bottle of Freshscent cocoa butter, which was approximately half full. Lieutenant Gray turned the property over to Investigator Burke (property sheet
97 signed). Investigator Burke took digital photographs of the cell where the incident occurred and later copied them onto a compact disc.
98
99 All the interviews were audio recorded, which were later copied onto a compact disc. Investigator Burke submitted the FDLE Sexual Assault
100 Evidence Kit and the victim's underwear into the District IV Evidence cooler. Investigator Burke also submitted the victim's pair of green shorts, the
101 bottle of Fresh Scent cocoa butter, the compact disc containing the photographs, and the compact discs containing the interviews into a District IV
102 evidence locker for safekeeping.
103
104 Investigator Burke completed a Florida Department of Law Enforcement request for examination of physical evidence form and submitted it to the
105 Volusia County Sheriff's Office Evidence Section.
106
107 On 08/02/12, Investigator Burke responded to the Volusia County Branch Jail. Allen was arrested for sexual battery.



1 On 07/29/12, at approximately 1916 hours, Investigator Burke was contacted by the Volusia County Sheriff's Office Communications Center.

2 Investigator Burke was advised to contact Sergeant Wingard regarding a sexual battery that occurred at the Volusia County Branch Jail.

3 Investigator Burke contacted Sergeant Wingard, via telephone. Investigator Burke was informed the victim was currently incarcerated at the

4 Volusia County Branch Jail and he advised he had been sexually battered by another inmate on 07/27/12. Investigator Burke contacted the

5 victim's advocate and notified her of the incident. Investigator Burke also notified SART personnel of the incident. Investigator Burke responded

6 to the Volusia County Branch Jail and made contact with Deputy Gray.

7

8 After speaking with Deputy Gray, Investigator Burke made contact with Lieutenant Gray inside the jail.

9

10 At approximately 2039 hours, Investigator Burke made contact with the victim, XXXXXXXX (V1). XXXXXXXX stated on 07/27/12 between

11 approximately 2300 and 2330 hours, his cellmate, identified as Steven Allen (Defendant), pulled him off his top bunk and then proceeded to pull

12 his shorts down. XXXXXX stated Allen did not have on any clothing when he pulled him off his bunk. XXXXXXXX stated he did tell Allen, "No", "Get

13 away from me". XXXXXXXX advised when Allen pulled him off his bunk he tried to push him away. XXXXXXXX stated he finally got away from Allen

14 and got near the door, but Allen began pulling him away. XXXXXXXX stated Allen grabbed him around his arms, like a "bear hug" and then

15 proceeded to put his penis in his anus, which occurred against a wall near the bunks. XXXXXXXX advised he could not move his arms when Allen

16 was holding him. XXXXXXXX stated he told Allen to get off of him and to leave him alone. XXXXXXXX advised Allen did tell him it would take him five

17 (5) minutes. XXXXXXXX further stated Allen did ejaculate inside him.

19 XXXXXX stated on 07/28/12 Allen began touching him again, but he told Allen to get off of him. XXXXXXXX advised Allen brought his hand back, as

20 if he was going to hit him. XXXXXXXX stated he did not report the incident sooner because he was scared to report it. XXXXXXXX stated he wished to

21 pursue criminal charges and wished to have a medical exam completed. XXXXXXXX raised his right hand and swore to the statements he provided

22 to Investigator Burke.

24 It should be noted during the interview with XXXXXXXX he also advised Allen kept telling him to take a shower. XXXXXXXX did inform the SANE nurse

25 he had a learning disability. During the interview with XXXXXXXX, it appeared he had some sort of cognitive disability.

26

27 Corrections staff later transported XXXXXXXX to Halifax Hospital, located in Daytona Beach. A SART medical exam was initiated at approximately

28 2150 hours and was completed at approximately 0021 hours. It should be noted Investigator Burke heard XXXXXXXX advise the SANE nurse, Allen

29 did use lubricant during the incident. The SANE nurse turned over the FDLE Sexual Assault Evidence Kit, along with the victim's underwear, and

30 the victim's pair of green shorts, to Investigator Burke. XXXXXXXX was transported back to the Volusia County Branch Jail by Corrections.

31

32 Investigator Burke responded back to the Volusia County Branch Jail. Investigator Burke made contact with Lieutenant Gray. Investigator Burke

33 was informed by Lieutenant Gray, Allen asked a staff member for bleach on 07/29/12.

34

35 Investigator Burke then interviewed Rizvan. Rizvan stated his cell was next to XXXXXXXX's and Allen's (AKA Miami) cell. Rizvan advised he sleeps

36 on the top bunk in his cell. Rizvan stated on 07/27/12 between approximately 0000 hours and 0100 hours, his bunk kept moving. Rizvan advised

37 their bunks are actually bolted together. Rizvan stated he heard a commotion in the cell next to him, but he could not decipher exactly what was

38 going on. Rizvan stated XXXXXXXX and Allen would be the only two people in the cell at that time. Rizvan raised his right hand and swore to the

39 statements he provided to Investigator Burke.

40

41 Investigator Burke then interviewed Allen. Investigator Burke read Allen his Miranda Warnings from a pre-printed department issued card. Allen

42 stated he understood his rights and wished to speak with Investigator Burke.

43

44 Allen stated he was in cell number XX with XXXXXXXX. Allen advised XXXXXXXX moved into the cell with him on Friday, 07/27/12. Allen advised he

45 slept on the bottom bunk and XXXXXXXX slept on the top bunk. Allen stated he asked XXXXXXXX to take a shower and to clean-up after himself, due

46 to him being sick. Allen advised XXXXXXXX appeared to be "slow". Investigator Burke asked Allen if he and XXXXXXXX were involved in any sexual

47 activities and he denied being involved in sexual activities with XXXXXXXX. Allen continued to say he never did anything to or with XXXXXXXX.

49 When Investigator Burke asked Allen if he and XXXXXXXX were involved in sexual activities, he continued to deny any involvement. When Allen

50 was made aware of the allegations, Allen continued to state he did not do anything against XXXXXXXX's will. When Investigator Burke asked Allen if

51 he and XXXXXXXX had sexual intercourse, he would deflect the question and become defensive. Allen continued to state he did not do anything

52 against XXXXXXXX's will. Allen also stated as inmates they are not allowed to be involved in sexual activities as they can get into trouble. Allen further

53 advised his DNA would not be located inside XXXXXXXX. Allen further stated he never went that far with XXXXXXXX. Allen kept telling Investigator

54 Burke he did not do anything against XXXXXXXX's will.


