Notice of Intent to Suspend Without Pay

REFERENCE:

Purpose: The purpose of this memorandum is to provide notice of intent to suspend without pay.

Because of your recent arrest, the County has the right to suspend you without pay for seven calendar days or until our investigation is completed. This is provided in Section 86-455 of the Merit System Rules and Regulations (c)(1)a.

Background: On Tuesday, March 18, 2014, you were arrested by the Florida Department of Law Enforcement under the allegation of child pornography.

Information: On Tuesday, March 18, 2014, you were involved in a standoff with the Florida Department of Law Enforcement and the Volusia County Sheriff's Office SWAT team. You surrendered to the Florida Department of Law Enforcement and were arrested on two counts of possession and distribution of child pornography.

Violations: Your actions on March 18, 2014, violated the following:

<u>Volusia County Merit System Rules and Regulations – Division 13 Reasons for Disciplinary Actions</u> <u>Sec 86-453 Reasons for Disciplinary Action (8); and (13)</u>

Sec. 86-453

- (8) Criminal, dishonest or other conduct which interferes with effective job performance or has an adverse effect on the efficiency of county service.
- (13) Any conduct, on or off duty, that reflects unfavorably on the count as an employer.

Conclusion: Accordingly and based on your arrest on March 18, 2014, I am issuing this letter of intent to suspend you without pay. Because of your recent arrest, the County has the right to suspend you without pay for seven calendar days or until our investigation is completed. This is provided in Section 86-455 of the Merit System Rules and Regulations (c)(1)a.

Should your response be inadequate or should you fail to respond in a timely manner, this action will proceed.
