Interesting - so apparently there is NO Volusia County "policy" - rather Volusia County is just attempting to follow State Law. VolusiaExposed.Com is obviously very much aware of F.S. 119 (Florida Public Records Law). We just wanted to confirm whether an actual "County Policy" existed. Apparently by your response, no actual county policy exists.

As you might, or might not be aware of - VolusiaExposed's tag line is - "Keeping the public safety employees we trust to enforce our laws, within the law." - Therefore, it is our duty to report that at least three current or former law enforcement officers / correctional officers pictures are currently posted on the Volusia County Website.

Ironically all of these officers are apparently personally known to Lt. Langdon.

We, here at VolusiaExposed.Com are confident that since the Volusia County Government now openly admits in this email that posting these pictures are violations of Florida State Law, that these pictures will be immediately removed. In doing so, Volusia County will be in compliance with Florida Law and VolusiaExposed will have accomplished its mission of ensuring that our government officials obey the very laws that they are entrusted to enforce.

At least one of these officers have been openly threaten in the past, whereas a criminal conviction was secured against the subject making the threat. Surely it is NOT the intentions of Volusia County Government to subject these current / former officers to such additional threats. Is it?
