Joel Bressett said he was told by Katrina M. Bressett of a altercation which may have been physical. Joel Bressett said he notified central dispatch.</p> <p>3 Upon arrival, Officer Curcio made contact with Summer A. Bogami who advised she was in a verbal altercation with Nathan R. Buckley over relationship issues. Bogami advised the verbal altercation became physical when they began to shove each other. Bogami was unsure who started the altercation. Bogami advised Buckley grabbed her right forearm and the inside of her left arm during the altercation. Bogami stated she did not wish to prosecute and refused to provide a sworn written statement. Officer Curcio provided Bogami a domestic violence rights and remedies pamphlet, which she signed for. Officer Curcio observed bruising on the inside of Bogami's left arm and red marks with slight bruising on her right forearm, where she alleged she was grabbed during the altercation. Bogami denied medical attention. Bogami advised Officer Curcio she has a child in common with Buckley. 16 was in a verbal and physical altercation with Buckley. Bressett advised Bogami stated Buckley grabbed the inside of her right arm and left forearm and threw her into a coffee table multiples times. Bressett said Bogami told her Buckley had punched a mirror and cut his hand. Bressett stated 17 Bogami had blood on her shirt and key fob, which was from Buckley. Bressett advised Bogami stated Buckley choked her but did not specify if it cut 18 off her air way. Bressett advised Bogami stated she attempted to shove Buckley off while being choked. Bressett refused to provide a sworn written 19 statement but agreed to a sworn verbal statement, which was captured on Officer Curcio's body worn camera. Bressett Provided Officer Curcio with 20 photographs of blood on Bogami's key fob, a bloody print on Bogami's forearm. Officer Potter obtained photos of the blood on Bogam's shirt. 21

22 Officer Curcio responded to [REDACTED] Upon arrival, Officer Curcio made contact with Buckley who denied having any verbal or physical 23 altercation with Bogami. Sergeant Hirsch attempted to retrieve more information from Buckley; however, Buckley was not willing to speak. Sergeant 24 Hirsch asked Buckley about the injuries on his hands; Buckley advised he acquired the lacerations from punching a mirror in his residence. While 25 inside the home, officers observed blood on the floor in the living room and on the wall. Buckley showed officers a broken beer bottle and a picture 26 frame inside the trash can located in the kitchen. Buckley advised Bogami broke the bottle and picture frame on the ground during the altercation. 27 Officer Curcio observed blood on the kitchen floor and side door leading outside. Sergeant Hirsch provided Buckley a third opportunity to provide a 28 statement. Buckley denied the verbal and physical altercation again. Buckley had some minor redness to each side of his neck. Officer Potter took 29 photos of Buckley's injuries. 30

31 Sergeant Hirsch obtained photos of the broken furniture inside the residence. All photos obtained during the investigation were placed onto a CD and 32 into evidence. 33

34 Officer Curcio's investigation revealed the following facts:

35 Bogami and Buckley were in a verbal altercation. The verbal argument became physical when Buckley became the primary aggressor and grabbed 36 the inside of Bogami's left arm and right forearm while throwing her to the ground into the coffee table. Buckley began to choke Bogami which led to 37 Bogami shoving him in attempt to protect her self. Due to statements and physical evidence, Officer Curcio found probable cause to place Buckley 38 under arrest for domestic battery. Buckley was secured by Officer Potter and was placed into the patrol car. While on the way to the patrol vehicle 39 Buckley spontaneously uttered how he grabbed Bogami's arm in attempt to make her leave the residence. Buckley additionally said he was attacked 40 by Bogami during the altercation and was only attempting to escort her out of the residence after being placed under arrest. 41

42 Officer Curcio transported Buckley to the Edgewater Police Department for processing. Upon completion of the paperwork, Buckley was transported 43 to the Volusia County Branch Jail. 44

45 Brayden M. Buckley was picked up by his legal mother Summer A. Bogami in completion of the investigation. Brayden Buckley was present during 46 the altercation. 47


48 Officer Curcio, Officer Potter and Sergeant Hirsch utilized their department issued Taser Axon Body Camera's during the investigation. 49


