Well it's done and over with, I don't talk to her no more. I don't try to contact anybody anymore. They ask me questions about inmates now I tell them sorry I can't help you. Talk to me about, they come up and you know, try to eyeball me or anything anymore, get away from me I don't want to be caught up in it, which I already am. But, well, kind of cut that off thinking, you know, hey I don't want to you know be dealing with you. I don't want to be in trouble, which I am.

Modzelewski: Yup.

Neel:

But. There is no kind of contact anymore.

Modzelewski: Since you have gotten notice of this investigation have you had any

contact with that female?

Neel:

Which one? The

Modzelewski: The one that you have met three times, or alleged met three times?

Neel:

That was, that was uhm, I actually killed that off awhile before because I

told her that I didn't want to get involved in anything.

Modzelewski: Have you, have you talked to anyone and tried to coerce their conversation

in the event that I contacted them?

Neel:

In here?

Modzelewski: Anywhere.

Neel:

No.

Modzelewski: Told your friend T.J, hey if this guy calls you tell him this or that. Or

called her up, hey if you get contacted by this guy.

Neel:

I haven't seen T.J since, it was awhile before I went to Ohio.

Modzelewski: Have you discussed this situation?

Neel:

I haven't, my dad told me not to and I said okay.

Modzelewski: Okay so other than your dad you haven't discussed this with anybody.

Neel:

Exactly.

Modzelewski: Haven't contacted anyone?

Neel:

Inmates come up in here and ask me to do that stuff, no you are going to

get me in trouble, that's all I say.

Modzelewski: You sure it was only three times that you met this young lady? Are you

sure that's what she is going to say?

Neel:

I didn't meet her a lot. Huh.

Modzelewski: Have you ever met her family? You said that she had a couple of kids.

Neel:

Her mom when I went there.

Modzelewski: Where did you meet her mom?

Neel:

Up there with her.

Modzelewski: What's her mom's name?

Neel:

I don't know, something weird. That's why I can't you know think about

it. She's a little (inaudible).

Modzelewski: Have you had, one more time, you particularly zeroed in on this one

female, are you sure there weren't other females that you met outside of

here that were in custody?

Neel:

Ah hum.

Modzelewski: So she was the only one.

Neel:

Ah hum.

Modzelewski: You went up there for a reason Dustin, she told you where she was going

to be, you went there for a reason. You didn't go there just because.

Neel:

It was, it was going to be then I realized that it shouldn't be.

Modzelewski: So you were pursuing, you were in fact pursuing or at least exploring the

possibility of being involved.

Neel:

Exploring. But then it was, not, not...

Modzelewski. So those three encounters weren't, none of them were just chance encounters, they were all orchestrated, planned.

Neel:

Well that's, well that's what I said.

Modzelewski: That's what you said the second time.

Neel:

Yeah, second time, I'm sorry, (inaudible) I don't want to, I don't want to bullshit you, which I was at first.

Modzelewski: (sigh) Why weren't you truthful initially, you knew coming...

Neel:

Because...

Modzelewski: into this room.

Neel:

I was, I was nervous. I was really nervous.

Modzelewski: Did I not tell you, that...

Neel:

Yes I know, I know.

Modzelewski: the worse thing you could do is not be truthful.

Neel:

Yes you did.

Modzelewski: And what happened?

Neel:

I was slipping around the truth.

Modzelewski: You were completely avoiding the truth.

Neel:

Well.

Modzelewski: You knew.

Neel:

Well it, it was kind of awkward say, you know, hey I went up there to meet her. Cause, you know I did not know how to put it the words. You know, I was going to go up there and you know, check to see how, you know, what could, what could maybe happen and then not, you know, then I didn't want nothing to happen. I, you know, hard, hard to explain.

Modzelewski: You know that the difficult thing right now is that you had that

prearranged meeting.

Yes, I know.

Modzelewski: What adds to the difficulty is that you weren't truthful up front about it.

Neel:

Yes, I know.

Modzelewski: And that now creates a more difficult problem.

Neel:

Yes, I know, which I should have in the first place say, hey she said meet

her here, I went up there, talked to her.

Modzelewski: Now I have been doing this job for a long time.

Neel:

All right.

Modzelewski: And I'm going to start looking at stuff.

Neel:

Ah hum.

Modzelewski: I don't need to find things on my own, is there anything else out there that's going to come up and hit me in the face.

Neel:

She's the only one that I have met. Seriously

Modzelewski: And only three times?

Neel:

It should be right there all in a row. There all pretty close together.

Modzelewski: Has she ever been, and I'm going to ask you directly, these are yes or no answers. Has she ever been to your house?

Neel:

No she has not been to my house.

Modzelewski: Have you ever been to her house?

Neel:

No.

Modzelewski: Has she ever been to your friend's house?

Neel:

No.

Modzelewski: Has she ever been to any of your friend's houses?

Neel:

No, I try...

Modzelewski: Have you met her other than the three locations, have you met her anywhere else where you were alone privately with her?

Neel:

Her kids were always with us.

Modzelewski: How many kids?

Neel:

Two.

Modzelewski: What's their names?

Neel:

Uhm, I'm thinking one's, the oldest one was named Jasmine and the

youngest one was named Tatiana (sp).

Modzelewski: Okay so only one female?

Neel:

From the, I didn't tell you, from the Race Track, we did, we went up ah,

by the beach, not, you know, that's whenever I first, you know, went up

there initially to explore something.

Modzelewski: Ah hum.

Neel:

And then we left.

Modzelewski: So you left the Race Track.

Neel:

On up to the beach.

Modzelewski: And went to beach where at, New Smyrna?

Neel:

Ah, the I guess it would be Flagler, that's the county in...

Modzelewski: Oh Flagler Beach?

Neel:

Barberville, whatever, it is, right?

Modzelewski: Yeah, well, you went north. Flagler Beach.

Neel:

(inaudible)

Modzelewski: To the pier?

It was just some old side pull off and her kids were out there playing in the sand, and then we were talking and I got, you know, real creeped out with her kids being there.

Modzelewski: Okay.

Neel:

So probably if her kids weren't there, it probably would have went a little bit farther, if she didn't have kids. But it was a little bit weird with, you know, I don't something.

Modzelewski: In other words the kids prevented you from becoming...

Neel:

Which is...

Modzelewski: sexually involved.

Neel:

which probably is a little bit kind of glad that's the way it happened.

Modzelewski: But you were passionate with her, you just weren't sexually involved?

Neel:

No I wouldn't even say that, I would just say, you know.

Modzelewski: What would you say?

Neel:

Exploring the possibility of maybe being passionate with her.

Modzelewski: Were you kissing her?

Neel:

No.

Modzelewski: Okay, did you walk on the beach with her?

Neel:

We were up by, there was a near a wooden thing, we talked up there.

Modzelewski: Holding hands?

Neel:

No.

Modzelewski: No contact.

Neel:

We were just standing next to each other.

Modzelewski: Okay, but no physical contact?

Like she came up and hugged me when I you know, first met, you know.

Modzelewski: Okay, so first time, you meet her at the track and then you went to the

beach.

Neel:

We...

Modzelewski: You added the beach to the first time.

Neel:

we went up there and talked.

Modzelewski: Okay, so now second time. That was it, you guys left from the beach and

then where did you go?

Neel:

I took her back and she drove away.

Modzelewski: Took her back to where?

Neel:

To her truck.

Modzelewski: Where was that car at or truck, or whatever she drives?

Neel:

She had drove, we left it up on or by the Race Track cause that's close to

her house I guess.

Modzelewski: Okay.

Neel:

So she said...

Modzelewski: Never been to her house?

Neel:

She said that she lived around that way.

Modzelewski: Never been to her house?

Neel:

No, she said she lived in a trailer.

Modzelewski: Have you ever been to her trailer?

Neel:

No I don't...

Modzelewski: Have you ever been to where she lives?

dig trailers, you know, don't dig trailers. I told her, I said if you have got a trailer I don't want to go. That was the first time whenever we talked because that was the one thing about, you know, she said oh I have a trailer, I don't want to go to a trailer.

Modzelewski: Okay let's get back to the time that she was released, what kind of car do you drive?

Neel:

Ford (inaudible).

Modzelewski: What's your license tag number?

Neel:

Something Q and L, A something Q and L.

Modzelewski: Okay. Is that the only car that you have driven in the last month?

Neel: Hum, I when I moved I drove my dad's truck. That was (inaudible).

Modzelewski: Okay so in the last say, thirty days the only vehicle that you operated was your own personal vehicle. Didn't borrow your dad's truck, your fiend's car...

Neel:

No.

Modzelewski: nothing? Never drove them? Only your own vehicle.

Neel:

Yeah.

Modzelewski: Your working on night shift, you were, weren't you? Or were you always on day shift?

Neel:

Ah, when I first started, when I very first started, I worked on nights.

Neel:

I think it was a month before I went to school. It was like ten days and

then I had a week.

Modzelewski: When did you graduate out of the academy?

Neel:

Ah, December.

Modzelewski: This past December, right?
