Yes. Those copies were sent to the legal department for review. It was necessary that four attorneys review them as they handle different areas of interest. The result of the review is that nine documents (29 ppg) are exempt from public records at this time because they relate to pending litigation or open investigation. Included with the copies will be a list of those nine documents with the identifying information and the statute which applies to the exemption. At such time as the litigation or investigation is complete, those copies become public record.

Because you paid for 49 pages, I am including a credit slip which you may apply to your next paid public records copies.
