Accusations against SGT Willie Jenkins

Purpose: To provide the results of a fact finding inquiry regarding an accusation against staff.

Background: On the morning of October 17, 2016, I was briefed regarding an accusation made against staff. Evidently inmate Salina Hillman (981643) reported that inmate Culler, Stacey (983768) had told her that she had had a sexual relationship with SGT Willie Jenkins. I was told that SGT Prudente had interviewed Culler about the potential relationship and that Culler had denied any such relationship.

On the afternoon of October 17, 2016, I was briefed once again about this situation. Evidently SGT Westgate was conducting rounds with Case Manager Craitin when immate Culler, Stacey (983768) approached them requesting to speak to a Captain or someone with rank. Culler evidently reported to SGT Westgate that there was some truth to the investigation SGT Prudent was conducting.

On the evening of October 17, 2016, CPT Larry Langdon and I met with inmate Culler regarding the accusation against staff. As soon as we began speaking to inmate Culler she began to tell us about a sexual encounter she had with SGT Jenkins. Culler said that she wanted to recant the statement she had made when SGT Prudente had asked her. Culler made a written statement admitting to having sex for money (\$100.00) with SGT Jenkins on or about October 2 or 3, 2016. Culler said that she had received a text message from an ad she had posted on backpage.com, which she said was a website for an escort service. She said that SGT Jenkins arrived at her hotel room at approximately 0530 hours and said he had a present for her. She said that Jenkins handed her \$100.00 and they had sex. See her complete statement for additional details. Culler said that she has saved the text messages and has Jenkins contact information in her phone under Will Jenkins, because that is what he told her to call him. She said that her friend has her phone and she can provide evidence of her story if she can make contact with her friend who has her phone.

On October 18, 2016, I received another briefing regarding this situation, but this time inmate inmate Muja, Lindite (983336) had made comments in dorm 3 in the presence of SGT Isaac that inmate Watt, Breanna (983299) had had sex with SGT Jenkins for money. SGT Isaac repried what had been said to CPT Langdon and on the afternoon of October 18, 2016, CPT Langdon and I met with and interviewed

inmate's Muja and Watt.

Neither inmate wanted to make a written statement, but inmate Muja stated that SGT Jenkins had picked up inmate Watt at Muja's house and drove a maroon Nissan Maxima that was shiny like his head and his boots. Muja said that she hung out with Jenkins and Watt at a hotel in Daytona and that Jenkins got pissed because Watt would not have sex with him a second time one day so he left the hotel. Muja said that Jenkins told them all about Officer Lynch being fired because she was having a relationship with a female inmate and that Wilder was terminated because her house was searched by the police and that the kitchen at VCCF was closing in the future.

Inmate Watt denied having sex with Jenkins, but stated over and over that Jenkins has asked her several times for oral sex and has paid for hotel rooms, food and even given her money to buy drugs with hopes of having sex with her. Watt said that she has played Jenkins many times over, but would never have sex with him, because he is black and her dad would never forgive her. Watt admitted to having a backpage account, but denied ever receiving any hits from Jenkins on that website. Watt told us that Jenkins makes contact with her through Facebook or a person named Liz Drees who has also been in custody. Watt went on to state that there are several other ex-inmates who Jenkins contacts and has sex with outside of the jail. She mentioned someone named Jazmen Vasquex who is in FDOC custody. Watt claims that Vasquez was bragging the last time she was in VCDC custody about the relationship. Watt described Jenkins' car and said that they (Jenkins, Drees and Watt) have gone to dinner several times. Watt was released from prison in July 2016, so she said they have gone to dinner at least twice since then. She said she knows Jenkins from the jail.

### Findings:

Based on the information gathered in the fact finding inquiry, I am requesting an Internal Investigation in this matter.

On the above date and time an interview was conducted with inmate Culler, Stacy 983768. Director Flowers and I were present. The interview started at approximately 1610 hours. The purpose of this interview was to question inmate Culler about the validity of information regarding Sergeant Jenkins. The information that security received is that Sergeant Jenkins had solicited Ms. Culler through a web based escort service called "The Back Door". Inmate Culler informed Director Flowers and me that when she was first asked about this on 10/15/16 that she made a written statement denying the allegations. She then said that she had lied on that statement and would like to tell us the truth. Inmate Culler stated that she was contacted by a person through "The Back Door" web site and that person indicated that he knew her and she knew him, and that he would be getting off work at 5:00 am and would like to meet her at 5:30 am. She agreed. When the encounter occurred she recognized the person as Sergeant Jenkins. Inmate Culler then stated a monetary amount was exchanged between them and then they had sex. Inmate Culler then said Sergeant Jenkins told her to call him "Will" and keep this a secret. Inmate Culler then stated that she received text messages from Sergeant Jenkins requesting naked pictures of her. Inmate Culler then stated that once she was incarcerated she was pulled out of the block by Officer Chapman and then escorted down the hall by Sergeant Jenkins and questioned by Sergeant Jenkins if she had said anything about their relationship, she told him she did not. Director Flowers asked inmate Culler if she was in possession of her phone. Inmate Culler indicated that when she was arrested she had given her phone to a friend. Inmate Culler gave me the number to call to verify this information but the phone went right to voice mail. Inmate Culler said that she could get in touch with her friend though Facebook if she was given the opportunity.

The interview then ended at 1635 hours.

On 10/18/16 Director Flowers and I continued our investigation regarding allegations involving Sergeant Jenkins based on additional information received. At approximately 1300 hours we interviewed inmate Muja, Linditte # 983336. Inmate Muja was overheard talking about Sergeant Jenkins and inmate Watt, Breanna having sex in the past. Inmate Muja stated that herself Inmate Watt and Sergeant Jenkins were in a hotel room together shortly before being incarcerated in late September, 2016. While in the hotel room she said I one point Sergeant Jenkins had gotten mad because inmate Watt would not have sex with him again and left. Inmate Muja stated that while in the hotel Sergeant Jenkins would talk about operational details about the Jail. The interview with inmate Muja ended at 1310 hrs. A second interview was conducted with inmate Watt, Breanna #983299 this interview started at 1320 hrs. Inmate Watt was asked about the allegation of her having sex with Sergeant Jenkins. Inmate Watt denied ever having sex with Sergeant Jenkins but did indicated that they "hung out". She stated that Sergeant Jenkins has paid for a hotel room for her and another inmate Drees, Liz. She stated that he would give her money for drugs and he has driven her around in his car. Inmate Watts also said that Sergeant Jenkins would ask for oral sex, but she never engaged in that. This interview ended at 1400 hrs.
