The article exposed the apparent fact that the Volusia County Division of Corrections failed to investigate allegations that a jail sergeant was in violation of Florida State Moral Character Standards for Law Enforcement and Corrections Officers – as defined in Florida Administrative Code 11B-27.0011. With NO doubt – the Corrections Director within his October 19, 2016 memorandum (see scroll box – right of page within our December 13, 2016 article) – suspected that Sgt. Jenkins violated F.S. 796.07 (engaging a prostitute).

As we (VolusiaExposed.Com) explained to your office within our below linked December 12, 2016 email to your office – a suspected violation of F.S. 796.07 – whether criminally prosecuted or NOT – must cause the employing agency to conduct an internal investigation – and if the allegations are sustained – that fact must be reported to CJSTC / FDLE for possible action against the officer's law enforcement certification.

According to the WFTV article – a County Spokeswoman stated that they (Volusia) did NOT open the required internal investigation – due to the fact that Sgt. Jenkins had resigned.

As you know – and as published within a May 2010 CJSTC Professional Compliance Bulletin – the employing agency **must still conduct** this internal investigation – **regardless** of the officer's employment status. (see the below linked August 10, 2015 Volusia Exposed article – this May 2010 CJSTC Professional Compliance Bulletin is incorporated within this particular article) http://volusiaexposed.com/vcso/deputykorossy2.html

We submit — that **you** have a responsibility, as defined in F.S. 943.1395(5) - to insure that Volusia County conducts this internal investigation. We further submit - that should your office fail to uphold this responsibility — FDLE's investigative credibility regarding officer misconduct investigations with be jeopardized.

In short Mr Lehman – it's our opinion – that both the public - and Sgt. Jenkins are being short changed absent the completion of this legally mandated investigation.

Again – as per our December 12, 2016 email – we request to be advised whether your office will insure that Volusia County meets their statutory obligation to internally investigation these allegations against Sgt. Jenkins.

We anticipate posting this email – as an OPEN LETTER.
