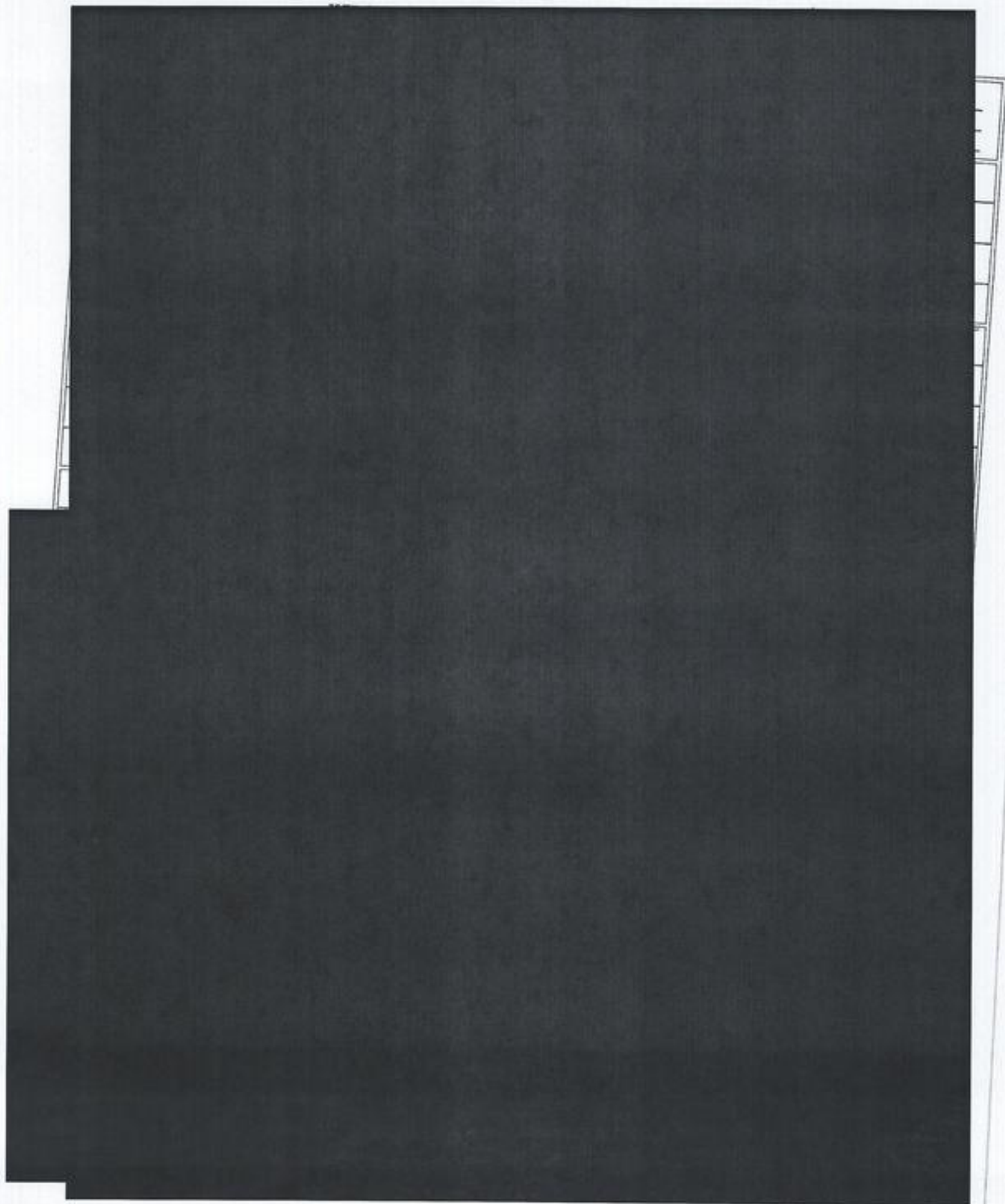

I further understand that visiting will be non-contact, meals will be eaten in my cell and I will be allowed showers daily and three hours of recreation, out of the cell, each week.

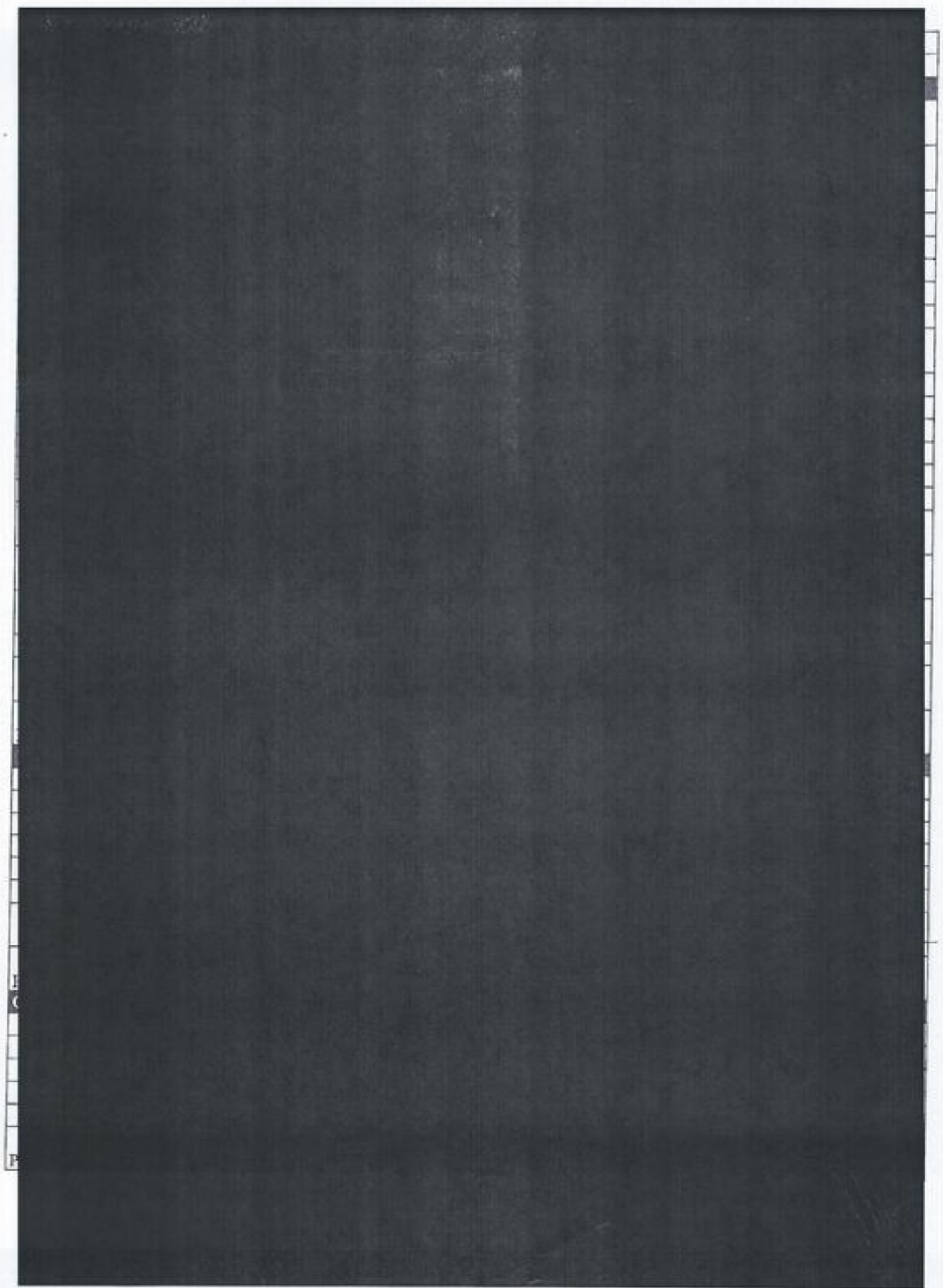

Tuesday alleged sexual assault on 07/26/2011

On Tuesday night I was in my cell (B4), I was preparing myself for the night when two men approached me from behind and held me down with my head in the mattress and my arms held by my side. One of them pulled my pants down and assaulted me sexually. The incident was only a matter of 2-3 minutes and they rushed out of my cell. I do not know the exact identity of them because I seem to be getting all of negative attention from the more experienced inmates. As for the two fights, they were more of me getting ~~put~~ backed into a corner and having to defend myself, both times one inmate was the same, he is a young black male with short dreadlocks and gold teeth and is housed on the lower right side of 5C block, the other two inmates have since been moved and I don't recall where they or most of the other inmates stay because I spend as much of my time in my cell as possible. One of them was a black male, early to mid 20's with approx 5'10", short dreadlocks and no gold teeth, the other was a young black male with no gold teeth and short hair, approx 6'2". Both of them have since moved and I'm not sure where they stayed.

I was in my cell (13c) at approx 10³⁰ ^{twilight} pm when I was preparing for the night I was approached from behind by two men and held down on the lower bunk. My arms were held down by my side and my face was pressed into the bed, I believe my roommate to be in the dayroom playing cards or watching tv. My pants were pulled down and one of the men sexually assaulted me for approx. 2-3 min then they both quickly left my cell. I did not see the two men but from the sound of their voices I believe them to be African American. Other than this information I don't have anything to go on, I seem to be a target for the more seasoned inmates.

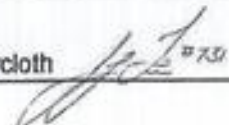

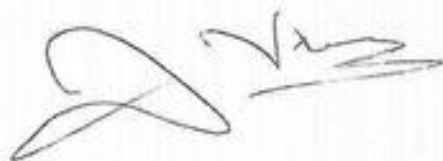

While gathering these statements I observed the exposed areas of the accused inmates. I did not note any defensive wounds on their hands, arms, neck, or face.
