I now have the file and will review. However, if there was a fraud issue that was supported by fact, even if not prosecuted, the separation code would be Terminated for Violation of Moral Character Standards 11B-27-0011,F.A.C. However, we would be required to submit documentation to FDLE Officer Discipline. Those doc's would not have to be generated from an I/A and could consist of the final termination letter and the source documents that support the language in the termination letter. I could package it up to be transmitted to FDLE, even though this was not an IA case, but, I would need the information for the package. Just for your information this should of been done by someone at the time the separation forms were transmitted to FDLE, but, late is better then not at all. Please advise how I can help bring this matter to closure.
