But during our telephone conversation today - you stated that FDLE has no authority to investigate jail DEATHS within the Volusia County jail, even where evidence exist that officers falsified their safety and security rounds. When evidence exist that there is a conflict of interest between the county jail, the sheriff department and the county medical examiner's office.

Maybe you can further explain why FDLE will arrest a DCF worker for falsifying his safety checks / rounds, but is NOT interested in reviewing our documents regarding falsification of jail rounds where SEVERAL inmates died. (Please review the below FDLE Press release)
