BASIS FOR INVESTIGATION:

On February 22, 2022, Daytona Beach Police responded to a motor vehicle accident (#P220532553) at 1851 LPGA Boulevard, Daytona Beach. The accident was reported to be a motor vehicle versus a pedestrian crash at that location. According to the reporting party, the two subjects who were involved in the accident were in an altercation. Daytona Beach Police officers arrived on-scene at 2333 hours and were unable locate anyone involved.

On February 23, 2022, at 0047 hours, Daytona Beach Police Department received an additional call at 1851 LPGA Boulevard, Daytona Beach, in reference to an alleged battery. The reporting party was [REDACTED] and her boyfriend, Deputy Jeffrey McClafferty, was the alleged suspect. According to [REDACTED] she and Deputy McClafferty currently lived together as a family unit and have been together for approximately three to four years.

[REDACTED] provided the following information to law enforcement officers who arrived at the incident location. [REDACTED] alleged she was involved in a verbal disturbance with Deputy McClafferty as the two were returning to their residence located at [REDACTED], Daytona Beach. Deputy McClafferty was driving the vehicle and the two were traveling in Deputy McClafferty's Nissan Titan pick-up truck. Upon arrival, the incident escalated, at which point Deputy McClafferty threw a soda drink at [REDACTED] [REDACTED] responded by throwing leftover food back at Deputy McClafferty, who was still inside the vehicle. After [REDACTED] threw

the food at Deputy McClafferty, he quickly accelerated his vehicle, causing the vehicle door to close on [REDACTED]. This resulted in [REDACTED] being knocked to the ground.

[REDACTED] then contacted law enforcement to report the incident. After the investigation conducted by the Daytona Beach Police Department was completed, Deputy McClafferty was arrested and charged with simple battery (domestic violence).

OFFENSES:

GO-026-02.IV.B.3 – Any other conduct or action, on-duty or off-duty, of such seriousness that disciplinary action is considered warranted.

GO-026-02.IV.F.4 – Misdemeanors Injurious to VSO – VSO personnel shall adhere to all federal, state and local laws and shall not commit any act or crime defined as a misdemeanor, first or second degree, whether chargeable or not, which brings discredit upon the VSO or otherwise impairs the operation and efficiency of the VSO or which is likely to impair the ability of personnel concerned to perform assigned duties.

GO-026-02.IV.F.6 – Criminal or Illegal Conduct – Regardless of the filing of criminal charges, or lack thereof, or the absence of a criminal conviction, criminal or illegal conduct that interferes with effective job performance or has an adverse effect on the VSO is prohibited.

INVESTIGATION:

On February 23, 2022, Chief Deputy Joseph Gallagher assigned the above incident to the Internal Affairs Unit. This report details the Internal Affairs investigation conducted by Sergeant Ben Gordon.

Sergeant Gordon obtained and reviewed the Daytona Beach Police Department report authored under case number 220003077. In the report completed, [REDACTED] is referred to as V-1, Deputy Jeffery McClafferty is referred to as D-1, and Kelly Beveridge is referred to as W-1.

Officer Wagner documented the following excerpts in DBPD 220003077:

"On February 23, 2022, at approximately 0051 hours, Officer Wagner was dispatched to 1851 LPGA Blvd. #2306 for a battery. Officer Wagner arrived on the scene at approximately 0103 hours and contacted V-1 in the residence. Officer Wagner positively identified V-1 via her Tennessee-issued Driver's license."

Officer Wagner then detailed [REDACTED] statement to law enforcement about what took place:

"V-1 stated that she was involved in a verbal argument with D-1 in D-1's 2010 Black Nissan Pickup. V-1 stated the argument was over her family. When they arrived at the residence, V-1 was getting out of the vehicle and D-1 threw V-1's cup of soda at her. V-1 stated the cup hit her and the contents splashed all over her. V-1 stated after D-1 threw the cup at her she threw a to-go box of food at D-1. V-1 stated D-1 then revved his engine causing his tires to spin and then took off at a high rate of speed. When the truck sped off it caused the passenger side door to close on V-1. V-1 fell back onto the pavement and hit the back of her head. V-1 stated her neighbor came out and saw her laying on the ground. V-1 informed Officer Wagner that D-1 is a Patrol Deputy for Volusia County Sheriff's Office."

In regards to [REDACTED] well-being Officer Wagner detailed:

"V-1 was offered medical treatment and refused. Officer Wagner did not observe any marks, scratches, or bruises on V-1." Officer Wagner offered V-1 all appropriate domestic violence paperwork and V-1 refused all of it. Officer Wagner offered V-1 access to the shelter and she refused."

Daytona Beach Police Officers then contacted Kelly Beveridge about the incident. The following was documented about the contact made with Beveridge:

"W-1 stated she heard the commotion outside and went downstairs into the parking lot. W-1 stated she did not see what happened but saw V-1 laying on the ground."

While Daytona Beach Police Officers were conducting their investigation, Deputy McClafferty arrived at the incident location. Sergeant Gordon noted the following about their interaction:

"While Officers were on scene D-1 pulled into the parking lot in his vehicle. Officers contacted D-1 at the vehicle and informed him a domestic battery investigation was being conducted. D-1 stated, "Well, I bet you are." D-1 was asked for his last name. D-1 stated, "Why." As Officers attempted to explain they were conducting an investigation D-1 stated, "come on, I'm not playing this fucking game." D-1 was detained at this time and advised of Miranda by Officer Fletcher. D-1 stated he understood his rights and wished to speak with officers on the scene. D-1 was asked what happened earlier he stated, "When." Officers stated let's start with when you got back from the bar. D-1 stated, "What Bar." D-1 was asked what happened in this parking lot. D-1 stated, "Nothing happened in the parking lot. Nothing at all." D-1 paused for a few seconds and then stated, "I pulled up here. She got out of the car. She threw food in my face. I got out of the car. My neighbors came down and hung out." Sgt. Booth started to speak with D-1 about the incident and D-1 stated, "Nothing happened." D-1 was asked if his story was "nothing happened." D-1 stated, "Nothing Happened." D-1 was placed in the back of a patrol vehicle at this time."

Volusia Sheriff's Office Watch Commander Lieutenant Tatum was notified of the incident due to Deputy McClafferty's involvement. Lieutenant Tatum responded to the location and placed Deputy McClafferty on administrative leave. Lieutenant Tatum collected all pertinent VSO equipment.

On February 23, 2022, Lieutenant Shivers and Sergeant Calkins served Deputy McClafferty with a Notice of Internal Investigation. Deputy McClafferty signed formal documentation acknowledging his receipt of the provided documents. Deputy McClafferty was also given a copy of his Florida Law Enforcement Officer's Bill of Rights. Additionally, Deputy McClafferty was notified the administrative investigation would be tolled until the criminal case was completed.

On March 8, 2022, Sergeant Gordon observed the Assistant State Attorney of the Seventh Judicial Circuit filed a "no information or intent not to prosecute" concerning Deputy McClafferty's criminal case. Internal Affairs notified Deputy McClafferty that his administrative investigation was un-tolled.

On March 9, 2022, Sergeant Gordon spoke with Assistant State Attorney (ASA) Simonsen about the criminal case. ASA Simonsen provided Sergeant Gordon a shortlist detailing the grounds for her announcement of no information:

- ██████ spoke with ASA Simonsen and stated she no longer wished to pursue criminal charges against Deputy McClafferty.
- There was no physical evidence to sustain proof beyond a reasonable doubt.
- During the incident, it was evident both parties were inebriated.
- The witness in the case did not witness the actual incident and only observed what occurred after the alleged battery occurred.

ASA Simonsen also explained that ██████ wished to dissolve the no-contact order for her safety.

Sergeant Gordon contacted Kelly Beveridge, who was a witness to the incident by the Daytona Beach Police Department report. Beveridge made clear she did not wish to participate in the administrative investigation.

On March 9, 2022, Sergeant Gordon received an unsolicited phone call from Xavier Richardson. Richardson told Sergeant Gordon he witnessed what occurred after the alleged battery and would be willing to provide a statement.

On March 31, 2022, Sergeant Gordon attempted to contact the reporting party for the motor vehicle accident involving a pedestrian (#P220532553). The unknown reporting party reported the incident approximately thirty minutes before ██████ called in to report the battery complaint.

Sergeant Gordon called the phone number provided and left a message requesting assistance with the investigation; however, Sergeant Gordon established no contact. A search of available law enforcement databases did not identify information based on the phone number provided.

An unknown person posted a video of the incident on the social media Instagram account: "whatsshadyindaytona_386." A summary of the video is as follows:

The video starts with [REDACTED] lying on the pavement in the parking lot and Deputy McClafferty driving away in his pick-up truck. [REDACTED] lies on the pavement for approximately twenty seconds and struggles to get to her feet. When [REDACTED] begins to walk, she is noticeably unbalanced and appears disoriented. Two subjects, later identified as Richardson and Deputy McClafferty, are seen checking on [REDACTED] and Deputy McClafferty collect items on the ground nearby, and [REDACTED] begins to yell expletives at Deputy McClafferty. The video ends with [REDACTED] walking toward Richardson and Deputy McClafferty walking in the opposite direction.

Interview with Xavier Richardson

On March 10, 2022, at approximately 1232 hours, Sergeant Gordon conducted a sworn recorded interview with Xavier Richardson. Sergeant Gordon interviewed 1851 LPGA Boulevard Apartment 203, Daytona Beach. Xavier Richardson, Sergeant Gordon, and Lieutenant Shivers were present for the interview. Below is a synopsis of the audio-recorded interview:

Richardson started by stating he has no prior relationship with neither Deputy McClafferty nor [REDACTED]. Additionally, he has not spoken with either party since the incident occurred.

Richardson stated how he became a witness to the incident: *"Ok, well I was sitting on the couch. Heard get the fuck out of my face. I don't know if it was from the woman or the male because it was outside. So then my girlfriend asked is that the tv? I'm like no, she comes outside she says somebody on the ground, but as that's going on we hear a car like skirt off comes around, parks. A male figure gets out of the car, he's walking up I'm talking to the woman the woman actually gets up off the ground by the time I get downstairs. So I asked her if she's fine she's like yes, she grabs her purse. My girlfriend comes downstairs. They go to talking, my girlfriend brings her upstairs lets her pet her animals. Me and the guy me and him are standing outside we're talking. He's just like she's drunk and she, but before she walked inside of the house she kept saying that the male was on probation. I don't know if it was for like criminal or whatnot but I knew from seeing him before that he was a Sheriff but I knew from the way she was talking she was antagonizing him and being like you know how would I, like aggressive towards him because I see he wasn't the aggressor so me and him kept talking and whatnot and then I just pretty much told him I said well she's upstairs I don't know what you're gonna do if you're gonna stay."*

Richardson said, *"She was drunk,"* when speaking about [REDACTED] behavior. Richardson continued and said, *"She was stumbling like she was drunk, and when she was talking to me, slurred like she was drunk."*

When Richardson contacted [REDACTED] he said, *"She fell, and then she was just laying there. And then I came up and was like, are you ok, and the first thing you tell me is I'm fine, I'm ok, and you grab your purse. Oh yeah, your girlfriend has the dogs, and yeah. Then she came down. Then they came up here. They was up here probably like two seconds and like she said she literally said the girl probably in here two seconds, didn't say Nothing all she did was pet the dogs and she said ok yeah I'm fixing to go. But my girlfriend seen her in the light. Her clothes weren't wet."*

Sergeant Gordon asked Richardson if he observed any injuries on [REDACTED] person. Richardson explained he did not see any injury to [REDACTED] Richardson believed [REDACTED] was uninjured during the incident because *"She got up and grabbed her purse and walked upstairs."*

When explicitly asked if he observed any liquid on [REDACTED] clothes, Richardson said, *"No, sir."*

While Richardson and [REDACTED] spoke, Richardson said [REDACTED] did not mention any act of violence, nor mention anything about Deputy McClafferty throwing a drink at her.

Richardson believed [REDACTED] was the primary aggressor due to several factors during the incident.

According to Richardson, [REDACTED] called Deputy McClafferty a *"dumb mother fucker"* and taunted Deputy McClafferty several times to escalate the situation. He further added, *"All I can say is she seemed like she really was trying to get him [Deputy McClafferty] to either hit her or do something."*

Richardson recalled [REDACTED] mentioning to him that Deputy McClafferty was on probation. Sergeant Gordon asked Richardson if he felt [REDACTED] was attempting to get Deputy McClafferty in trouble with his job, to which he stated: *"I can say she wasn't trying to like, she wouldn't say 'Oh I don't want you to have your job.' Nothing like that. But she, when you, when someone's referencing you're on probation, and you're doing something, I know what that means like...I could get you in trouble. I could do whatever I wanna do to you. I don't know if she's gonna do it, but I know what that means."*

Sergeant Gordon asked Richardson about his interaction with Deputy McClafferty and if Deputy McClafferty was intoxicated. Richardson explained, *"I couldn't say he was, but I could, I can say he, he probably was...He had something to drink."*

While speaking to Deputy McClafferty, Richardson commented, *"I could tell that he was the one that was trying to like, how would I say it, like make the altercation dismal. Like make it smaller than what it is. And like, like get her inside make sure she's good, and then he was gonna go about his business."*

Additionally, Richardson recalled, *"He just said she was drunk. She was saying a lot of crazy shit to him, and he was just pretty much trying to get her inside. But, I could tell that this isn't the first time. It probably happened by her getting drunk and them getting in an argument and stuff like that. But I could tell that he wasn't trying to like be on what she was on."*

Richardson then commented on the video that the unknown person posted on the Instagram account *"whatsshaddyindaytona_386:"*

"All I'm saying is I know for a fact with that video and that right there it looked like he did something but from my point of view all he did was got away. That's like if, if I was probably trying to throw something at your car or if I'm standing at your door window and I'm yanking at you or something like that he just got away from you. And parked his car because he don't know what you're fixing to do but he's gonna make sure you're ok because you fell."

Richardson continued and explained he believed [REDACTED] either fell out of the vehicle or held onto it due to her level of intoxication.

Detectives asked Richardson if he witnessed any behavior that warranted Deputy McClafferty's arrest, to which he responded, *"No. He shouldn't have been arrested."*

Richardson concluded, *"I don't think he really, he didn't do anything to like for this to be for him to like be in this situation he is in. I feel like it was blown way out of proportion because she was intoxicated."*

Interview with [REDACTED]

On March 10, 2022, at approximately 1307 hours, Sergeant Gordon conducted a sworn recorded interview with [REDACTED]. Sergeant Gordon interviewed [REDACTED] at 1851 LPGA Boulevard [REDACTED] Daytona Beach. [REDACTED], Sergeant Gordon, and Lieutenant Shivers were present for the interview. Below is a synopsis of the audio-recorded interview:

According to [REDACTED] before the incident in the parking lot, she commented, *"We were out drinking."* When they arrived at their apartment, [REDACTED] said, *"He [Deputy McClafferty] was being an asshole because he was drunk, and he wanted me to get out of the truck, so I got out of the truck. Then he's like he said "Take your Diet Coke." I had like a Diet Coke like in a, in a glass*

and he took it and then he threw it on me. So I had a to-go box and threw it back at him into the truck and then he like, I was like standing in between the door and the like you know the door is open and I'm like standing here, and he like squealed his tires and like peeled off and slammed on his brakes and the door knocked me on the ground so...."

██████ described the incident stating Deputy McClafferty's actions caused her to fall. Detectives specifically asked ██████ how Deputy McClafferty's efforts (driving forward while outside the vehicle) knocked her to the ground. ██████ responded, *"I may have been holding onto the door. I don't remember like totally. But I mean I know that I ended up on the ground."*

According to ██████ two neighbors witnessed the incident (Xavier Richardson and Kelly Beveridge) who checked on her. Additionally, Deputy McClafferty parked his pick-up truck and came to check on her. ██████ said she spoke with them briefly and then stated, *"So I went up to their apartment, the girl's apartment. And she [Beveridge] was like, "I think you should just at least like call," so I called non-emergency, and I was like, "Hey like I'm ok but like you know two other people have called and said that you guys were like you know concerned or whatever about finding somebody so here I am, hi." you know."*

It should be noted that Sergeant Gordon obtained the 911-recorded phone call placed by ██████ when she reported the incident. During the 911 call, ██████ explained, *"I just want to call and report about uh not a maybe a domestic violence I don't know."* and, *"He's drunk, Um, he's a deputy. He hit me with his door, and I fell down."*

In addition, ██████ stated in the call, *"It is what it is. I am not trying to get him in trouble; it just needs to be documented."* During the call, ██████ said, *"He [Deputy McClafferty] squealed his tires and like sped off knocked me on the ground."*

Detectives asked ██████ about the possibility of visible liquid being observed on her clothing due to the battery. Detectives explained that the officers who spoke with her did not see fluid on her clothing during the investigation. These questions were asked specifically because, in an earlier statement, ██████ described the volume of liquid on her clothing as, *"It was just all over me."* Detectives asked ██████ if there would be any reason that officers did not observe her wet clothing, and ██████ replied, *"I know I had Diet Coke spilled on me. Like, I know that I'm not lying about that, that's fine. Like I said I don't want anybody to get in trouble. Like obviously, I don't want the criminal like I, I dropped all of that like..."*

Detectives asked the follow-up question about why she wrote a sworn statement that she wished to pursue charges that night, and ██████ responded, *"I was, I was drinking I was upset. I'm a female...I was on my period."*

██████████ said Deputy McClafferty then left the area and headed to an unknown destination. After Deputy McClafferty left, she said they began to exchange text messages. Sergeant Gordon asked to obtain a copy of those messages; however, ██████████ advised she had since deleted them. ██████████ explained the messages revolved around Deputy McClafferty asking her to gather her belongings and leave the apartment.

Detectives asked ██████████ if she was in a relationship with Deputy McClafferty, to which she said, *"No, I don't, I mean, I don't think it's been like super like thrown out there I don't know that it'll be finalized until you know I move away."* According to ██████████ they lived together since Deputy McClafferty's court case had been resolved. ██████████ said she planned to move back to Chattanooga to pursue a career.

Detectives asked ██████████ if she believed Deputy McClafferty deserved to go to jail for his actions, and ██████████ replied, *"I do."*

Near the interview's conclusion, ██████████ stated she had previously been involved in a domestic violence incident while they lived in Chattanooga, Tennessee. ██████████ said, *"There was I mean there was an incident that we both almost went to jail in Chattanooga. Like I don't know if you guys are aware of that. Yeah I mean. There was warrants taken out on both of us because he slammed me against the fucking dashboard of my truck and I had a knot on my face. And then he dropped me off at home, went down to the bar and my dad called and then Chattanooga came up and they were talking to me and they're like, oh yeah, so then they went down to the bar talking to him. And he said "Oh she hit me" and this and that so they couldn't get anything, you know, that wasn't conflicting. And so they took warrants out on both of us and that was right before we moved here. We never got arrested. So there were warrants taken out. Hampton County called and said hey you guys, and they know me, hey you and have warrants or whatever and so I went to, no I went I left work and went straight to an attorney and it was first like we went like first appearance the next morning and we never had to go because they just recalled the warrants. Does that make sense?"*

According to ██████████ this occurred in June of 2021, and she and Deputy McClafferty had the records expunged. ██████████ provided the expungement paperwork about the case. While referencing the incident, ██████████ referred to it as *"bullshit."*

Interview with Sergeant Jason Turner

On March 16, 2022, at approximately 1930 hours, Sergeant Gordon conducted a sworn recorded interview with Sergeant Jason Turner. Sergeant Gordon interviewed Sergeant Turner at 123 West Indiana Avenue, DeLand, at the Sheriff's Office Administration Building. Present for the interview

was Sergeant Jason Turner, Sergeant Gordon, and Sergeant Calkins. Below is a synopsis of the audio-recorded interview:

Sergeant Turner advised he was working on February 23, 2022, as the District 3 North patrol sergeant when the Watch Commander notified him of an incident. According to Sergeant Turner, Lieutenant Tatum called him about a deputy involved in a possible domestic violence incident investigated by Daytona Beach Police Department. Sergeant Turner said Lieutenant Tatum asked him to respond to the incident location with him.

Upon arrival, Sergeant Turner began to collect Deputy McClafferty's department-issued gear at the direction of Lieutenant Tatum. While collecting Deputy McClafferty's items, Sergeant Turner recalled [REDACTED] *"was highly intoxicated."* Sergeant Turner based this determination by saying, *"I could smell a strong odor. Her speech was slurred. She was kind of emotional then just not emotional, slurring her words."* During this time, Sergeant Turner could not recall anything expressly stated by [REDACTED]

Sergeant Gordon asked Sergeant Turner if he ever made contact with Deputy McClafferty during the investigation, to which he stated, *"I did not."*

Sergeant Turner had no further information to provide about the incident.

Interview with Lieutenant Tom Tatum

On March 16, 2022, at approximately 2008 hours, Sergeant Gordon conducted a sworn recorded interview with Lieutenant Tatum. Sergeant Gordon interviewed Lieutenant Tatum at 123 West Indiana Avenue, DeLand, at the Sheriff's Office Administration Building. Present for the interview was Lieutenant Tatum, Sergeant Gordon, and Sergeant Calkins. Below is a synopsis of the audio-recorded interview:

Lieutenant Tatum stated he was working on February 23, 2022, as the night shift watch commander when Central Dispatch notified him of a possible battery incident involving a deputy. Given the circumstances, Lieutenant Tatum headed towards the calls. Lieutenant Conde with the Daytona Beach Police Department later contacted him and gave him an update about the incident. Lieutenant Tatum said, *"I just kind of touched base with them said, hey, you know I'm working tonight, so keep me updated on what's going on; I'm gonna let you guys do your investigation. I'm gonna stay out of it, so whenever you guys come in contact with him and have a conclusion, just let me know, hit me up."* Later, Lieutenant Tatum explained, *"I heard confirmation that they made an arrest, and then I got a phone call saying yeah we've got him here, and so I started enroute."*

When Lieutenant Tatum arrived at the scene, he contacted Deputy McClafferty, who was already in the backseat of a marked Daytona Beach patrol vehicle. During the conversation, Lieutenant Tatum advised, *"So I identified myself to him, and he said yeah, I know who you are. And I told him the reason I was there, and he understood, and so I asked him where his patrol car was if he had a patrol car, and he said yeah, it's in the parking lot. I'm like, well, this is a huge parking lot. Can you tell me where it is? He goes yeah, it's over there. So basically, wanted to see what he had, you know I told him the reason I was there and that if he had a patrol car if he had his duty weapon upstairs if he had a rifle, I needed to know that. So he answered all those questions. He didn't have a rifle, told me where everything was, and his girlfriend had the keys upstairs in the apartment. So that was a short conversation with him. Went upstairs and retrieved his gun belt, gun, magazines. The girl was, the girlfriend was handing me stuff left and right, so I think we took his vest, ID card, all the pertinent equipment that should actually come back with us."*

Lieutenant Tatum contacted his chain of command and received direction to place Deputy McClafferty on administrative leave. Lieutenant Tatum then *"spoke to Deputy McClafferty again and advised him you're being placed on administrative leave till further notice."*

During the interview, Detectives asked Lieutenant Tatum about Deputy McClafferty's demeanor and any observable impairments during his contact. Lieutenant Tatum commented, *"So I was too far away to smell any alcohol on his breath. He appeared to be somewhat disheveled sitting in the patrol car. I wanna say maybe he had some kind of food or some stain on his shirt. Didn't appear to be slurring too bad from his speech, but he just really just conversation was very short."*

While speaking about McClafferty's behavior, Lieutenant Tatum said, *"He had a little bit of an attitude about where he parked the car, but I mean nothing major."*

Detectives asked Lieutenant Tatum about his conversation with [REDACTED] and her demeanor during the investigation. Lieutenant explained, *"I mean, she had obvious signs of impairment. You know she was pretty high strung I would call it. So during my conversation with her I explained to her why we were there and she invited us inside and started gathering all of his stuff and she actually tried to hand me his inner duty belt the Velcro belt and she like stuck it up like almost in my face and I'm like, kind of was like whoa hey you know settle down here. And then she goes oh I'm sorry, she starts stroking my beard. And I just had to tell her step back you know just you know settle down. She just seemed like she was like overly aggressive and that's the impression that I got with her."*

It should be noted while reviewing Sergeant Turner's body-worn camera footage; Sergeant Gordon observed [REDACTED] giving Lieutenant Tatum Deputy McClafferty's issued equipment. During the encounter, [REDACTED] states, *"Well he's going to be terminated for sure"* and, *"You play stupid games you win stupid fucking prizes."* While doing so, [REDACTED] almost strikes Lieutenant Tatum's face

with a strap while handing over Deputy McClafferty's vest. [REDACTED] then reached up to stroke the left side of Lieutenant Tatum's face with her hand in a "petting" motion. Lieutenant Tatum defused the situation by moving his head away and said, "Let's just take it easy ok?" [REDACTED] immediately became upset with Lieutenant Tatum as she began staring directly at him, making hand gestures indicating her displeasure.

Sergeant Gordon asked Lieutenant Tatum if [REDACTED] made any comments about Deputy McClafferty's job. Lieutenant Tatum said, "If she did I don't recall her saying anything about that." While speaking to [REDACTED] she did not mention any injuries, and Lieutenant Tatum did not observe any sign of moisture on her clothing.

Lieutenant Tatum briefly spoke with Sergeant Booth with Daytona Beach Police Department about what took place. According to Sergeant Booth, Deputy McClafferty threw a drink at [REDACTED] which resulted in Deputy McClafferty's arrest for Domestic Violence Simple Battery.

Lieutenant Tatum then authored memo 053M0012.22, which he forwarded through the chain of command, placing Deputy McClafferty on administrative leave.

Interview with Officer Aurian Fletcher

On March 30, 2022, at approximately 2008 hours, Sergeant Gordon conducted a sworn recorded interview with Officer Aurian Fletcher. Sergeant Gordon interviewed Officer Fletcher at 129 Valor Boulevard, Daytona Beach, at the Daytona Beach Police Department. Officer Fletcher, Sergeant Gordon, and Sergeant Calkins were present for the interview. Below is a synopsis of the audio-recorded interview:

On February 23, 2022, Officer Fletcher worked as a patrol officer with the Daytona Beach Police Department. He responded to a battery complaint at 1851 LPGA Boulevard and observed one-half of the disturbance was a deputy with the Volusia Sheriff's Office.

Officer Fletcher recalled the following information "*We were dispatched to a disturbance involving a male and a female out in the parking lot. A neighbor called it in saying that they heard screaming outside and a female say, screaming I can't recall exactly what they were screaming at the time or exactly what that witness called out or said. But saying something along the lines of help out in the parking lot. And when they looked out the window, they observed a female on the ground and you know a squealing of a tire of some vehicle. As we got on-scene we made contact, we attempted to locate any subjects for the altercation and we ended up finding the victim in the case, do not recall her name.*"

Officer Fletcher contacted [REDACTED] who provided a statement about what occurred. Officer Fletcher explained, *"She [REDACTED] said that her boyfriend and her were in an argument in the parking lot. As she was getting out, she threw a cup in the car. There was some kind of cup, a battery with a cup."*

While speaking to [REDACTED] about the incident, Officer Fletcher believed she was intoxicated. Officer Fletcher did not observe any injuries on her person, nor did she complain of harm to him. Officer Fletcher said he could not see any signs of liquid on [REDACTED] clothing due to her black outfit.

During the investigation into the incident, Deputy McClafferty arrived at the location of the incident. Officer Fletcher contacted Deputy McClafferty, who had just exited his vehicle. According to Officer Fletcher, Deputy McClafferty appeared intoxicated and said, *"He wasn't truly himself as far as you know, he basically how he came up that he was a deputy is you know he said that I do your job and of course went further into it and found out that yeah he's a deputy sheriff."* Officer Fletcher said, *"I started talking to him trying to do an investigation for the bat, the reported battery."*

Officer Fletcher said, *"Speaking with him, it was like trying to get, pulling teeth, to be honest."* Officer Fletcher said Deputy McClafferty did not comment further on what occurred between [REDACTED] and himself.

Officer Fletcher explained Deputy McClafferty was arrested due to the battery complaint provided by [REDACTED] coupled with Deputy McClafferty not providing a statement on the matter.

Interview with Officer Sean Wagner

On March 30, 2022, at approximately 2115 hours, Sergeant Gordon conducted a sworn recorded interview with Officer Sean Wagner. Sergeant Gordon interviewed Officer Wagner at 129 Valor Boulevard, Daytona Beach, at the Daytona Beach Police Department. Officer Wagner, Sergeant Gordon, and Sergeant Calkins were present for the interview. Below is a synopsis of the audio-recorded interview:

Officer Wagner started by saying he was working the night of the incident, which was February 23, 2022.

Officer Wagner provided insight into the first call received from 1851 LPGA Boulevard, Daytona Beach, which came out as a possible motor vehicle accident. Officer Wagner said, *"Earlier that night we got a call about a black truck potentially hitting somebody in the parking lot. So we initially, I initially went through the parking lot, no one flagged me down no one answered the*

phone that I was calling back you know no one answered the phone when I tried to. Saw no black truck no one flagging me down couldn't find any evidence of it so we left".

Officer Wagner responded a second time to the apartment complex about a battery complaint. Officer Wagner recalled, *"I arrived on-scene the defendant was no longer there. I contacted the victim at her residence. She [REDACTED] had stated that they had been together for approximately; I want to say it was, five years. Both prior law enforcement in another state. Information she gave to us, she said that there was a verbal argument, just verbal argument inside the truck outside of their apartment. During that verbal argument, the defendant had thrown a cup at her striking her, and then the verbal argument continued a little bit. As she was getting out of the vehicle, he sped off, and when he sped off, causing her to fall backwards, smacking her head on the ground."*

Officer Wagner contacted [REDACTED] inside the apartment, which was well lit. Officer Wagner did not observe any injury to her person nor any signs of liquid on her clothing. Additionally, Officer Wagner noticed [REDACTED] was intoxicated while collecting a statement from her.

According to Officer Wagner, Sergeant Booth and Lieutenant Conde contacted Deputy McClafferty. While Officer Wagner spoke with [REDACTED] Deputy McClafferty returned to the scene. Deputy McClafferty was subsequently taken into custody and placed in a nearby patrol vehicle.

Detectives asked Officer Wagner about Deputy McClafferty's demeanor, and any statements made that might be relevant. Officer Wagner stated, *"You know he was upset that he was gonna lose his job, things like that. I didn't deal with him down at the car. I was told that he had said some things that he was just not very cooperative at the beginning."* Officer Wagner also added that he believed Deputy McClafferty was intoxicated when they contacted him during the investigation.

When asked who determined to arrest Deputy McClafferty, Officer Wagner advised either Sergeant Booth or Lieutenant Conde decided to arrest Deputy McClafferty based on the totality of the situation.

Interview with Sergeant Marcus Booth

On March 30, 2022, at approximately 2115 hours, Sergeant Gordon conducted a sworn recorded interview with Sergeant Booth. Sergeant Gordon interviewed Sergeant Booth at 129 Valor Boulevard, Daytona Beach, at the Daytona Beach Police Department. Present for the interview was Sergeant Booth, Sergeant Gordon, and Sergeant Calkins. Below is a synopsis of the audio-recorded interview:

According to Sergeant Booth, he was working as a shift sergeant on the night of February 23, 2022. Sergeant Booth responded to 1851 LPGA, Daytona Beach, about a domestic disturbance. Sergeant Booth made contact with [REDACTED] and recalled, *"She just explained that her and I guess her boyfriend at the time were in some type of disturbance and he [Deputy McClafferty] threw water or ice or something at her, hit her with the water and ice and that he left. At that time, some of my dep, or I was gonna say deputies, some of my officers arrived on-scene. They took over the investigation portion. Myself and my shift lieutenant at the time we were down in the parking lot. And prior to going out to the parking lot, she told us what he drove. We seen a, she told us it was a black Titan. A older black Titan pulled into the parking lot, at which time he just kind of looked at us. He came over to where we were in his truck like he was gonna park. At that time, we had him park his truck. The Lieutenant made contact with him. We detained him at that time."*

Detectives asked Sergeant Booth about Deputy McClafferty's demeanor. Sergeant Booth said, *"He appeared a little bit angry, or he was telling us that he knew what a domestic battery was and trying to explain it to us all. Long story short, we ended up walking him over to the car to put him in the car. He, you know, was kind of, I don't know the best way to describe it. He was uh, I don't know he just he was very unpleasant to deal with. We were walking him to the car, he told us you guys need to check me. I guess he was indicating we needed to check him for whatever I don't know. You know just check his person before we put him in the car. Then I just kind of told him you know hey man listen you've gotta tighten up you know, command staff's on-scene your command staff just trying to help the guy out a little bit. He continued to tell me like you know he knows what we're doing, and he's not, he's not playing this game. So and that was the end of my involvement with him, really."*

Sergeant Booth commented by saying both Deputy McClafferty and [REDACTED] were both intoxicated. According to Sergeant Booth, [REDACTED] told him both she and Deputy McClafferty had been drinking that night. While speaking about the level of intoxication of Deputy McClafferty, Sergeant Booth advised, *"I didn't smell any alcohol coming off him at the time. Maybe I just wasn't close enough to him. I mean I was pretty close but I didn't smell any alcohol coming off of him."*

After placing Deputy McClafferty in a patrol vehicle, Sergeant Booth turned his attention to Deputy McClafferty's truck. Deputy McClafferty requested they return the firearms in his vehicle to his apartment. Sergeant Booth then collected the firearms from the vehicle. Sergeant Detectives asked Booth if he observed any physical evidence inside the vehicle that would corroborate [REDACTED] allegation. Sergeant Booth replied, *"Honestly I didn't even, I wasn't even looking for evidence I was just looking for anything of value."*

Detectives asked Sergeant Booth about the determining factors which led to the arrest of Deputy McClafferty. Sergeant Booth said, *"I think just the totality of the circumstances you know with her claiming a battery...I believe it was between the Lieutenant and I, you know and off her"*

statement you know and going off our directive once again it was, it was the Lieutenant and I who made the determination."

Interview with Lieutenant Leonardo Conde

On March 30, 2022, at approximately 2137 hours, Sergeant Gordon conducted a sworn recorded interview with Lieutenant Conde. Sergeant Gordon interviewed Lieutenant Conde at 129 Valor Boulevard, Daytona Beach, at the Daytona Beach Police Department. Present for the interview was Lieutenant Conde, Sergeant Gordon, and Sergeant Calkins. Below is a synopsis of the audio-recorded interview:

On February 23, 2022, Lieutenant Conde worked as the Patrol Lieutenant for District 1 in Daytona Beach. While working, he was notified of a battery complaint at 1851 LPGA Boulevard in Daytona Beach. Before responding, he received a message through his computer-assisted dispatch system, making him aware a deputy was the suspect in the battery complaint.

Upon arrival, Lieutenant Conde said, *"I was one of the first officers to arrive on-scene with Sgt. Booth and we made contact with the female [REDACTED] and you know she advised what happened. She said she was out with her live in boyfriend Jeff and they were out on Main Street. They were drinking hanging out they kind of got into an argument. When they got back home the one point I do remember specifically is when she got back home she said that she was getting out of the car and as she was exiting the passenger side there was an altercation and they were yelling at each other back and forth and at one point he slammed on the gas and peeled away from her and she fell and like rolled off to the side. She said there was a neighbor who saw what happened and she came down to check on her. I actually did make contact with that neighbor, the neighbor said she did not see what happened she only heard the sounds."*

About [REDACTED] demeanor, Lieutenant Conde stated, *"she appeared to be intoxicated" and "she made it a point to you know check to see what our year of hire was, you know, and she was just a little bit off."*

While speaking to [REDACTED] in her apartment, Lieutenant Conde did not observe any injuries or damp clothing on her person. Additional officers arrived on the scene, at which point they conducted the investigation.

Lieutenant Conde went to the parking lot and contacted Lieutenant Tatum about what occurred. While speaking to Lieutenant Tatum, Deputy McClafferty pulled into the parking lot in his pick-up truck. Lieutenant Conde contacted Deputy McClafferty and said, *"He pulled in, parked the car, closed the window, stepped out. I contacted him. Not exactly the most amicable, you know, conversation with him. I asked him who he was he was asking me why am I asking, I said you know*

we're investigating a domestic battery what's your name? Well why do I have to tell you that? Like I told you we're investigating a domestic battery are you, I don't know if I asked him specifically what his last name was or what his first name was. I think he did provide me the first name. And then in my contact with him I asked him if he was armed. He said he was not. Sgt. Booth then approached as I was making contact with him. It became apparent that he was not gonna be necessarily 100% cooperative with us so you know at that point we had enough you know we detained him at that point."

Detectives asked Lieutenant Conde if they believed Deputy McClafferty appeared intoxicated during the investigation. Lieutenant Conde explained, *"I didn't get close enough to smell anything. I didn't smell any alcohol on him, and when I was reviewing my body camera footage, I didn't see any like orbital swaying or anything like that that would be outright."*

While conducting the investigation, Lieutenant Conde later contacted the witness, who they later determined to be Kelly Beveridge. Beveridge provided a statement to Lieutenant Conde; however, she explained she did not witness the actual incident. He said she told him that she only saw what occurred after the alleged battery. According to Lieutenant Conde, his officers attempted to contact the reporting party for the first call (the motor vehicle accident); however, they were unsuccessful.

Detectives asked about the determining factors that led to Deputy McClafferty's arrest. Lieutenant Conde said, *"The allegations made by the female and his lack of cooperation once we read him, Miranda, you know he continued to say that he had nothing further to say."*

Interview with Deputy McClafferty

On April 8, 2022, at approximately 0938 hours, Sergeant Gordon conducted a sworn recorded interview with Deputy Jeffrey McClafferty. Sergeant Gordon interviewed Deputy McClafferty at 123 West Indiana Avenue, DeLand, at the Sheriff's Office Administration Building. Present for the interview was Deputy McClafferty, IUPA representative Sean Gowan, Sergeant Gordon, and Sergeant Calkins. Below is a synopsis of the audio-recorded interview:

Deputy McClafferty began the interview by saying there had been a history of issues between him and his longtime girlfriend, [REDACTED]. During an incident in Tennessee, Deputy McClafferty said, *"Yeah she was drinking she was at her friend's house all day drinking, and I had to leave and pick her up because I worked as a bouncer at a bar. Went and picked her up and on the way home she was arguing about my family which is I think the same argument we had this time. And then it turned into a slap in the face and then I was driving and then I hit the brakes coz she slapped me in the face, and then that was the allegation from as far as I know, as far as I can remember anyways."*

According to Deputy McClafferty, [REDACTED] father contacted the police in Chattanooga to report the incident after the incident took place. Due to the circumstances present at that time, both Deputy McClafferty and [REDACTED] had assault warrants issued. The incident was dropped and expunged from both of their records.

Deputy McClafferty stated on February 22, 2022, *"I was on my last day before I had to go to, it happened on a Tuesday, I had to work in Deltona District 4 on Wednesday, Thursday night that week. So I was trying to sleep all day and then stay up late in the night so I can get back in that pattern. She was at work all day I think she got off work about 6:00. We went to dinner at Outback Steakhouse then we went out. I went to Froggy's Saloon because she's trespassed from there and she, I don't, we're in the process of breaking up at the time anyways and that's really bothered her. And she went to Danny's bar I think it was for a little while then I picked her up and we went home and that's when we got in an argument in my car on the way home."*

Deputy McClafferty explained the argument began because [REDACTED] complaining about the lack of time he spent with her. Deputy McClafferty also clarified that both of them had been drinking the night of the incident. Deputy McClafferty recalled [REDACTED] had a few shots of liquor while he had a few drinks of "White Claw."

Deputy McClafferty said the incident escalated when they arrived at their apartment. Deputy McClafferty said, *"We were in a argument as we were pulling in and then we pull up in front of the staircase to my apartment, or to where I live on that side of the building. And I don't exactly remember what we were arguing about, but she got out of the car and she threw the leftover Outback at me. I read that she claimed that I threw a drink. I don't even think there was a drink to throw at her. I don't remember having any beverages or any cups or anything in my truck. She was standing up and she threw the food at me and like my reaction was to like I was, wasn't in park so I was going forward and then I went forward and she fell down. I don't know if the door hit her I don't know how that happened or whatever. [Deputy McClafferty then referred to the video uploaded to Instagram previously mentioned] I saw it, you saw the video. I turned around and I parked and I helped her pick her stuff up like and then that's what it was."*

Detectives asked Deputy McClafferty what occurred after the video stopped. Deputy McClafferty said, *"Yeah so there was a, some neighbors that were there came down. The guy came over and talked to me and then she [REDACTED] went over to the other staircase and talked to the female neighbor. I've never met them I don't know who they are. He just kept saying you know you're a deputy sheriff, you're a deputy I was like yeah I know that's why I'm not here right now I get what I am. And then she disappeared I don't know what happened, Hailey went with or [REDACTED] she goes by Hailey. She went with the other neighbor and then I just decided to leave at that point because I didn't wanna be around."* Deputy McClafferty believed by leaving the scene, he would defuse the situation and prevent it from escalating further.

When Deputy McClafferty returned to the apartment complex, he recalled, *"I pulled up I saw the cars there and I'm like you know, shit this is not good I don't know what's going on. So I eventually got defensive like because I had an idea that they're there for [REDACTED] and I based off the fact that the neighbors came down and whatever. So I got out I talked to the officers. I didn't give them any, I wasn't gonna say anything that's gonna, I don't know what they heard or what happened so I just didn't say much. I was nervous, scared, upset I don't, I've never been arrested before so I don't know. And then I talked to them and then they put me in the back of a car and then I talked to like three or four people while I was sitting in the back of the car. They asked where my guns were. I told them where all my stuff was and I just didn't give out a whole bunch of information."*

Detectives asked Deputy McClafferty about his current relationship with [REDACTED]. Deputy McClafferty said, *"Currently, since this incident, I stayed there one night, like right after the no-contact order was done, I stayed in the guest room just to see how this was gonna go and I it wasn't right, so I haven't stayed there since. I've been staying at a guest at my friend's guest room so. We text over financial stuff, bills that have to get paid. Our relationship's over with."*

Deputy McClafferty explained he currently is on a lease agreement with [REDACTED] which ends on May 27, 2022. Deputy McClafferty has severed all other financial and otherwise ties with [REDACTED].

During the interview, Deputy McClafferty was asked if there were anything he would have done differently. Deputy McClafferty said, *"I probably would have made a call when I first so I didn't get in trouble or anything. I probably would have made the call first to say look, she just threw some food at me, like this is an argument that's happening. I don't. I can't risk my job for this I don't want this to happen. Wouldn't have, I probably would have just made her get an Uber home instead of take her home because I knew, I always know when an argument's gonna happen and I just wouldn't have fed into the argument either."*

Deputy McClafferty provided several examples of steps to prevent an incident of this nature from re-occurring. Deputy McClafferty mentioned, *"Separating myself with her, putting my job number one realizing that the magnitude of my career. This I mean not that I didn't take it serious then but this just even more puts it in perspective coz this is, I'm a brand new officer it's just not a good way to start a career."*

Deputy McClafferty was asked if he violated the following General Orders, and his responses are detailed below:

GO-026-02.IV.B.3 – Any other conduct or action, on-duty or off-duty, of such seriousness that disciplinary action is considered warranted.

On April 13, 2022, the Internal Affairs investigation was presented to Chief Deputy Brian Henderson and the executive command staff. Upon completion of the presentation, Chief Deputy Henderson sustained the aforementioned General Order violations against Deputy McClafferty:

1. List Violations of the Volusia Sheriff's Office General Orders-

GO-026-02.IV.B.3 – Any other conduct or action, on-duty or off-duty, of such seriousness that disciplinary action is considered warranted.

2. Documented behavior and dates of the incident(s) supporting the violations-

On February 22, 2022, you were involved in an altercation while off-duty, later reported to Daytona Beach Police Department. It was alleged you battered your girlfriend with a drink while she was exiting your personal vehicle. The incident occurred at your apartment complex, and several public members witnessed the incident. An unknown person additionally broadcasted the events of the incident on a social media platform. After the on-scene investigation, you were arrested and charged with simple battery.

Although the charges were eventually "no filed" by the State Attorney's Office, General Order GO-026-02.IV.B.3 states that any other conduct or action on-duty or off-duty of such seriousness that disciplinary action is considered warranted.

While the evidence was insufficient in your arrest, an unfortunate incident occurred between you and another person. When speaking to Internal Affairs detectives about the incident, you noted several things you should have done differently to prevent an incident of that nature from occurring. You understood how your conduct created an unfavorable perception of the Volusia Sheriff's Office, and you referenced the need to put your career at the forefront of your priorities.

Deputy McClafferty, as a deputy with the Volusia Sheriff's Office, you are held to the highest of standards. You are expected to uphold those standards on and off-duty. Your decision-making and conduct created an unfavorable perception of the Volusia Sheriff's Office, which is unacceptable and will not be tolerated. Deputy McClafferty any subsequent discipline can result in more severe administrative action, up to and including dismissal. Take due care and govern yourself accordingly. Be especially aware of Progressive Discipline GO 26-01.
