BASIS FOR INVESTIGATION:

On August 25, 2023, Detective William Leven, of the Volusia Sheriff's Office assisted with a traffic stop conducted by Deland Police Department officers at the intersection of South Adelle Avenue and West Euclid Avenue in Deland. The vehicle being stopped was a white Dodge Charger bearing Florida license plate DZFL32 and was suspected of being involved in an attempted homicide within DeLand.

As the traffic stop was being initiated, Detective Leven was in front of the Dodge Charger in his agency issued unmarked Toyota Rav4. Sergeants Justin Allen and Jason Floryance of the Deland Police Department then conducted the traffic stop. To prevent the Dodge Charger from fleeing, Detective Leven reversed his vehicle closer to the Charger's front bumper. Detective Leven then exited his vehicle and began approaching the Dodge Charger.

As Detective Leven continued approaching the vehicle from the front, Jayvion Barthel, who was seated in the rear seat on the passenger side of the vehicle, armed himself with a firearm. Barthel removed the firearm from his waist band and began raising it when Sergeant Allen saw it and yelled, "Gun" before discharging his firearm. Detective Leven, also discharged his agency issued firearm, a 9mm Glock 43X bearing serial number BRSL630.

Barthel was struck several times and life-saving measures were attempted; however, he was pronounced deceased at the scene.

Due to the nature of the incident, Chief Deputy Brian Henderson initiated an internal affair investigation.

OFFENSES: NONE

INVESTIGATION:

On August 25, 2023, Detective Leven was involved in an officer-involved shooting. On the same date, Chief Deputy Brian Henderson assigned the above-described incident to the Internal Affairs Unit for investigation. Detective Leven submitted to a drug urinalysis screening immediately after the incident. The result of the drug screening was negative, and Detective Leven was placed on administrative leave with pay. Sergeant Hachenberger also notified Detective Leven, through official correspondence, regarding the tolling of the internal investigation until the completion of FDLE's criminal investigation.

On September 15, 2023, Detective Leven completed his fitness for duty examination. He was evaluated by Dr. Gregory Landrum, Psy. D., DABPS., and cleared to return to work.

Sergeant Hachenberger obtained the firearms qualification records for Detective Leven through the Volusia Sheriff's Office Training Section. Sergeant Hachenberger observed the following -

Detective Leven successfully requalified in the use of his agency issued Glock 43X bearing BRSL630 as per the Volusia Sheriff's Office General Orders on January 23, 2023.

At the completion of his investigation, Special Agent Chris Shephard delivered his completed FDLE Investigative Summary, along with a complete copy of the related police use of force case file, to the Volusia Sheriff's Office Internal Affairs Unit. This comprehensive case file (OR-27-0439) concluded, stating the following –

"This comprehensive investigation into the use of force incident includes a crime scene examination, a review of statements provided by witness officers, a review of physical evidence, and FDLE's analysis of that evidence. FDLE submits this investigative summary to the office of the State Attorney for their review and disposition."

On January 4, 2024, Sheriff Chitwood received a letter from State Attorney R.J. Larizza regarding the Office of the State Attorney's review of the use of force on August 25, 2023. State Attorney Larizza wrote:

"Dear Special Agent Shephard;

This letter is to advise that this office has reviewed all of the investigative reports, officer statements and witness statements provided by your office regarding the "police use of force" involving Sgt. Justin Allen of the DeLand Police Department and Detective William Leven of the Volusia Sheriff's Office that occurred on August 25, 2023.

Based on a review of the investigation and the information provided, no further action is warranted by this office."

CONCLUSION:

On January 5, 2024, this investigation was presented to the Sheriff and his administrative staff. After review, the Sheriff determined the deputy's use of deadly force was **Justified** to defend themselves from serious bodily harm and to prevent imminent death or great bodily harm to the public. In addition, no violations of General Orders were observed.
