We have two (2) arraignments per month, one (1) pre-trial per month, one (1) Violation of Probation hearing per month, and one (1) day a week conducting First Appearance hearings. In addition, I am scheduled for trial weeks. I also appear for First Appearances on weekends and holidays. Due to the pandemic, court appearances are hybrid on Zoom and in person.

- (1) State v. Daniel Chance: 2008-270CFFA, Lewd Battery, Honorable Richard O. Watson (deceased), Lead Counsel, Kelly Wark (Assistant State Attorney), 09/17/2009.

Reason: Defendant was institutionalized due to serious mental health issues since he was a child. He aged out of the facility, left Texas and moved to Florida to meet his biological father. Shortly after arriving in Florida, Defendant was charged with a sex crime against his step-sister, went to trial, was found guilty and was sentenced to 15 years prison. The Court was despondent about the case because the client had been institutionalized for most of his life and there was no alternative for a person who suffered from major mental health

issues since childhood. I learned that there is frustration in the Court system striking a balance between protecting society and finding alternative means to treat the mentally ill.

(2) State v. Joseph Milano: 2010-136CFFA, Aggravated Assault, Honorable Kim C. Hammond (deceased), Lead Counsel, Scott Westbrook (Assistant State Attorney), 06/17/2010.

Reason: Client was in a federal witness protection program, he got into a fight with a customer over pizza, and his true identity was then discovered. This case followed and involved his wife accusing him of aggravated assault with a firearm. The wife testified favorably for the defense. I chose not to cross examine the witness because I did not want to invite error. After the State rested its case, I successfully argued and the judge granted my JOA (judgment of acquittal). Even though the testimony was favorable, to successfully argue a JOA requires knowledge and understanding of the applicable case law. You must connect the law to the facts, distinguish cases that seem unfavorable and present your position clearly to the Court.

(3) State v. Giovanny Concepcion: 2005-575CFFA, Attempted Murder, Honorable Robert K. Rouse, (retired) Lead Counsel, Steve Nelson (Assistant State Attorney) (retired), 05/16/2005.

Reason: My first jury trial. I learned about the purpose and significance of proper interpretation because client was not an English speaker.

(4) State v. Sean Todd Monti: 2016-986CFFA, Aggravated Battery, Burglary of an Occupied Structure, Criminal Mischief and Resisting Officer Without Violence, Honorable Dennis Craig, Lead Counsel, Joseph Ledonne (Assistant State Attorney).

Reason: The client was a prison release reoffender, the aggravated battery charge and burglary charges required the maximum sentence which was 15 years. He was also a habitual felon which would require the 15 to be 30 years. So he was facing a total of 60 prison due to enhancements. I severed the aggravated battery charge from the rest and tried two jury cases based on one case. He was found guilty of a misdemeanor battery in the first severance. The second severance was more difficult because academically the State could prove a burglary. However, the jury found him guilty of trespass because we conceded he trespassed onto the property. Plus, they found him not guilty of criminal mischief which was a third degree felony. So, overall he was found guilty of misdemeanors only and sentenced to county jail.

(5) State v. George Wood: 2008-787CFFA, Trafficking Hydrocodone, Honorable Raul A. Zambrano, Lead Counsel, Edward Haenftling (Assistant State Attorney), 02/23/2011.

Reason: This case was considered a bad case for the defense because it involved a video transaction. However, during the trial and after viewing the video, the detective continued to testify differently from the video. I argued to the jury that the video is the best evidence of what happened and that they should rely on that. After two hours of deliberation, the jury found him not guilty. He was facing a mandatory minumum prison sentence if found

guilty. Although the evidence and testimony may vary in a trial, you must pay close attention to these details that develop in your case and be flexible to change your approach if these details are favorable.

Due to this and many other novel experiences, I must overcome their distrust of the legal system by assuring them I can and will fight for them. At times, some of my clients are bitter because they do not have the money to retain their own lawyer. So, I have learned to manage emotions, ideals, and misunderstandings. I must think on my feet, turn on a dime and adjust my strategy at the last minute.

I have over 18 years of court and trial experience. I started in private practice handling dependency cases. Then I was hired by the Public Defender's office and started in juvenile court. Afterwards, I transferred to Bunnell, Florida to handle felony cases full time. My court maturation was due to hundreds of first appearances, bond hearings, motions to suppress, motions in limine, child hearsay, William's rule, violation of probation and the occasional contempt hearings. Also, due to numerous trial appearances, I have honed my research skills, trial strategies, conflict resolution, understanding the rules of Evidence, and procedure. Furthermore, I am a good listener, a good communicator with my clients, their families, court

staff and judge/jury. Likewise, as a judge, I cannot pick and choose my litigants. Due to my diverse clientele, every case is unique. Therefore, I will exhibit the same type of assurance to the litigants of neutrality, dependability, and fairness. I will judge based on the facts of the case and not based on opinion. Therefore, I am accustomed to the demands of the courtroom and can efficiently administer justice and fairness equally.

Real world experience

Calm seas never made skilled sailors. My book, "Boundless Success with Regina Nunnally", details one of the most important lessons my father, Willie James Nunnally taught me which was to "Finish What You Start." I had him in my life for only sixteen years. Both he and my mother, Shirley Ann Pierce-Nunnally moved from Statesboro, Georgia to Daytona Beach to make a better life. They both grew up on farms picking cotton, peanuts, tobacco, and the like. They both dropped out of high school. Nevertheless, they worked their way from a boarding room behind the Krispy Kreme to a four bed, two bath home on the Westside of Daytona Beach. My father battled with diabetes, cancer, strokes, car accidents and work-related injuries. He died the day after Mother's Day in 1989. We had his funeral the same day of my junior prom. We went from a two-income home to a one income home overnight.

The courtroom is the stage of real-life experiences. As a judge, I can relate to the struggles of the everyday person. I understand the value of hard work, unexpected hardships, loss of a loved one and overcoming what can be perceived as obstacles. The youngest of five children, I am a first-generation college graduate and lawyer. Stress, anger, misunderstandings, fear, and hopelessness arise in a courtroom setting. As a judge I bring peace and assurance to the benefit of the litigants and lawyers. I will not be mentally derailed by what I see or experience but will make every effort to humanize their situation to better serve them.

Community Service

You must have an active life both on and off the bench. Building rich relationships in the community closes the gap between the judiciary and the community. Community service creates partnerships. I was raised in the church so service to the community is a moral obligation. Recently, I participated in a couple of podcasts that are on Youtube. I have been invited to speaking engagements at Mantanzas High School in Palm Coast and Bethune Cookman University about the law and justice system to provide positive youth development.

A judge must learn to give back to the community. Judges are role models in the community. A judge cannot be sincere about serving people if he or she is not willing to learn about the people in the community to which they serve. Due to my lifelong community involvement, I am already ahead of the game. There will be no need to create a connection, but I will continue to build a sincere foundation of respect and humility for litigants. People can tell if you are sincere and real. They will see that in me. My contribution to the community is to treat everyone with respect regardless of their background, race and lifestyle.

Servant Leader

My father was a Baptist preacher in Oak Hill, Florida. My mother was a school bus driver and later became a lead driver trainer. They both installed a duty to serve others in leadership. At a young age I was secretary of Sunday school and president of the youth usher board. In high school, I was president of the Beta Club and achieved Black Belt status Tae Kwon Do. My Tae Kwon Do instructor entrusted me with teaching his class for a month. I was 16 years old at the time.

In college, I was President Thomas Hall dormitory. In law school, president of Moot Court Board, Student Bar Senator and Community Service coordinator for Black Law School Association. I was the first black woman to be president of the Moot Court. During my leadership term, my school received terrible news about provisional accreditation being denied by the ABA. So, I encouraged my moot court classmates to finish the year strong.

As youth pastor at Macedonia Missionary Baptist Church, we visited the juvenile detention center, door-to-door prayer requests activity during Halloween and coordinated two mock trials to teach youth about the law and the court system. I am associate pastor at Restoration Church in Daytona Beach. I assist the head pastor with ministry to the members. I lead the praise and worship team. I preside and carry-on services when the head pastor is away. I pray, encourage, and solve disputes.

A leader must lead during the good and bad times. A judge must make the hard decisions that the law allows during the good and bad times. As a neutral arbiter, I will not allow the court of public opinion to guide my judicial actions.

Business Experience

Since 2017, network marketing has taught me business skills that are applicable to the practice of law. For example, overcoming objections or reasons for not accepting an offer by asking detailed, fact specific questions to ascertain the need of the prospect and not taking rejection personally. This skill is necessary when negotiating cases, oral argument, and voir dire. Business skills teaches you to listen attentively to what is or not being said. I have managed over 100 people on my team. I have achieved residual income status in my company. The pandemic has hit my business hard, but I am rebuilding. Due to these accomplishments and challenges, my ability to find ways to resolve cases are sharpened. As a judge, I know how to ask the right questions to determine the issues to resolve cases.

Our court system has changed due to the pandemic and technology has made it possible for us have a semblance of order. I am accustomed to Zoom due to my business activities and court appearances. Therefore, as a judge I will be flexible and can adjust with technological advances that will affect the court system.

Leadership Development

As a public defender, we undergo in house training. As a business owner, personal development by reading books, watching videos, going to trainings, and mentoring is a must. To prepare for the bench, I am mentored by sitting judges and retired judges. I am a perpetual student, and humility requires one to push you will to the side to learn. Therefore, I am open to being coachable and teachable to maintain excellence in the courtroom.
