I have practiced criminal appellate law in Volusia County for over ten years. During this time, I have developed a broad knowledge of the workings of the criminal justice system, particularly the appellate process and criminal law. I have argued over sixty cases in the appellate courts, including the Fifth District Court of Appeal and Florida Supreme Court. During my 5 of 6

practice, I have worked with numerous public defenders, assistant state attorneys, and private defense attorneys in the entire district.

In 2001, I was narred Employee of the Year for Criminal Appeals, Attorney General's Office, and the following year, I achieved Board Certification in Criminal Appellate Law. During my tenure with the Attorney General's Office, I have been exposed to the vast away of legal issues that arise in a criminal case and have been called upon to handle high profile cases. Prior to my service with the Attorney General, I served as an appellate law clerk on the Indiana Court of Appeals.

In addition, my husband and I are raising three children in Volusia County who are ages 9, 7, and 14 months. I am actively involved as a volunteer in my sons' school and in their year-round participation in our city's recreational sports. For the past three years, I have chaired the School Visits program for Law Week for the Volusia County Bar Association, and have arranged for judges and attorneys to speak to thousands of local students. Each year I speak at numerous schools during Law Week. Also, as a member of the Parish Finance Committee for my church, Our Lady Star of the Sea, I have helped our church in financial choices for its present and future needs.

The decision to choose an attorney for the appellate court should include a person (or persons) who routinely practice before that court as those practioners are keenly aware of the practices, procedures, and tenor of the court. The bulk of my practice is before the Fifth District Court of Appeal. My vast experience in appellate law, my years of government service, and my involvement in this community give me a well-rounded background to serve on the Judicial Nominating Commission for the Fifth District Court of Appeal.
