

I then made contact with Mrs. Cindy Flachmeier, who is the Director at the Community Service Council, which is the business that the defendant parked his vehicle in and was standing in. Mrs. Flacmeier stated that she wanted the defendant removed from the property and that he, his wife, and their vehicle were not welcome on the property. I then advised the defendant that he had to leave the property and he had to remove his vehicle. The defendant had to be told twice to leave the property and that he was trespassing. The defendant then walked away from me and toward the street in front of the vehicle Deputy Cook had stopped. I advised the defendant that he had to remove his vehicle and he stated that his wife would move the vehicle. I observed that the driver of Deputy Cook's traffic stop was crying and her child in the rear seat of the vehicle was also crying. Deputy Cook advised me that the people inside the vehicle were crying because they believed the defendant was a threat to Deputy Cook and they believed that he was going to harm Deputy Cook and then them. The defendant then stood on the county right of way in front of the traffic stop and in front of the business. I then advised the defendant that he was under arrest and placed him in handcuffs. The defendant was arrested without incident. The defendant had a cellular telephone attached to his shirt, which was videotaping the incident and I retrieved the yellow cellular telephone the defendant was holding which had recorded the entire incident. The defendant was transported to the Brevard County Detention Center.
