The undersigned certifies and swears that there is probable cause to believe the above-named defendant,			
on the <u>22</u> day of <u>January</u> , <u>2013</u> , at approximately <u>0228</u> <input type="checkbox"/> a.m. <input checked="" type="checkbox"/> p.m.			
at <u>997 Whiporwill Dr PORT ORANGE</u> within <u>Volusia</u> County, violated the law and did then and there:			
1 On January 22, 2013 around 1449 hours, I responded to 997 Whiporwill Drive in reference to a civil complaint. Dispatch advised the reporting party,			
2 Joseph Nolin, was having trouble with his adult son, Joseph Cameron Nolin. Dispatch advised Joseph Cameron Nolin was misbehaving, had narcotic			
3 paraphernalia in his bedroom and was refusing to leave.			
4			
5 Upon arrival I made contact with Joseph Nolin and Joseph Cameron Nolin, who were near the front driveway of the residence. Joseph Nolin advised			
6 his son, Joseph Cameron Nolin, was not respecting him or the rules of his residence. Joseph Nolin advised Joseph Cameron Nolin would not get a			
7 job and smoked cannabis inside the residence. After talking with Joseph Nolin, I asked him to go inside his residence so I could speak with Joseph			
8 Cameron Nolin separately. Joseph Nolin provided his Florida Driver License and agreed to go inside.

10 As Joseph Nolin proceeded inside I made contact with Joseph Cameron Nolin, who was approximately ten feet away. Upon contacting Joseph			
11 Cameron Nolin, he was reluctant to provide identification and alleged he was battered by his father, Joseph Nolin. Joseph Cameron Nolin stated			
12 Joseph Nolin kicked him, striking his right shin. While talking with Joseph Cameron Nolin, Joseph Nolin approached us and spontaneously admitted			
13 he kicked Joseph Cameron Nolin by stating, "I kicked him". Joseph Nolin said the incident occurred in the driveway approximately ten minutes prior to			
14 my arrival. Joseph Nolin said he was trying to talk with Joseph Cameron Nolin and became angry and kicked Joseph Cameron Nolin. Prior to Joseph			
15 Nolin's spontaneous statements he was not asked any questions regarding the battery.

17 Joseph Cameron Nolin had a red mark on his right shin. Joseph Cameron Nolin refused to write a statement and would not allow me to photograph
18 his red mark. Joseph Cameron Nolin did not wish to press charges. In regards to Joseph Nolin's allegations of Joseph Cameron Nolin having
19 narcotics in his bedroom, Joseph Cameron Nolin would not allow me access to his bedroom and refused to talk about any narcotics. Joseph
20 Cameron Nolin was provided a Domestic Violence Rights and Remedies pamphlet and a Victim's Rights Booklet. Joseph Cameron Nolin signed for
21 both items.

23 My investigation also revealed Joseph Cameron Nolin was residing at 997 Whipporwill Drive since April 2012, when he was allowed to move back
24 into the residence. I made contact with Joseph Nolin's wife, Nanci Nolin, who advised she was inside the residence during the altercation and did not
25 witness Joseph Nolin kick Joseph Cameron Nolin in the driveway.

27 Based on the totality of my investigation I determined this incident met the criteria for domestic violence. Due to the red mark on, Joseph Cameron
28 Nolin's right shin and Joseph Nolin's spontaneous statements it was determined a battery had occurred and Joseph Nolin was the primary aggressor.
29 Joseph Nolin was placed under arrest for domestic violence battery and transported to the Port Orange Police Department for processing and later to
30 the Volusia County Branch Jail. No bond was set.

32 All of my conversations with the involved parties were recorded. The recordings were placed into evidence. A Victim Notification Card was completed
33 a forwarded to the Volusia County Branch Jail.
