

WHEREAS, DET. GRANT KARCHER has made oath before SGT. SCOTT GOSS, A Law Enforcement Officer, that one, LARRY LEON JONES, on or about February 11, 2015, in the County of VOLUSIA and State of Florida, while a public servant, did unlawfully, with corrupt intent to obtain a benefit for any person or to cause harm to another, falsified or caused another person to falsify any official record or official document, contrary to Florida Statute 838.022(1)(a). (3 DEG FEL)

COUNT II: LARRY LEON JONES on or about February IO, 2015, in the County of VOLUSIA and State of Florida, without lawful authority did forcibly, by threat, or secretly confine, abduct, imprison or restrain against that person's will, contrary to Florida Statute 787.02(2). (3 DEG FEL)

COUNT III: LARRY LEON JONES on or about February 10, 2015, in the County of VOLUSIA and State of Florida, did actually and intentionally touch or strike (or) did intentionally cause bodily harm to contrary to Florida Statute 784.03(1)(a). (1 DEG MISD)
