NARRATIVE: The undersigned has probable cause to believe the above-named defendant on the, 25 of February 2011 at 1:43 AM at 100 BLOCK OF E CENTRAL (Zone: D5) in Orange County did

Commit the offenses of Battery on a Law Enforcement Officer, Resisting Law Enforcement Officer with violence, and disorderly conduct.

On 2/25/2011 at approximately 0140 hours Officer Paymayesh (15173) and I, Officer L. Beccaccio (13101), were in full Orlando Police uniform in the area of E Central BV and S Magnolia AVE. I looked north and saw a large group of approximately 20 people near this intersection. This group was yelling and appeared to be at the brink of physical altercation.

Officer Paymayesh and I walked toward the group. The group began fighting and then the bulk of the crowd began moving east. Officer Paymayesh and I began pursuing the group eastbound. We began yelling "Orlando Police! Stop fighting!" The group refused our commands. As I approached, I saw both defendant Reid Robertson and defendant John Ballard actively engaged in the fight. Both Robertson and Reid were pushing and throwing punches. Officer Paymayesh and I arrived and the crowd began to separate. I yelled for defendant Robertson and defendant Ballard to sit down. Ballard complied and sat down on the curb. Robertson remained standing on the south sidewalk.

As I attempted to get information about the incident, Robertson continually yelled and then stepped toward me. I told Robertson to back up again and he still refused to comply. I stepped toward Robertson and pushed him in his chest with both of my open hands. Robertson stumbled back and bumped into defendant Lisa Wareham. I advised Robertson that he was under arrest. Wareham immediately began screaming at Robertson. She attempted to attack Robertson for bumping into her. She lunged at Robertson, screaming for him to "get the [redacted] off me!" I grabbed Wareham and pulled her away from Robertson. I told Wareham to calm down and back up. I released my hold on Wareham and attempted to redirect my attention back to Robertson.

Wareham again attempted to attack Robertson, calling him [redacted]. Wareham responded with, "[redacted]". Wareham pushed me in the chest with her open hands in an attempt to get to Robertson. I again pulled Wareham back and told her to calm down. I maintained control of Wareham's left arm and attempted to walk her away from the area. Wareham, with her right hand reached across her body and smacked me several times in my right hand and arm, while attempting to pull her left arm from my grasp. I released Wareham who again attempted to push past me. I then pushed Wareham back in an effort to both create distance from her and I, and to prevent her from attacking Robertson. Wareham stumbled forward and fell to the pavement.

My attention was then drawn to Officer Paymayesh, who was in a physical altercation with Ballard. I went to Officer Paymayesh, who now had Ballard on the ground. Officer Paymayesh was able to get Ballard's right arm behind his back but was having difficulty gaining control of Ballard's left arm. I arrived near Ballard's head and placed my left knee on the back of the defendant's right shoulder. I began giving Ballard loud verbal commands to "stop resisting" and to "put your hand behind your back". Ballard refused my commands and attempted to pull his left arm under his chest. Ballard had not been searched and I feared Ballard may be attempting to retrieve a weapon. I administered three close fist strikes to Ballard's left upper arm in an attempt to gain compliance. I was then able to place Ballard's hand behind his back so Officer Paymayesh could complete the handcuffing.

After Ballard was secure, I approached Robertson and told him to lay on his stomach and put his hands behind his back. Robertson complied, was placed in handcuffs, and charged with resisting law enforcement officer without violence and disorderly conduct. I then returned my attention to Wareham.

As I approached Wareham, who was now west of me on the sidewalk, she began to walk away. I grabbed Wareham by her left arm and told her she was under arrest. Not having any more handcuffs, I sat Wareham down on the curb until additional officers arrived. I then placed Wareham in handcuffs. It was then that I noticed Wareham had chipped her front teeth. Officer Massicotte (11766) responded for use of force paperwork. The defendant's were transported to the downtown police bike office for processing. Rural Metro ambulance #160 responded and evaluated Wareham's injury. Rural Metro determined that Wareham did not need transportation to the hospital. The defendant's were transported to BRC.
