NARRATIVE

1 On 4/2/13 at approximately 2101 hours I was dispatched to an accident with injuries at the intersection of South Atlantic Avenue and Cascade Terrace. I arrived on scene at 2103 hours and found two vehicles in the southbound lanes of South Atlantic Avenue, both with substantial damage.

2 There was a group of people standing about and I asked if there were any injuries to any of the vehicle occupants. No one reported any claims of injuries, only shaken up. I made contact with Kelley Ryder, driver of a black Mercedes with Florida tag N678YQ and she advised that she was the only occupant of her vehicle and she had no injuries other than an abrasion from the airbag deployment. I then made contact with Patricia Trembley the driver of the silver GMC with Florida tag 803HMF, she appeared dazed and confused but advised me she was not injured. When Patricia Trembley exited her vehicle, she was very unstable and had to use the side of the vehicle to walk from her driver's side door to the rear of the vehicle.

NARRATIVE / CONTINUATION

11 PSO Rademacher assisted me with the crash investigation. Kelley Ryder was able to provide me with her Florida Driver License, vehicle insurance card and registration and I gave them to PSO Rademacher for the Driver's Exchange. I then approached Patricia Trembley and requested that she provide me with her Driver License, insurance card and vehicle registration. In response Patricia Trembley began sobbing and mumbling that she was sorry. A strong odor commonly associated with the consumption of alcoholic beverages was emanating from Patricia Trembley when she spoke. I again requested the required information from her and she just looked at me with a puzzled look. I asked again and asked if they were in her purse. Patricia Trembley mumbled and motioned towards the passenger side floor board. Patricia Trembley kept trying to move the deployed side curtain airbags from the driver's side of her vehicle. I repeatedly advised her that they were airbags and that she would not be able to move them. There were fluids leaking from both vehicles involved in the accident and after watching Patricia Trembley walk down the side of her vehicle, I feared she may slip and fall in the fluids, attempting to retrieve her purse from the passenger side floor boards. I requested that she remain on the driver's side of the vehicle while I retrieved her purse for her. While I was retrieving Patricia Trembley's purse, I could see an open bottle of wine on the passenger side floor board as well as small bottles of wine located in an ABC Liquor bag. I retrieved Patricia Trembley's purse and brought it to her so that she could look for her license and insurance card. Patricia Trembley initially handed me a Bank of America Visa card with her photo on it, as her license. I advised her that it was a credit card and that I needed her license. Patricia Trembley advised me that she knew that and "that it's in here somewhere." Patricia Trembley was eventually able to locate her Florida Driver License from her wallet and handed it to me. She also was able to produce her vehicle insurance card from her purse. When I asked Patricia Trembley about her registration, she advised it was in the glove compartment of her vehicle. I checked again for the registration and advised her that I was unable to locate it.

29 When I questioned Patricia Trembley about where she was headed when the accident happened, she did not respond to me. I questioned Patricia Trembley again as to where she was driving or which lane she was travelling in and she advised that she didn't know. I asked Kelley Ryder where she was travelling when the accident happened, she advised me she was travelling south on South Atlantic Avenue in the inside lane when her vehicle was struck by Patricia Trembley's.

34 I provided PSO Rademacher with the information that I was able to obtain, so that he could complete the Driver's Exchange form for the accident. PSO Rademacher advised that there was an independent witness to the accident who had been waiting to turn from Cascade Terrace on to South Atlantic Avenue. Thomas Eddy completed and signed a sworn affidavit. Thomas Eddy stated that he witnessed Patricia Trembley's GMC SUV travelling north on South Atlantic Avenue and then turn left in front of Kelley Ryder's Mercedes as she was travelling south on South Atlantic Avenue. Thomas Eddy also advised that the vehicles nearly hit head on, as the front of Patricia Trembley's vehicle struck the left front of Kelley Ryder's vehicle. The damage to both vehicles was consistent with Thomas Eddy's account of the accident.

41 Sgt. K. Howard was taking photographs of the accident scene and the damage to the vehicles. I advised her of the alcohol I had located in the passenger side of Patricia Trembley's vehicle and requested that she photograph it. While taking photographs of the alcohol, Sgt. K. Howard also located a plastic cup in the center console of Patricia Trembley's vehicle containing ice and a liquid which smelled consistent with wine. The open bottle located on the passenger side floor board was a 750mL bottle of "Jacob's Creek Chardonnay Vintage 2012" While obtaining photographs, Sgt. K. Howard noted that the bottle was open and still partially full. That bottle, along with a four-pack of unopened 187mL bottles of "Sutter Home Chardonnay" were collected from Patricia Trembley's vehicle. The alcohol remaining in the open bottle of "Jacob's Creek Chardonnay" was disposed of on scene and the bottle collected and entered into evidence as item #002. The four-pack of "Sutter Home Chardonnay" bottles was entered into evidence as item #003. A CD containing all of the photographs from the accident scene, the vehicles and the contents of Patricia Trembley's vehicle was entered into evidence as item #001.

51 I requested that Patricia Trembley walk with me over to the sidewalk on the west side of South Atlantic Avenue, away from the vehicles. Universal Towing arrived on scene and removed both vehicles and towed them to their tow yard. While standing on the sidewalk, Patricia Trembley was swaying visibly from side to side and was sobbing and repeating that she was sorry. Patricia Trembley was confused by the tow truck and I had to explain to her multiple times that the vehicles were being towed due to the damage.

56 PSO Rademacher came over to where I was standing with Patricia Trembley and provided her with a copy of the Driver's Exchange as part of the accident investigation. PSO Rademacher explained that due to the location of the damage on vehicles and the independent witnesses to the accident that he determined Patricia Trembley to be the at fault driver. PSO Rademacher advised Patricia Trembley that she would be receiving a citation for failing to yield to oncoming traffic while making a left hand turn. PSO Rademacher returned Patricia Trembley's insurance card to her. PSO Rademacher then advised Patricia Trembley that we were complete with our accident investigation.

62 PSO Rademacher advised Patricia Trembley that we were now going to conduct an investigation for driving under the influence because we believed that she was too impaired to operate her vehicle. PSO Rademacher requested Patricia Trembley to complete a series of Field Sobriety exercises. Patricia Trembley refused to complete FSEs. PSO Rademacher explained the FSEs and asked Patricia Trembley if she understood what they were, she verbally acknowledged that she did and still refused to complete them. I advised Patricia Trembley that she was under arrest for driving under the influence. Patricia Trembley advised that she wanted an attorney, PSO Rademacher and I acknowledged that and explained that there were things we had to do first. PSO Rademacher then read Patricia Trembley her Florida Implied Consent Warning and requested that she submit to a lawful test of her breath to determine its alcohol content. Patricia Trembley refused the test of her breath. PSO Rademacher read

69 Patricia Trembley the consequences of refusing to submit at approximately 2140 hours. After she was read the refusal, Patricia Trembley still

70 refused the test of her breath. No further questions were asked of Patricia Trembley at that point.

71

72 I searched Patricia Trembley's person with negative results for any narcotics or contraband, and placed her into the rear of my patrol vehicle. I

73 transported Patricia Trembley to the Daytona Beach Shores Department of Public Safety for processing.

74

75 During an inventory of Patricia Trembley's vehicle prior to it being towed, Sgt. K. Howard located a letter in the vehicle containing statements about

76 an individual drinking or being drunk and their attempts to change. The letter also mentions that the author is experiencing difficulties in their life

77 and "wishing I were dead rather than feeling this pain." The letter was obtained from the vehicle and has been entered into evidence as item #004.

78 When Patricia Trembley was questioned about the letter, she advised that she had written it a couple of weeks ago and had kept a copy of it in her

79 vehicle. Patricia Trembley advised me that she was "okay" and is not having suicidal thoughts or trying to harm herself.

80

81 Patricia Trembley received Florida UTC 6914-GZZ for failure to yield to oncoming vehicle, and Florida UTC 6915-GZZ for possession of an open

82 container in a vehicle. Patricia Trembley received Florida DUI UTC 7932-XEI for driving under the influence and DUI UTC 7933-XEI for DUI

83 property damage. Patricia Trembley's Florida Driver License was collected and submitted with proper paperwork.

85 Patricia Trembley was transported to the Volusia County Branch Jail for booking.
