**AFFIDAVIT**

STATE OF FLORIDA  
COUNTY OF VOLUSIA

I, Jessica Fowler, in my position as Police Detective with the City of Ormond Beach Police Department, swear and affirm that the following facts are true and correct.

1. James Adam Greene (Respondent) poses a significant danger of causing personal injury to himself or others by having a firearm or any ammunition in his custody or control or by purchasing, possessing or receiving a firearm or any ammunition. The following specific statements, actions, or facts give rise to a reasonable fear of significant dangerous acts by the Respondent.

“The defendant (James Greene) did, wantonly or maliciously, shoot at, within, or into a public or private building whether occupied or unoccupied, contrary to Florida Statute 790.19. (2 DEG FEL) (LEVEL 6) . The defendant fired approximately two bullets into the ceiling of his own residence, while occupying it.

On May 8, 2025 at approximately 1426 hours I was requested to respond to 45 Wild Cat Ln in reference to a suicidal person. The caller, later identified as Pamela Brinn, advised that she was in contact with her brother who stated he was going to kill himself. According to the sister, he was upset over a “Dear John” letter and the recent passing of a family member. While enroute to the residence it was noted that the suicidal subject was

James Greene, Deputy with Volusia Sheriff's Office. Officers attempted to make contact with Greene at the residence with negative results.

Greene contacted his wife, Cheryl Greene and asked who contacted the cops. He stated "You know who I am" and threatened to harm himself. He stated "I want to kill myself."

The Crisis Negotiation Team responded to the residence and while on the phone with Greene he made several concerning statements. Greene stated that he was going to die today and that he was going to shoot anyone who walked through his door to the residence. Greene also stated that he will come out "blazing" and shoot and kill everyone outside. Greene fired approximately two shots through the ceiling of his residence. It should be noted that there were multiple officers on scene in close proximity to the residence. Officer Feeley advised that he heard a projectile hit the roof of one of the vehicles located in the driveway at the residence. It is unknown what type of firearm Greene used as he is known to have several as he is employed as a Sheriff's deputy.

It should be noted that the defendant has lowered all of the storm shutters and denied access to the residence for his wife or anyone else to provide assistance"

On today's date Det. Mele, contacted the wife of the Respondent and advised her of the Petition for Temporary Ex Parte Risk Protection order. The wife confirmed knowledge to several firearms in the residence as the Respondent is a Volusia Sheriff's Deputy.

Based on the information reported, the Petitioner believes the Respondent poses a significant danger of causing personal injury to himself or others by having a firearm or any ammunition in her custody or control or by purchasing, possessing or receiving any firearm or any ammunition.

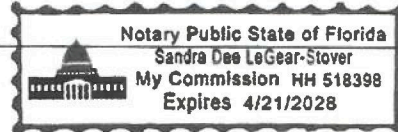
