

On 12/17/2022 at approximately 11:15pm, I was conducting enforcement on Interstate 4 traveling eastbound in the express lanes heading towards Lake Mary Boulevard. At this time, I observed a red mustang traveling in the inside lane and began to cross over splitting the inside lane and the number 3 lane. I was almost out of the express lanes to merge back onto the mainline and was able to get next to the red mustang. The mustang continued to travel eastbound and changed lanes into the number 2 lane. The mustang was increasing and decreasing speeds and began to split between the number 2 lane and number 3 lane. During this time, the mustang was in the outside lane crossing over the solid white line and splitting between the outside lane and the right shoulder. The mustang corrected its self and continued in the outside lane approaching the intersection of County Road 46a. At this time, the mustang traveled onto the right shoulder and then splitting again between the outside and shoulder on the exit ramp approaching County Road 46a. I conducted a traffic stop on the vehicle and the mustang after my emergency lights and siren came off the shoulder and back onto the outside lane. I was able to conduct the traffic stop on the right shoulder on the exit ramp to County Road 46a. I approached the vehicle and was met by a female driver and her passenger and advised the driver for the reason for the stop. I asked the driver for her driver's license and vehicle registration and insurance and the driver was able to provide them. I was able to identify the driver as a Julia Curtin (#C-635-424-99-786-0) and was showed valid insurance from the Defendant's phone. During this time, I detected the odor of a alcoholic beverage emitting from the facial area of the driver. I asked the driver where she was coming from and the driver advised "Orlando". I asked the driver if she had anything to drink and the driver advised "yes". I asked the driver what did she have to drink and she replied "vodka". The driver was displaying signs of slow movement and being larthargic. The driver's eyes were glossy and the driver's speech was slow and slurred.

I returned to my patrol vehicle and ran a search through NCIC/FCIC and advised my sgt of the traffic stop. I approached the vehicle and was met with the driver and asked the driver to step out of the vehicle. I instructed the driver to walk towards the front of my patrol vehicle. At this time, I advised the driver of her Miranda Warnings at 11:28pm and the driver wished to continue speaking with me about the events of this incident. I asked the driver if she had anything to drink for a second time and the driver advised "Vodka". I asked the driver how many drinks did she have and she answered "three vodka drinks". I asked the driver how long ago did she consume these drinks and she replied "Around 10pm". The driver advised that she had nothing else and I followed up with if she was taking any

medications. The driver advised "yes" and I asked her what she was taking. She replied with anti anxiety medications and muscle relaxers. I asked what kind of muscle relaxers she was taking and she wasn't able to respond. The driver advised that she was going home and that she could have the vehicle towed and get a lift home. I advised the driver that this isn't the way this would be going and asked her if she was willing to perform Field Sobriety Exercises. The driver asked what would happen if she refused and I advised her that I would be having to go off of my observations. The driver agreed to perform Field Sobriety Exercises and the following are the results.

HGN: I asked the defendant if she had any medical issues and the defendant advised no, but she had a stigmatism but couldn't advise in what eye. The defendant did wear glasses and was asked to remove them during the excise. I instructed the defendant to hold her head straight and follow the stimulus with her eyes and eyes only. The defendant confirmed that she understood. The defendant failed to follow the stimulus by moving her eyes off the stimulus. I instructed the defendant for second time to follow the stimulus with her eyes while keeping her head still. After the second instruction, I observed the defendant had lack of smooth pursuit in both the left and right eye. The defendant had Nystagmus began prior to 30 degrees and was present at maximum deviation in both the left and right eye. The defendant showed orbital sway while in the starting position drifting from left to right.

Walk and Turn: I asked the defendant if she had any medical problems that would keep her from performing the exercise and she advised "No". The defendant was instructed to stand with her left foot on the line with her right foot touching heel to toe with her left foot and with her arms down at her side throughout the instruction phase. The defendant was instructed to take nine heels to toe steps down the line then make a left turn by taking several small steps and return back down the line by taking nine heels to toe steps, counting each step out loud. The defendant was instructed not to stop once starting the exercise. The defendant confirmed she understood. The defendant missed heel to toe on steps 1,3 and 4. The Defendant took ten steps back down the line instead of the nine instructed steps, missing heel to toe on steps 2, 5 and 10. The defendant used her arms to stay balanced by lifting them more than six inches from her body.

One Leg Stand: The defendant was instructed to stand with her arms at her side, and her feet placed together. The defendant was instructed to raise either foot approximately six inches off the ground and foot parallel to the ground counting to 30 by thousands (1001, 1002, 1003 etc.) The defendant confirmed she understood. The defendant failed to raise her foot six inches off the ground and foot parallel to the ground. The defendant leaned to the left during the exercise.

Modified Romberg: The defendant was instructed to stand with her feet together and hands down by her side. Advised to not start the exercise until instructed to. The defendant was instructed to close both eyes and tilt her back back and keep her arms at her side. To estimate 30 seconds and when finished to bring her head down, open her eyes and say stop. The defendant advised that she understood the exercise. The defendant swayed back and forth and I observed jerking of both eyes. The defendant advised stop at 26seconds instead of the instructed 30sec.

The defendant was asked to walk to the front of my patrol vehicle and was placed under arrest at 11:55pm. The defendant was placed in hand cuffs and checked for proper fit and double locked. I returned to the vehicle and was able to retrieve the defendants cell phone. The defendant was transported to the Seminole County Jail and booked in. The defendant was read Implied consent and provided two breath samples. The first one resulting in 0.00 at 01:22am and the second resulting in 0.00 at 01:26am. At this time, I contacted Sgt Hawkins and asked her for a Evaluation as she is a Drug Recognition Expert in regards to the medications the defendant advised earlier. Sgt Hawkins was able to meet at the Seminole County Jail and perform a DRE Evaluation of the defendant. The defendant was read implied consent at 02:54am for a sample of urine and the defendant was able to provide that sample. The sample was transported to the Deland station and placed in evidence for FDLE testing. All events occurred in Seminole County Florida.

Statements made by defendant prior to, during, and after arrest as related to each charge:

defendant advised to having three vodka drinks and using medications.




