6	TT	The recorder is on. This will be a taped interview reference to Internal Affairs
7		case number 11-017. Today's date is May 1, 2012 and the time is 1410 hours.
8		The location of this interview is Sheriff's Office Administrative Offices in
9		Deland. Presently being interviewed is Dep. Taylor Sierstorpff, also present is
10		Inv. Glen Bennett with the Volusia County Sheriff's Office Internal Affairs Unit.
11		I'm Sgt Tom Tatum with the Volusia County Sheriff's Office Internal Affairs
12		unit? Dep. Sierstorpff, are you aware that this interview is being recorded?
13		
14	TS	I am aware that this interview is being recorded.
15		
16	TT	Ok, as a law enforcement officer and a Notary Public of the state of Florida I am
17		empowered to take sworn statements. At this time I would ask you to raise your
18		right hand to be sworn. Do you swear and affirm that the statement you're about
19		to give is the truth, the whole truth, and nothing but the truth so help you God?
20		
21	TS	I do swear.
22		
23	TT	Alright, Taylor we did the interview April 20th with you, the first interview that
24		we did.
25		
26	TS	Yes
27		
28	TT	And Glen and I were going over the transcripts and there's some things that we
29		need to have clarified as we were going through there.
30		
31	TS	Ok

32		
33	TT	Just some things that I don't know if they weren't answered directly or if they
34		were kind of vague in answers and we just need to narrow this down.
35		
36	TS	Ok
37		
38	TT	Ok, so go back to the night of the arrest, I think you were working overtime,
39		right? Because you were assigned to Pierson back in September of last year?
40		
41	TS	Correct
42		
43	TT	So this was in December when the arrest was made on Stephen DeHut.
44		
45	TS	I was probably working overtime because Chuck and I had swapped, he used to
46		be the Yankee unit which I am now.
47		
48	TT	Uh huh
49		
50	TS	He was working Delta 24 so I was probably working 26 zone I assume, I'm not
51		100% sure, I was working overtime.
52		
53	TT	Ok alright so when Dep. Deane called you on the phone, what exactly did he say
54		about Stephen DeHut?
55		
56	TS	Only that and again I don't want to make anything up but he had told me about
57		the battery I guess that occurred between Stephen DeHut and
58		that he wanted me to go to the house to find it. I think that was part of the
59		telephone call because we didn't know which house it was, we were looking for
60		the big truck. I only know, I didn't know Stephen that well I still don't know him
61		that well, I only know because she works at Pierson Family Restaurant. But
62		I drove by, I found the truck and that was, well sorry to continue on but to answer

63		your question I think that was to go find the truck, to find out where the incident
64		took place.

66	TT	Did Dep. Deane make any comments as what his personal opinion was on
67		Stephen DeHut?
68		
69	TS	He may have. He said something I don't want to make anything up but I know
70		that they don't
71		
72	TT	No we don't want you to make anything up Taylor but if he said something in
73		regards to what his personal opinion was you need to tell us.
74		
75	TS	I know he didn't like him but if I was to quote what he said I don't know what it
76		would be. Maybe, I don't know if he called him a piece of shit or not. I don't
77		
78	GB	That's a pretty significant statement, to call someone a piece of shit would be
79		something that would get your memory kicked in. did he call him a piece of shit?
80		
81	TS	I can't, I don't know, if I would, if I quoted myself on that I'd be lying to you I
82		know that they didn't like each other.
83		
84	GB	Did he use any derogatory terms towards Stephen DeHut while he was on the
85		phone with you?
86		
87	TS	It's possible, I'm sorry I don't remember if he did, it's quite possible, I just
88		
89	TT	He did voice his opinion on Stephen DeHut?
90		
91	TS	Well sure yeah.
92		H.
93	TT	And what he thought?

94		
95	TS	But I don't remember exactly what he said. But yeah I would assume that he did
96		yeah.
97		
98	GB	So he made, is it fair to say that he made negative comments towards Stephen
99		DeHut?
100		
101	TS	Sure
102		
103	GB	What those comments are, you don't recall?
104		
105	TS	Correct
106		
107	TT	Alright like I said you worked in Pierson since September 2011 is when you were
108		reassigned to Pierson.
109		
110	TS	Is that what it was? That sounds about right.
111		
112	TT	Yeah
113		
114	TS	Ok sounds about right.
115		
116	TT	And did you know before you started working in Pierson?
117		
118	TS	No not even remotely, never even heard of her.
119		
120	TT	Did you meet her when you were up there?
121		
122	TS	Yeah working at the restaurant.
123		
124	TT	That's where you got to know her from going in the restaurant?

125		
126	TS	Only the restaurant.
127		
128	TT	Did you ever see Stephen DeHut come in there when she was working?
129		
130	TS	Maybe once, maybe once.
131		
132	GB	But you would recognize him if he walked in?
133		
134	TS	Now I would because I've seen him maybe four five times but, I mean if I saw
135		somebody, I might have but now I'd recognize him.
136		
137	GB	Was it carnal knowledge that Stephen was dating ?
138		
139	TS	I didn't, I wasn't that close or I mean I assume yeah I, , , I was there to
140		eat really I mean I didn't say hey what are you doing later. I never really got
141		involved in her personal life that much. The only reason I knew about Stephen is
142		some of the other patrons who live their lives at Pierson Family Restaurant and
143		don't go anywhere else but there really know the two and the fact that apparently
144		he had done some bad things to her in the past, whether it's hot her or push her or
145		call her names or whatever because that's their bubble. That's their life.
146		
147	TT	All that came out after he was arrested though right? or was that before?
148		
149	TS	Um after
150		
151	TT	Are you certain or are you just throwing that out there?
152		
153	TS	No I'm not certain, I'm not certain, I'm not certain, I'm assuming after only
154		because the conversations leading up to it, they were having issues you know?
155		and apparently nobody thought that should be with this kid because of the

156		kind of kid that he was and the history that they had of this DV kind of stuff. But
157		they had lived together in the past and uh I guess nobody liked the kid. But I
158		didn't know him from Adam at the time I mean because he never came into the
159		restaurant. He did maybe once possibly twice but maybe once.

161	TT	In your first statement you said that you didn't know the defendants name when
162		we were asking you about what Dep. Dean had said on the phone when he asked
163		you to go down and check for the vehicle. Did you know his name at the time?

165	TS	If, uh, probably yeah, if I said I didn't that wasn't intentional. I mean I know
166		Stephen DeHut, I know of him.
167		
168	TT	We'll show you the transcript real quick, it should be towards the front.
169		
170	GB	Yeah, you were asked by Sgt Tatum do you remember the content of the
171		conversation or text other than you know, can you find this vehicle. You replied
172		no only to go look for the vehicle and that it was in reference to and
173		the defendant. In this particular case I don't even remember his name.
174		
175	TS	Um, I was probably just, the way I was talking I didn't remember, I don't study, I
176		probably didn't remember his name off the top of my head.
177		
178	TT	Didn't study?

180	TS	Forgive me, whenever you have a depo or something

182	TT	I mean either you

185		defendants names any witnesses or whatever and I'm coming in here with
186		nothing. And really I mean the guy doesn't mean anything to me. I'm involved

187		in this completely of somebody else's volition but I know . I didn't
188		remember Stephen's name at the time I truly didn't but I do know.

190	TT	Right I mean it was a pretty forward question. It was pretty, I mean either you
191		know or you don't. I mean he's calling you

193	TS	Yes to answer your question.

197		that way if you knew him.
