TT Ok. Alright were you working at the Pierson Restaurant at the time that you were living with him?

KC Uh huh.

TT Ok so that would be kind of a long drive.

KC Well it's like 30 minutes.

TT Yeah.

KC But I have to leave about the same time from my house because I live in the middle of nowhere so.

TT Oh ok.

KC It wouldn't probably make a difference.

TT Alright so you lived together for about two months?

KC Yes sir.

TT And that was where?

KC At his house.

TT At the Holly Blvd?

KC Yes.

TT Ok. During our first interview I think you said you took exception to some of the things that were written in the report right?

KC Uh huh.

TT Did you say you disagreed with some of the things that were...

KC Yes.

TT ...authored in the report?

KC Uh huh

TT So you had a chance to look at it?

KC Yes.

TT And you probably didn't bring a copy with you today did you?

KC Huh uh.

TT Ok I have a copy of the report.

- KC Ok.
- TT What I'd like for you to do is just kind of go thru there take a look at it and I've got a highlighter. Anything that you disagree with that you say didn't take place or you never said just highlight it and then we'll go over it ok?
- KC Ok, yeah.
- There is a copy of the incident report and this is incident report VCSO case 11-37078. And that's just the person's page on the first page there.
- KC Well like I don't, do I just highlight because like I was gonna highlight where it says that he punched holes in the wall causing me to be in fear. I didn't say so much I was in fear I just didn't want to be there anymore. Because like I told you last time I figured the argument would continue so I was like well if I go home then we'll just...
- TT Yeah just highlight anything that stands out to you and then we'll talk about it.
- KC Ok. Ok I think that's it.
- TT Got it? Ok. So lets see, going thru this you've got "causing to be in fear" highlighted. Ok so this is, in the first paragraph of this report where you made the phone call to Dep. Deane looking for a ride out of the house after the heated argument right? So at the time of your phone call to him did you tell him that you were in fear or were you looking for a way out of there? Explain that to me.
- KC Well I was, I was, I called, well no he called me or something, we I don't know.
 We got a hold of each other and I was crying so he might have thought I was scared but it was more like, like I was upset like emotional like we just got in a big argument.
- TT Uh huh.
- KC And, but I never said like I'm scared I want to leave I just said "I don't want to be here anymore" I never said I was scared.
- TT But were you a little bit afraid? I mean because you didn't want to stick around there right?
- KC Well I wasn't so much scared because like I told you there was other people there like at the house and stuff so it wasn't even like I knew he would like, I knew he wasn't going to hurt me.
- TT Uh huh.

- KC And then if say if something was to happen there was other people there so I wasn't scared.
- TT Ok but you were upset and you were crying when you made the phone call.
- KC Uh huh, so that like...
- TT So it may have led him to believe that you were in fear?
- KC Yeah but I was...
- TT Ok.
- KC ...like more emotional.
- Ok. And lets see, you also have, now you have just one part of this sentence that's highlighted right here and it's at the very end of the first paragraph where it said "included physical dispute as well" did you read the whole sentence?
- KC Well what does this word mean?
- TT Evasive?
- KC Yeah.
- It means that you weren't directly answering the questions, you weren't saying yes it was physical or no it wasn't you were just kind of dancing around.
- KC And that's on the phone with him that night?
- TT Yeah, yeah. So I don't, I mean...
- KC Honestly I don't know what I said on the phone that night. Like this was what two months ago or something now. I don't, I don't know what I said but I know I wouldn't have said he hit me. Like I know I didn't say that so that's why I highlighted the physical part.
- TT Right but it's a continuation, you've got to read the whole paragraph to...
- KC Yeah.
- TT ...you can't just single that out because what you have highlighted stands alone and says "included physical dispute as well" which is not the case or totality after the sentence.

- KC Well because what I was thinking was like, like he asked if there had been an argument and I did say there was an argument and then I, like I did the included the physical because there was an argument but there was no physical.
- TT Right.
- KC Like hitting or anything.
- TT Ok so if you read that whole sentence in totality I mean it kind of makes sense.
- KC Uh huh.
- TT Because evasive means that you weren't directly answering yes or no to the question, it was just...
- KC Ok I don't even know what that word meant so.
- TT Ok, well I mean if you don't know what something means let me know you know.
- KC Ok.
- TT Because I mean if you don't know what it is you can't really make a determination on what you're saying right?
- KC Yeah.
- Then the second paragraph down you have the words "struck on the left side of the face" highlighted which is just part of the sentence. The full sentence is "through casual conversation advised that she had been struck on the left side of the face during the altercation"
- KC Well I could have highlighted the whole sentence.
- TT So I just want to make it clear what the whole sentence is instead of taking just part of what you highlighted.
- KC Yeah,
- TT So did...
- KC I was just highlighting the part.
- During the casual conversation when you guys were just in the restaurant talking and he's like "hey what happened?" you know "by the way what happened the other night when you called me?" and so you're just having a conversation about this, do you think you mentioned to him that maybe you got struck in the face?

- KC No. I know he asked like kind of asked me if I had or something and I think I was like "no" I was like "does it look like I got struck in the face?" or I think I said something like that but I never said he hit me, punched me or nothing so that's why I highlighted the struck on the face because I never specifically said he did.
- TT But at any point like because we talked before and you said that he was keeping you from moving around because he wanted to talk to you and he had his hands on your shoulders and stuff.
- KC Uh huh.
- TT Do you think at any point where you were trying to get away maybe his hand accidentally hit you in the face and that's why you made that statement?
- KC I don't, I don't know.
- TT You don't know?
- KC I don't think. I, like I think I would have known if I would have gotten hit and I don't...
- TT Because it clearly says you know further in the report when you read it that there's no physical signs of...
- KC Yeah.
- TT ...you know bruising or anything on your face.
- KC Uh huh.
- Alright so it's your contention and your statement that during the conversation you never said you got hit in the face or do you not recall?
- KC I don't recall saying it.
- Ok. Then it goes on to say "while yelling at her and shook her" and that's part of the sentence "elaborated stating Dehut had grabbed her on the upper arms while yelling at her and shook her" is that an accurate account of what happened?
- KC He didn't, he wasn't yelling at me and shaking me. Like I told you before he had grabbed me and we were like not physically like trying to hurt me grab me but he put his arms around me and was like trying to talk to me but I never said he shook me.
- TT Now he put his arms around you or he grabbed you by the arms, how was that?

- KC Like, like on my shoulders like.
- TT Like on your shoulders?
- KC Yeah.
- TT And you were trying to get away and he was trying to keep you there to talk to you?
- KC Well like he was like we were trying to talk and that's when I was just like "I just want to leave" and then so that's when I was going to leave and then...
- TT And were you upset at that time?
- KC Uh huh.
- TT When you guys were having the conversation?
- KC Uh huh.
- TT Because it sounded like it was pretty heated.
- KC Well it was but like we started arguing so I was crying and stuff.
- Ok. Then you also have highlighted "took her phone" and that's part of the sentence "stated she attempted to call a friend for a ride at which time Dehut took her phone and threw it"
- KC He had my phone, he had my phone thru out the night in his pocket.
- TT So you didn't have it in your possession and he took it when you were trying to make a phone call?
- KC No I, I didn't have it he had it. And then I think I said like where's my phone or something and then that's when he like threw it and then I, he, he left or yeah he left and then I got my phone and then that's when I made the call.
- TT Alright so you're saying you didn't have the phone on you, he already had the phone and he threw it.
- KC Uh huh.
- TT Did you have a conversation about any of this? Did you tell her anything?
- KC I talked to her...

- TT I mean about the altercation and everything that happened out there that night?
- KC I don't think I did. Not that I can recall?
- TT Ok because we did talk to
- KC Uh huh.
- And when we were talking about you know if she was present because we didn't know who exactly was there the night that this took place. So we were asking her if she was there she said "no" and I said "did you hear anything about it?" and she said "well did tell me that he, that Stephen took the phone from her and threw it" so.
- KC I, like, well as you all know there was drinking that night and stuff but I'm pretty sure he already had my phone I didn't have it so I don't know. I didn't have it. I don't know if I told, what I told her I don't know.
- TT You just don't recall?
- KC Huh uh.
- TT Ok. And that's, so you guys had been consuming alcohol that night right?
- KC Yes sir.
- TT Alright, he's 21 you're 18?
- KC 19 now.
- TT 19 now ok, alright so were you pretty intoxicated that night?
- KC I guess you could say so.
- TT Ok. What were you drinking that night?
- KC Um...
- TT Was it beer or alcohol you know mixed drinks do you recall what it was?
- KC I think beer?
- TT You think it was beer?
- KC Uh huh.

TT But you're not sure? KC I'm pretty sure. Ok did you have any mixed drinks that night or anything? TT KC Huh uh. TT Ok. Let's see, and it says " asked Dep. Deane if a bruise could be seen on the left side of her face" No like I said a minute ago I was like "it's not" I was like "you don't see any KC marks on my face so you can tell that I didn't get hit" TT Alright so you were just saying that in clarification to him "you don't see any marks on my face right?" KC Uh huh. So you weren't asking that as a question you were just kind of saying that as a TT statement? KC Uh huh. TT Ok. Then the next thing you have highlighted is "defensive in nature consistent location with someone raising their arms to protect their face" and that's part of the full sentence of "Dep. Deane observed the bruise on rooms" forearms to appear defensive in nature consistent location with someone trying to raise their arms to protect their face" KC That's what he assumed. TT Uh huh. KC I'm guessing but I didn't...

- KC What I told him what happened.
- TT From walking into the table and hitting a pole.
- KC Uh huh.
- Alright so I think it's safe to assume thru our conversation and the things that we've gone over that at one point it was physical with you guys because he put his hands on you and there's the potential that you may have had the phone in your possession you're saying you don't recall you know.
- KC Uh huh.
- TT So you know like we talked about before domestic violence is a very serious criminal offense that we take action on because we don't want to see anything happen to anybody in the future you know. So we take these things very seriously and by your own account you guys were having a heated argument and he grabs you by the shoulders and I mean you're upset and you're crying and you know you don't dispute the fact that he punched holes in the walls over there.
- KC Huh uh.
- TT Right? So he was pretty upset.
- KC Uh huh.
- TT So we do have a physical altercation that took place this night, you could agree with that?
- KC Physical not towards me I would say because he didn't he wasn't...
- TT Well he was upset to the point where he's punching holes in walls.
- KC Yeah but he wasn't physical towards me.
- TT Other than the fact that he grabbed you by the shoulders right?
- KC Yeah but it wasn't like violently grabbing me.
- TT Ok. Alright anything else you want to add to that?
- KC I don't think so.
- GB Can you just initial next to the, each line there indicates a number to the left.

- KC Uh huh.
- GB Could you just initial next to the line where you had highlighted if you don't mind please on the incident report. Thanks, this way we know you did it not us.
- Alright and like we said this is obviously a two sided, actually there's two issues at hand that we're dealing with, the other one is the party at Travis's house. So I'm not sure if you told us last time, how were you invited to the party?
- KC Personally.
- TT Personally?
- KC And thru Facebook. He told me he asked me to come and then he...
- TT When you were in the restaurant or?
- KC Uh huh.
- TT Ok. And then also on Facebook?
- KC Uh huh.
- TT Did you reply to his request?
- KC I put yes. Because, because I remember once in the restaurant I was like, he's like "are you gonna come, are you gonna come?" and I was like "I'm gonna try I don't know if I'm gonna be able to make it" or something and he was like "well you better come" and was like egging me to come so I was like "yeah I'll come"
- TT So you guys had a conversation about it?
- KC Yeah.
- TT Alright.
- KC Oh and then I still have the thing on Facebook like the event invite.
- TT Uh huh.
- KC And I told you I couldn't remember what that stuff was called and it's Strongbow or something?
- TT Strongbow.

GB Oh so it's advertised there would be alcohol served?

KC Yeah.

GB Ok.

GB Before we're done here we'll probably have you just...

KC That's fine.

GB ...bring it up if that's ok with you.

KC Yeah.

Alright and I think we've already talked about the issue, you have consumed alcohol before even though you're underage so you know what the effects of consuming alcohol are on you right?

KC Yes sir.

- TT Alright so when you're at the party and you had the jello shots...
- KC Uh huh.
- TT ...did you taste anything in there? Did you recognize anything to be alcohol or?
- KC Well...
- TT How do you know there was alcohol in it?
- KC Well I've never had a jello shot without alcohol in it and then you could kind of taste it like it's not so strong you can't drink it but you know it's there.
- TT You've had jello shots in the past then so you recognize it from prior experience?
- KC Uh huh.
- TT Ok did you feel any of the effects of the jello shots or anything?
- KC Huh uh not really.
- TT Did you take two full jello shots I mean I know they were little cups you were saying something like that.
- KC Yeah uh, yeah I think there was two and then the one cup of whatever I had.
- TT Uh huh.
- GB You had a cup or a sip or? How much of that Strongbow?
- KC It was like a full solo cup.
- GB So you drank a full solo cup of Strongbow?
- KC Uh huh, or whatever it was yeah.
- GB Ok I assume a Strongbow is what your referring to is that combination on tap, that cider slash whatever it was?

KC Well because Wade, Wade and Stephen are friends so like once you put a picture up any one of your friends can comment on it. And that's my sister and then that's Stephen and Travis.

TT Ok.

KC Because they're all friends with Wade.

TT Ok.

GB So let me understand something. Travis received that photo of the patrol car right here...

KC Uh huh.

GB ...and the cups on it if he's friends? Is that accurate?

KC This, he saw this one because that one was on Facebook and then he commented on it so he knew that was there.

GB Ok so you're saying in this Facebook right here at the top of the Facebook page that we're looking at here it was printed out or this post was on November...

KC	Why he commented 25 days later I don't know but yes he was aware that was there.		
GB	Ok.		
TT	And that's his comment then the 5 th of November that's what he put on there?		
KC	Uh huh, uh huh.		
GB	Ok.		
KC	Because like once like I don't know if you all like you said you're not on Facebook much or something but like you upload a picture and then any of your friends can comment on it and like your Facebook page kind of like this like how she's got pictures and stuff on it.		
GB	Uh huh.		
TT	Uh huh.		
KC	Once you click it then that's what it brings is the comments of it.		
GB	Ok so he had to physically click on the picture of you and and then make the comment?		

KC Yes. GB And once again this is Wade's actual, you think this is Wade's book you think. KC Uh huh. Ok so he was on Wade's he saw the picture, clicked on it and made his comment GB on it? KC Yes. Ok. Was this photo ever on Facebook? And the photo I'm referring to is the GB photo of the patrol car with cups on top. KC I don't think so, no. GB You don't believe so ok. KC Huh uh. The only thing that had anything about the beer pong on the car was what she wrote and then like the pregnant nun and all that was, it was Halloween and all the people that were dressed up. GB Does Travis, is he friends with KC I don't know. GB Ok. I don't think so because I remember, I remember Travis making comment that KC he's not friends with anybody under 18 on Facebook and state is 17 so I don't think they were friends. GB And is that a parameter you can put up on your Facebook account? Like you can put on there nobody under 18 or is that something that you govern yourself. KC That's what like whatever you decide. GB Ok.

Because once somebody sends you like a friend request then you can decide if

you want them to be your friend or not. You can confirm or deny it.

How would you know their age?

- KC Well you, sometimes like some people can have their Facebook where it's private, nobody can see anything and other people have it where you can see like their birthdays and information like that, where they go to school and some people have where you can see all their pictures. It all depends on how like private you want it.
- GB So when you, make sure I understand this, so when you went onto, you're friends with Travis?
- KC Uh huh.
- GB Did you send him an invitation or did he send you an invitation? I know we're going back a little bit.
- KC To be friends?
- GB Yes.
- KC To be honest with you I, that was probably a long time ago.
- GB Ok but if, he would have to, he's not friends with anybody under 18 so he'd have to know your birth date I assume in order to be friends with you?
- KC Well I think he just knew that from knowing me in the restaurant.
- TT Now you said that your date of birth is posted on your...
- KC Uh huh, Facebook.
- TT Facebook. Is that your true date of birth that's on there?
- KC Yes.
- TT And do you have to click on that to get like your profile or that information or does it pop up like...
- KC Well like if he, if he's not my friend then I don't know I don't remember how I set mine up but like you can get yours completely private where nobody can see anything unless they're your friend.
- TT Uh huh.
- KC And some people can make it completely public where you don't even have to be friends with anybody and you can see everything they put.
- TT Just anybody can look at it.

- KC Uh huh. And I don't know if my birthday if it's public or not. Like I know once you're friends with the person you can see anything but I don't know.
- TT And you're friends with...
- GB But you're friends with him.
- TT ...Dep. Deane on Facebook.
- KC Yeah well not anymore but I was.
- TT No but prior to this.
- KC At the time yes.
- GB You're not anymore? Did you unfriend him on Facebook?
- KC Uh huh.
- GB Ok you did that.
- KC Uh huh.
- GB Yeah I'm just trying to get clarification because like I said he doesn't, he's not friends with anybody under 18 so there in fact...
- KC That's what he's personally told me.
- GB He's personally yeah so he'd have to know your date of birth.
- KC Yes.

- KC I'm assuming just from kind of like talking at the restaurant. Other than that unless he saw it on my Facebook I don't know.
- GB But you're friends, if we're friends and you have that on there I'd be able to see it?
- KC Yeah, yeah.

TT So once you and Wade left the party, Wade was driving, did they drive you back to your car? KC Yes. TT And that was in the parking lot of like TJ Maxx shopping complex there on the south end of Deland? KC Yep. TT And did you drive yourself home then? We all, we all like followed each other. Well we went to the fairgrounds because KC the fair had just like gotten over or something and Wade's, Wade had left his brother and one of his friends there or something so then we all followed each other to the fairgrounds and he picked them up and then we had gone to a birthday party afterwards. TT Ok so you drove your car after you were dropped off at TJ Maxx then you followed the other... KC Wade. TT Wade. KC Wade and TT And to the fairgrounds. KC And then got her car which was at the fairgrounds. TT Then you went onto another party. KC Uh huh. TT Alright where was that party? KC Deleon Springs. TTAlright. GB

And you were at Travis's house for how long?

- KC Probably like 45 or so minutes.
- GB 45 minutes which in turn you drove directly from Deane's house...

- GB I'm sorry Dep. Deane's house to get to your car which is approximately 15-20 minute drive possibly?
