So, ever since I did the review of <u>Harasty's Hard Class</u> (which I really liked) I've been looking for another to review. While researching that first review I ran into a comment on another biog that said **Strongbow** was their (avorite cider - in fact it was "head-and-shoulders" above **Hornsby's**. Not teally sure about the whole booze/shampoo comparison but I thought I should at least give Strangbow a try.

Strongbow is an imported "dry cider" from England. According to the "Since whenver" label, which we all know is pure builishik, Strongbow has been imported since 1887, the same year Clearsides: was first produced (also known as: the most boring-est year ever). This may account for the general lack of flavor.

Sorry anonymous commenters, Strongbow kinda blows: Look, I iterally blew through my 6pack of Hornsby's in about 2 days - had one with every meal. It was really good stuff that I didn't have to try to like. Strongbow? I've been trying to like it for about 2 weeks and I'm just now finishing the last bothe because I need more room in my fridge. When they say "dry cider" they aren't kidding. This shit is as dry as the Queen's ...eyes...her stolc and bearless eyes. As for a meal accompaniment? It made pretty much whatever meal I tried to drink it with worse. Actually I just tried it with a piece of dark chocolate which made it significantly less ass-tastic, but I'm not sure that makes up for the overall lack of satisfaction I've had with this cider. The worst part? Since it's imported it will set you back almost twice as much (\$10 for a 6-nack) as a domestic cider.

If your inclination is to drop the charges, you must attend the class in order for you to complete a request to dismiss the charge(s) and/or a request to modify the no contact order in your case. Please be advised, however, that filling out the request forms does not guarantee the charge(s) will be dropped or the contact order will be modified. Classes for women are held on the 1st and 3rd Wednesdays at noon in the first floor Grand Jury Room at the Volusia County Courthouse located at 101 North Alabama Avenue in Deland. Classes for men are held on Wednesdays at 1:00 p.m. in the same location. There is no charge for this service. Please see the enclosed schedule for more information.
