24 25 26	TT	Alright Sgt. Whitener. Can you tell me where you were assigned December 14, 2011?

34 35 36	TT	Ok here's a copy of the report just to refresh your memory on it. And that report number is 11-37078. So do you recognize that, do you recall that report?

109 110 111	TT	Ok. Did you have a conversation with Dep. Travis Deane about the incident? As far as I know a lot of times the guys call each other and say hey I've got charges on this guy can you go pick him up.

That the same boyfriend and girlfriend where she brought, the girlfriend brought it to his attention that the boyfriend beats her up and that she was scared of him and what he thought he should do about it being that they were friends. And I advised him that if he had probable cause to believe that a crime was occurring that he needed to act on it of course but being that he was friends with this girl he should probably get another deputy to handle it. And he said "ok" and that's the last we spoke of it.
