1 On 02-01-13 at 1927 hours, Deputy Savage was dispatched and responded to XXXXXXXXXXXXXXXXXXXXX. reference a 911 hang up.

Upon arrival Deputy Savage made contact with David Fuller(D1), who appeared to be under the influence of alcohol, and stated he had a verbal argument with his wife, identified as, Tania Fuller(V1). Fuller(D1) stated he arrived home from work, and had a verbal argument with Fuller(V1) reference Fuller(V1) not cleaning their house while he was at work all day. Fuller(D1) advised he did not make physical contact with Fuller(V1), and only yelled at her. Fuller(D1) advised after the argument was over Fuller(V1) left with his son identified as, XXXXXXXXX, to an unknown location. Fuller(D1) also advised he was not aware Fuller(V1) had called 911 because she makes threats to call 911 often. Sergeant Whitener arrived on scene see report VCSO 13-3141 for full details.

During the investigation Sergeant Whitener determined a small collapsible cart was used by Fuller(D1) to throw at Fuller(V1)'s vehicle as she left the residence. Deputy Savage searched the outside area where Fuller(V1)'s vehicle was parked and located a broken collapsible cart located on

12 a plastic chair near the front entrance of the house. Deputy Savage observed a tire track located on the collapsible cart. Deputy Savage 13 photographed the tire track on the cart and submitted the photo into the VCSO Digital Crime Scene Database. Deputy Savage took possession of
