NARRATIVE The undersigned certifies and swears that there is probable cause to believe the above-named defendant, on the 11 day of October, 2013, at approximately 0430 a.m. p.m. at [REDACTED] DAYTONA BEACH within Volusia County, violated the law and did then and there:

1 On September 29, 2013 the defendant was contacted in reference to him being accused of sexual battery of a child. The victim in this case stated
 2 that the defendant, on several occasions, would have the victim go into his office that was located inside of the defendant residence. The victim
 3 stated that the defendant would use his computer to show her sexually explicit images. The victim stated that the defendant would sometimes show
 4 her sexually explicit cartoon, and other times he would show her sexually explicit images that when described by the victim, were consistent with child
 5 pornography. The victim stated that she would view these images with him, on the computer in the office and then they would perform those actions
 6 on each other.
 7 Based on the above information, the defendant was asked for consent to seize and search the computer in question, a black and silver desktop PC,
 8 void of a name brand or a serial number. The defendant granted this consent and the computer was seized and transported to the Daytona Beach
 9 Police Department for forensic analysis.
 10 On October 04, 2013 I received the above computer and opened the case to remove the internal hard disk drive. While removing the drive, I noted
 11 that the internal HDD was a Western Digital drive and that it had the name "Ed Lueck" written on it with a permanent marker.
 12 I created a forensic image of this hard drive utilizing a [REDACTED] and [REDACTED]. Upon
 13 examining the hard drive, I noted the following facts that may be of evidentiary value.
 14 It was determined that the hard drive had a total capacity of 320 GB and one partition. This partition contained an NTFS file system with a volume
 15 serial number of "38AC-6B5D" and a computer name of

1 "ED-M8AFT3DY2Z6C" which had an installed operating system of Microsoft Windows XP Service Pack 3, listing the registered owner as "Ed Lueck".
 2 The product ID for this installation of Windows is "55277-OEM-0046972-75270". This operating system was installed on July 16, 2010 and was last
 3 shutdown on September 27, 2013.
 4 I located the SAM file (Security Accounts Manager) and discovered that there were two system generated default user profiles and two user
 5 generated profiles. System generated profile "Administrator" had a SID (Security Identifier) of 500 and had a logon count of (03), with the 1st being on
 6 December 29, 2011. System generated profile "Guest" had a SID (Security Identifier) of 501 and had a logon count of (00).
 7 User generated profile "Owner / Rusty" had a SID (Security Identifier) of 1003, with a logon count of (1070) with the last being on September 27,
 8 2013. This account indicated that a password is required to logon to this profile.
 9 User generated profile "Gwen" had a SID (Security Identified) of 1005, with a logon count of (02), with the last being on March 10, 2013. This
 10 account indicated that a password is required to loon to this profile.
 11 During a forensic examination of this drive, I located sexually explicit cartoon videos and images consistent with those described by the victim in this
 12 case. These items were recovered from a folder located under user profile "Owner/Rusty" SID 1003. Under this same profile, I recovered images of
 13 the defendant.
 14 An analysis of the unallocated space located on this HDD, revealed the following images, verified to be child pornography, these images are listed by
 15 "Count"
 16 Count 1:Image depicting two female children, nude, with one of the children placing their fingers into the other child vagina. (Seq. # 645324)
 17 Count 2:Image depicting a female child naked from the waist down, sitting on a bed with her legs spread exposing her nude vagina. (Seq. # 1125436)
 18 Count 3:Image depicting a female child, standing in an office, completely nude while looking at an adult male with his chest exposed. (Seq. #
 19 1122988)
 20 Count 4:Image depicting a female child, standing in an office, completely nude showing her exposed breasts and vagina. (Seq. # 645305)
 21 Count 5:Image depicting two female children, nude, lying on a bed on top of each other. One of the children is grasping and placing their mouth on
 22 the other child exposed nipples. (Seq. # 582574)
 23 Count 6:Image depicting a female child, nude, sitting on the lap of a nude male, with her vagina exposed and the males erect penis inserted into the
 24 child anus. (Seq. # 645511)
 25 Count 7:Image depicting a female child, nude from the waist down, kneeling on a chair with an adult male standing behind her. The adult male is
 26 nude from the waist down and has his erect penis exposed while he places his hand on her vagina. (Seq. # 1128632)
 27 Count 8:Image depicting a female child, nude, lying on her back on a bed with a nude male, using his erect, exposed penis to engage in sexual
 28 intercourse with that child. (Seq. # 566429)
 29 Count 9:Image depicting a female child, standing in front of a males erect and exposed penis, the child is grasping the exposed penis. (Seq. #
 30 937704)
 31 Count 10:Image depicting a female child, sitting on a couch, with her breasts and vagina exposed. There is a nude male with an exposed penis
 32 engaging in sexual intercourse with the child. (Seq. # 536524)
 33 Count 11:Image depicting a female child and a male child, both nude and engaging in sexual intercourse. (Seq. # 937630)
 34 Count 12:Image depicting a female child, kneeling in front of a males erect and exposed penis, the child is grasping the exposed penis. (Seq. #
 35 759845)
 36 Count 13:Image depicting a female child, completely nude while sitting on a bed with her fingers inserted into her vagina. The child is performing oral
 37 sex on an adult males erect, exposed penis. (Seq. # 1123064)
 38 Count 14:Image depicting a female child, nude, lying on her back with a nude adult male engaging in sexual intercourse with her. (Seq. # 1122991)
 39 Count 15:Image depicting a female child, nude, standing in front of a nude adult female that is kneeling in front of her. (Seq. # 645334)
 40 Count 16:Image depicting a female child, being bent over at the waist with a nude male behind her engaging in sexual intercourse. (Seq. # 937584)
 41 Count 17:Image depicting a female child, with her breasts exposed, standing next to an adult male that is touching her stomach and kissing her
 42 shoulder. (Seq. # 760599)
 43 Count 18:Image depicting a female child that is nude, exposing her vagina. (Seq. # 937700)
 44 Count 19:Image depicting a female child, sitting on the floor, completely nude exposing her breasts and vagina. (Seq. # 759979)
 45 On October 11, 2013, Detective Deschamps and I contacted the defendant at the Volusia county Branch Jail. Upon contact I told the defendant that I
 46 was not here to talk to him about his current arrest (sexual battery), and that he did not have to talk to me and that he was free to say no and leave at
 47 any time. I then asked the defendant if he would mind talking to me about his computer, and he agreed.
 48 I asked the defendant who owned the computer listed above and who used it. The defendant stated that the computer is his and he uses it, and his
 49 wife has also used it in the past. I asked the defendant if he ever looked at pornography on that computer and he stated that he did. I asked the
 50 defendant if he ever looked at child pornography and then deleted while using that computer and he indicated that he had.

1 I showed the defendant some of the child pornographic images that I had recovered from his computer and he stated that they were not his, and that
2 he never saves the porn that he looks at, and that we (police) must have planted those on his computer.
3 I asked the defendant if he installed and used Peer-2-Peer software "FrostWire" on his computer, under his profile, and he stated that he did, and that
4 he uses FrostWire to download music.
5 A forensic analysis of the defendant's profile, Owner / Rusty SID 1003, revealed that FrostWire was currently installed under that profile and that
6 several terms that are known to be associated with the sharing of child pornography were located within those FrostWire data files. These terms
7 included:
8 PTHC (pre-teen hard core), Lolita, pre-teen, young sex, and underage

10 An audio recording of the interview will be tagged into evidence at a later date.




