BASIS FOR INVESTIGATION:

On Friday, March 9, 2012, Lieutenant Erik Eagan met with Major Robert Jones in regards to an anonymous written complaint alleging Sergeant Shon McGuire was involved in an extramarital affair with Ms. Cara Gittner. Letter attached and made part of this investigation. (*See Tab - C*)

OFFENSE(S):

Volusia County Merit System Rules and Regulations 86-453 (13), Any conduct, on or off duty, that reflects unfavorably on the County as an employer. This violation may be sufficient grounds for disciplinary action ranging from oral reprimand to dismissal, depending on the seriousness of the offense and other circumstances related to the situation.

INVESTIGATIVE SUMMARY:

On Friday, March 9, 2012, Sheriff Ben Johnson assigned the above-described incident to the Internal Affairs Unit for investigation. This report details the investigation conducted by Lieutenant Erik Eagan.

On Friday, March 9, 2012, Sergeant Tom Tatum and Investigator Glen Bennett served Sergeant Shon McGuire with a Notice of Internal Investigation and provided him with a copy of the Law Enforcement Officer's Bill of Rights. (*See Tab - B*)

On Monday, March 12, 2012 Lieutenant Eagan reviewed the AVL data and conducted a search in Force Watch for possible contacts between Sergeant McGuire and Ms. Gittner's home, [REDACTED]. Lieutenant Eagan expanded the search area encompassing the entire peninsula where Ms. Gittner lives from March 12, 2011 until March 12, 2012. During this query Lieutenant Eagan noticed that on September 19, 2011 then Deputy McGuire drove

south on Atlantic Ave. [REDACTED] and west on Dunlawton Ave. to his home [REDACTED] FL.

There were also two matches in the AVL query that show Sergeant McGuire at Ms. Gittner's residence on July 22, 2011 for fourteen minutes and August 15, 2011 for an undetermined amount of time. Both incidents are when Sergeant McGuire was off-duty using his issued patrol car.

On Thursday, March 15, 2012 County Attorney Nancye Jones contacted Ms. Gittner's attorney, Melissa Murphy regarding Ms. Gittner participating in a witness interview for this investigation. On Friday, March 16, 2012 County Attorney Nancye Jones forwarded Lieutenant Eagan an email response from Ms. Murphy indicating that Ms. Gittner "...is declining to be interviewed as a witness."

Sergeant Shon McGuire

On Thursday, March 22, 2012, Lieutenant Eagan conducted a sworn recorded interview with Sergeant Shon McGuire at the Sheriff's Administrative Office in DeLand, FL. Also present at the interview was Sergeant Tom Tatum, Teamster's Representative Josh Vedder and Teamster's Business Agent Bob Walker. During the interview, Sergeant McGuire told investigators that he has not had an extramarital affair with Ms. Cara Gittner while on-duty. The two instances when Sergeant McGuire stopped by Ms. Gittner's home while in his issued patrol, he was off-duty. These instances were recorded by Sergeant McGuire's patrol car AVL (automated vehicle locator) on July 22, 2011 and August 15, 2011.

Lieutenant Eagan asked Sergeant McGuire if he has had problems with his AVL not functioning properly and he responded that he has. He said that his supervisor was aware of the AVL problems along with Information Systems. He said that his supervisor would inform him if his AVL was not updating his location and he would re-log onto his computer. Sergeant McGuire said that Information Systems had done something to his computer, AVL or both to remedy the problem. Sergeant McGuire denied disconnecting, interrupting or shutting down his computer to avoid AVL detection. Lieutenant Eagan was able to substantiate Sergeant McGuire's claim with his AVL problem and his constant re-logging onto the CAD system.

Sergeant McGuire was questioned if he felt he violated the below listed policies regarding this investigation. He denied violating any policies cited.

26.2.34 Failure to Follow Directive or Order - Employees shall adhere to all official No Directives and/or orders, and shall faithfully execute all the duties and responsibilities of their assigned position. (Violation subject up to a 5 day suspension.)

26.2.142 Use of Equipment: AVL - Employees shall ensure proper maintenance and No utilization of the Department AVL (GPS) for its intended purpose and in accordance with installation requirements.

26.2.143 Employees shall not intentionally cause the interruption of AVL equipment through purposeful acts of negligence or inattention. (Violation subject up to a 1 day suspension.) No

26.2.144 Any employee found to engage in such purposeful acts with intent to deceive the AVL system in order to avoid detection while on duty will be subject to disciplinary action up to dismissal. (New 06/09) No

82.7.62 It is the responsibility of the person assigned to the MDC to immediately inform their supervisor and Information Systems of AVL connectivity problems. If Information Systems determines that the issue requires the equipment to be repaired or replaced, the assignee will bring the equipment to Information Systems for service as soon as possible. No

86-453 (13) Volusia County Merit System Rules and Regulations - Any conduct, on or off duty, that reflects unfavorably on the County as an employer. This violation may be sufficient grounds for disciplinary action ranging from oral reprimand to dismissal, depending on the seriousness of the offense and other circumstances related to the situation.

(See complete transcript – Tab – E)

Lieutenant Eagan contacted Information Systems to verify the work on Sergeant McGuire's computer/AVL and was informed that Information Systems does not keep a log of what computers they have worked on. Info Services Analyst Jeff Hart did not recall whether or not he had worked on Sergeant McGuire's computer and or AVL.

Conclusion:

On April 10, 2012 this investigation was presented to the Sheriff and his administrative staff. After review, the Sheriff determined the violations of the below listed Department Standards Directives to be:

Sheriff Johnson,

It seems that you've had some problems lately with your supervisory staff and their behavior. Since the subject has come up, there are many more within your organization at a supervisory level responsible for similar type behavior.

One in particular, is Sergeant Shon McGuire. He has been involved in an extra-marital affair for several months with the Beach Patrol Officer, Cara Gittner. If you recall, she was the same officer that resigned from the Beach Patrol after being accused of having an affair with Capt. Rich Gardner of the Beach Patrol.

If you were to check the history on his patrol car GPS, you would see that starting in mid to late July of 2011, Sgt. McGuire took his issued vehicle to Officer Gittner's residence, sometimes while on duty at the end or start of his shift.

In my opinion, Sgt. McGuire should not conduct himself in this manner when he expects his Deputies under his command to conduct themselves accordingly.

ADVISEMENT OF RIGHTS FOR A DISCIPLINARY INTERVIEW

I wish to advise you that you are being questioned as part of an official investigation of the Volusia County Sheriff's Office. You will be asked questions specifically directed and narrowly related to the performance of your official duties or fitness for office. You are entitled to all rights and privileges guaranteed by the laws and the constitution of this state and the constitution of the United States, including the right not to be compelled to incriminate yourself. I further wish to advise you that if you refuse to testify or to answer questions relating to the performance of your official duties or fitness for duty, it will be considered an act of insubordination and a violation of a direct order by a superior or competent authority. If you do answer, neither your statements nor any information or evidence, which is gained by reason of such statements, can be used against you in any subsequent criminal proceeding, (**except for perjury or obstruction of justice charges**). However, these statements may be used against you in relation to subsequent department charges.

The aforementioned Advisement of Rights is not the warning in criminal cases under the Miranda decision. As mentioned, Miranda has no application in a disciplinary interview.





Major,

Sorry it took so long to get you this information. As I mentioned we saw some discrepancies and wanted to verify what was happening. We only found AVL data for two days for the addresses provided. Both instances are outlined below and occurred while he was 10-75. I've also attached screenshots of the data.

7/22/2011 (1857 hours) – Arrives and stops in the area of [REDACTED]

7/22/2011 (1911 hours) – Departs the area of [REDACTED]

8/15/2011 (0917 hours) – Arrives in the area. Unsure if the unit stops because the last coordinate reported was heading NW at 33.8 MPH. (see file "1652 2011-08-15 Arrival.JPG")

8/15/2011 (1043 hours) – At the intersection of Dunlawton / US1 in Port Orange. This is the first coordinate received since 0917 hours (see file "1652 2011-08-15 Remainder.JPG")

As you can see, there is an unexplained gap in the AVL data on 8/15/2011. There are a few possible causes for such a gap. For example, we will not receive coordinates if the MDC is turned off, loses satellite signal (e.g. inside a building), or cellular (i.e. Sprint) connectivity. We will also see an interruption of AVL data if the GPS antenna is malfunctioning or is unplugged. In order to help isolate the cause in this case, we looked at the remaining AVL coordinates (see file "1652 2011-08-15 Remainder.JPG") on that date and found the following:

1043 hours – After approximately 86 minutes with no AVL activity, the unit starts transmitting AVL coordinates again at the intersection of Dunlawton / US1.

1054 hours – Last AVL coordinate reported for the day showing the unit heading north at 32.5 MPH on City Center Parkway in Port Orange (i.e. by old POPD location).

1257 hours – Unit runs a tag from his MDC (see file "1652 CAD Unit History 2011-08-15.PDF")

1300 hours – Unit logs out of CAD from his MDC (see file "1652 CAD Unit History 2011-08-15.PDF")

Based upon the above information, I suspect that he is unplugging his GPS antenna. For example, it seems that his MDC was on and he had cellular service during the three minutes when he ran the tag from his MDC and logged out of CAD. Therefore, we can eliminate his MDC being off or no cellular service. If you are inside a building, then it is possible to have a cellular signal, but no satellite signal. However, why would he be running a tag while inside? The GPS antenna could also be malfunctioning, but that is unlikely since it was obviously working earlier. If he is in the habit of unplugging the device, then that may explain why we only saw him in that area on a couple of days. I would suggest that someone start spot checking a few days of his AVL data.

To help identify deliberate attempts to circumvent AVL in the future, I've asked that my staff to begin looking at developing a routine that will log / alert anytime the MDC is on and it does not detect a GPS antenna connected. However, at this time, I don't have a timeframe on when I can get that implemented.







- 03-01-2012 SGT TATUM met with CHIEF COFFIN and completed a cursory search in Force Watch from June 1, 2011 thru February 1, 2012 regarding an anonymous allegation that SGT MCGUIRE was hanging out at [REDACTED]
[REDACTED]
The results of the cursory search in Force Watch did not reveal SGT MCGUIRE on-duty at the alleged address. The complaint was then given to MAJOR JONES for review and action.
- 03-09-2012 LT EAGAN received the anonymous complaint from MAJOR JONES after he met with SGT MCGUIRE and he affirmed that he was having an extramarital relationship with the alleged party. MAJOR JONES concluded the meeting and referred the administrative investigation to Internal Affairs for review and action.

SHERIFF JOHNSON ordered the administrative investigation into the allegation of misconduct by SGT MCGUIRE. SGT TATUM and INV BENNETT served SGT MCGUIRE with his Notice of Internal Investigation.

LT EAGAN received AVL data compiled by SO Info Systems that was originally sent to MAJOR JONES for review.
- 03-12-2012 LT EAGAN reviewed ForceWatch for possible contacts with SGT MCGUIRE at Ms. GITTNER's home, [REDACTED]
[REDACTED] LT EAGAN expanded the search area encompassing the entire peninsula from March 12, 2011 until March 12, 2012. During this query LT EAGAN noticed that on September 19, 2011 then Deputy MCGUIRE drove south on Atlantic Ave. (past the general area where GITTNER lives) and west on Dunlawton Ave. to his home [REDACTED]

INV GABRIEL conducted a drive-by of GITTNER's residence to attempt to verify that she still lives at the [REDACTED] GITTNER's vehicle was not located during this attempt.
- 03-14-2012 LT EAGAN met with County Attorney Nancye Jones to review potential interview questions for SGT MCGUIRE and Ms. GITTNER.
- 03-15-2012 LT EAGAN received a call from County Attorney Nancye Jones and she told him that she did have any concerns with the questions shown to her. She was going to contact Ms. GITTNER's attorney and try to arrange a meeting or obtain a phone number for Ms. GITTNER.
- 03-16-2012 LT EAGAN received an email from County Attorney Nancye Jones forwarding email correspondence between Ms. GITTNER's attorney and

her. Ms. GITTNER's attorney, Melissa MURPHY indicated in the email to Ms. JONES that her client "is declining to be interviewed as a witness."

LT EAGAN attempted to contact SGT MCGUIRE via his department issued cell phone/Nextel and was unable. He left a voice mail message and SGT MCGUIRE returned his call a few minutes later. LT EAGAN set up an appointment for SGT MCGUIRE's interview on March 22, 2012 at 1000 hours.

- 03-21-2012 LT EAGAN completed a sampling of SGT MCGUIRE's AVL (automated vehicle locator) performance during the months of April, May, June, July, August, September, October, November 2011.
- 03-22-2012 LT EAGAN and SGT TATUM interviewed SGT MCGUIRE at the IA interview room. Also present was Teamster Reps Josh Vedder and Bob Walker.
- 04-10-2012 LT EAGAN presented the administrative investigation to the Sheriff and his executive staff.
