DEMAND FOR DISCOVERY

The defendant, through the undersigned attorney, demands discovery, pursuant to the applicable provisions of the Florida Rules of Criminal Procedure, and further demands to be able to inspect, copy, test and photograph the following information and materials within the state's possession or control:

1. The statement of any person known to the prosecutor to have information which may be relevant to the offense charged, and to any defense with respect thereto.
2. Any written or recorded statements and the substance of any oral statements made by the accused, including a copy of any statements contained in police reports or report summaries, together with the name and address of each witness to the statements.
3. Any written or recorded statements and the substance of any oral statements made by co-defendant if the trial is to be a joint one.
4. Those portions of recorded grand jury minutes that contain testimony of the accused.
5. Any tangible papers or objects which were obtained from or belonged to the accused.
6. Whether the state has any material information which has been provided by a confidential informant.
7. Whether there has been any electronic surveillance, including wiretapping, of the premises of the accused, or of conversations to which the accused was a party, and, any documents relating thereto.
8. Whether there has been any search and seizure, and, any documents relating thereto.

9. Reports or statements of experts made in connection with the particular case, including results of physical or mental examinations and of scientific tests, experiments or comparisons.
10. Any tangible papers or objects which the prosecuting attorney intends to use in the hearing or trial and which were not obtained from or belonged to the accused.
11. It is further demanded as soon as practical after the filing of the indictment or information that the prosecutor shall disclose to defense counsel any material information within the state's possession or control which tends to negate the guilt of the accused as to the offense charged.
12. Any copies of transcripts or tapes of any and all radio or video transmissions made on the date involving this crime in connection with this cause, together with the name and address of the custodian of said transcripts or tapes.
