The parties will not interrupt each other, except to make a valid legal objection. If that objection is made in front of the jury, only a brief legal ground for the objection will be stated, for instance, "Objection, hearsay." Any further argument that is necessary will be held outside of the presence of the jury.

The parties shall direct their objections, argument or remarks to the Court and not each other or the audience, nor shall they directly address the jury except during voir dire, opening statement or closing argument.

The parties will refer to each other and witnesses using appropriately respectful methods of address, including "Mr." "Mrs." "Officer" "Deputy" or other titles as appropriate. Improper ridicule, harassment or maligning of witnesses or participants will not be tolerated.

The parties will refer to the Court as "Judge Schumann" or "Your Honor" and not "public servant" or "inferior judge" or in any other manner whatsoever.

These orders will be complied with under penalty of contempt of court. These rules will apply to all court proceedings in this case. If removal of a party becomes necessary for violation of these rules, the trial will continue in the party's absence.
