- LL Why am I out here?
- RG Why are you out here?
- LL Why are we here?
- RG Why are you here?
- LL Because I had an argument with my family a misunderstanding and I shoved my father by mistake and got a little hurt and I didn't mean it and...
- RG And he's over 65 so that made it a felony right?
- LL And I never did anything like that. He didn't fall but you know it's kind of; it was like a heated little argument but...
- RG Yeah but the problem is when they're old like that. What time do you got there son.
- IL 2:32.
- LL It was just a whole family thing.
- RG Ok. Who arrested you?
- LL I don't remember his name it was a young guy. And then he transferred me to a second car.
- RG Ok so what address did you get arrested at?
- LL (address deleted).
- RG (address deleted), and that's with a K right?

LL Yes.

RG (address deleted) ok. And how many deputies showed up?

LL Uh, I believe three cars, two or three cars.

RG Three cars ok, and you were arrested?

LL Yes.

RG And where did you go from there?

LL I went to the fairgrounds with the first officer.

RG Uh huh.

LL And I was switched into a car with another officer.

RG Car or van?

LL Vehicle.

RG Ok, switched at fairgrounds. Ok then you came here?

LL Yes, no.

RG What happened?

LL After I left there he took me across the street. He told the other police officer that he was going to get gas and the other police officer and him went to get gas and I was waiting in the car while they were, he was gassing up but there was two pumps and he waited for the other guy to finish the pump and leave, said "ok bye bye" so the, tells the police officer to leave...

RG Ok slow down, you're at the fair, you meet him at the fairgrounds.

LL I switch cars.

RG Ok, switch at the fairgrounds and then went and got gas?

LL Yeah.

RG Where were the pumps at?

LL Right across from the fairgrounds behind woods and buildings, an abandoned type

area.

RG Ok so the two of them went over there?

LL Yeah then the one waited for the pump to be available when the other one left. He waited a little while for the car to leave, disappear.

RG Uh huh.

LL And then he asked me to step out of the vehicle.

RG So the first car left right?

LL Made a left out.

RG Left, left the pumps.

LL Yeah he made a left out of the area.

RG Ok and then left you alone with the deputy.

LL A older man.

- RG Ok and then what happened?
- LL Then he said "I'm going to release your handcuffs don't fight me, don't hit me, you're not going to hit me right?" I said "no" and then he said "I'm going to switch them up to the front.

RG Uh huh.

LL I said "ok whatever" So um, as he's pumping the gas he tells me to turn around and um, he waited a few minutes he told me just put my hands on the car and that's what I did like he told me there was no one around and he started touching my breast.

RG Ok.

LL Then he went down...

RG After he took the cuffs down?

LL Oh yeah I'm loose now.

RG Ok you're out, you're completely loose?

LL Yeah I'm completely hands on the car.

- RG Ok. Switched cuffs to front. Ok so he didn't switch cuffs to the front he took them off?
- LL Yeah this all happened when my cuffs were off.

- RG Ok. Took cuffs off. Ok so he started to touch your breast?
- LL Yes very hard, not like a patting type searching feeling. Like a fondling type feeling.
- RG Would it be true to say touched and squeezed your breast?
- LL Yes he did.
- RG Ok and how long did this go on?
- LL That went on for about 10 seconds more maybe half a minute?
- RG Ok so 10 to 30 seconds?
- LL Yeah.

RG Ok.

LL And then he started slowly going down my waist, feeling my waist and I knew what he was doing already.

RG Uh huh.

LL Ok I already know what he's doing.

RG He's behind you?

- LL Yeah, and I already know what he was going to do so I got nervous. I didn't say anything, there was nothing I could do at that point. So he started touching my waist and he went down into my pelvic area ok, and then he came back out, started feeling my buttocks and squeezing them and feeling them and squeezing them and feeling them...
- RG From behind?
- LL From behind yeah and he went and he took his hand and he put it in between my legs and felt my private.

RG Ok.

LL And then he...

RG You're clothed?

LL I'm clothed he didn't take nothing off me. But I had no panties on I just had a pajama.

RG Ok so he started touching you thru your clothes?

LL Yeah then he didn't search my legs, I had socks on.

RG Uh huh.

- LL After he was done with what he was going to do he told me to turn around and he looked at me up and down and he looked inside of my breasts and that's when I said...
- RG Did you have a bra on?
- LL Yes I did but I had a low cut t-shirt on.

RG Ok.

LL And then he um, he handcuffed me in the front. The first officer handcuffed me in the back.

RG Ok.

LL He cuffed me in the front.

RG So after he got done for lack of a better term feeling you up...

LL Then he was trying to be nice to me, telling me everything's ok...

RG Cuffed you in the front.

LL ...you'll be alright, he cuffed me in the front, put me back in the car and started talking all nice things to me acting like I didn't know what he had done.

RG Ok.

LL And I'll take a lie detector test right now if I have to.

RG Alright, did he, so he never had sex with you as far as...

LL No he didn't have sex with me he just felt.

RG Ok did he ever play with himself? Did he ever get you to touch him?

LL I didn't see what he was doing, he didn't, I couldn't look back.

RG Ok. Alright and then this whole time gas is running in the car?

LL Uh huh.

RG Ok.

LL I think I'm not sure. I know, I know that the thing was still in the, I don't know if the gas was going thru but I know the thing was in there.

RG Ok describe the process of him trying to gas up.

LL He had to press buttons.

RG Ok so he pressed buttons.

LL The other officer left.

RG This is across from the fairgrounds?

LL Yeah.

RG Ok.

LL There was two pumps, they were white and gray.

RG Ok, so this whole thing for about 10 to 30 seconds he's touching your breast, squeezing your breasts as you worded it and then he stands you up, does he put your hands on the car?

LL When it all started and everything and he uncuffed me...

RG Uh huh.

LL Yeah he grabbed me by my arm, he wiggled me a little bit and then he said "just put your hands on top of the car" and I said "ok" and then he never cuffed me he, that's when he started doing the whole thing.

RG Ok.

LL Then when he was done...

RG Did he say anything to you?

LL No.

RG Didn't say sweet nothings or nothing?

LL Nope, not a word, just did what he wanted to do.

RG And then when you're done he put you in cuffs in the front?

LL Yep and then he tell me "oh what happened? You know you can get away with

this" and all nice stuff, all nice stuff, sweet talking me then.

RG Did he ask you for sex?

LL No he didn't.

RG He didn't ask you for oral sex?

LL No he didn't ask me for oral sex he didn't do any of that but he did, he did touch me.

RG Did you say anything to him?

LL No. I, I stood quiet until I got here.

RG Ok.

LL Because I was scared I was in the woods like you know the area where the...

- RG Ok let me ask you this. From, how long did it take to go from your house where you were taken into custody to the fairgrounds?
- LL Um, well I live at (address deleted) and the fairgrounds are all the way over there, it must have taken about 20 minutes, 15-20 minutes.

RG Ok. Did the deputy do the paperwork at your house or did he do the paperwork

that, you know the arrest affidavits and such...

LL Everything was done at my house, paperwork, the computer everything.

RG Ok so then it was just a matter of he called for the PT unit...

LL To switch.

RG ... and went to the fairgrounds to meet you.

LL Right.

RG Now when you got to the fairgrounds was the PT unit already there?

LL Yes waiting.

RG Ok so he was there waiting.

LL Uh huh.

RG And the trip there is only one deputy, so now it's only the two of them?

LL Right.

RG Two deputy cars and yourself?

LL Yes.

RG They exchange the paperwork.

LL Right quickly.

RG Ok well it's a quick process.

LL Yeah.

RG And then from, straight across the street?

LL Uh huh.

RG Now, the pumps, where are they?

LL Across the street?

- LL Yeah all I know is that I believe we went across the street, across, yeah it was across the street because there was a blue sign I don't remember what it says but yeah 44, we were by 44. Its right across the street from the fairgrounds is where he took me.
- RG Ok so it's on 44 not across um, wait a minute what's that street that runs behind the fairgrounds?
- LL I'm not sure what that street is.
- RG Goes into Deltona.
- LL Yeah that one that runs in and out of Deltona.
 - 8

RG That's how you got to the fairgrounds.

- LL That's the big highway to and go yeah, uh huh.
- RG Ok, 44 runs between Deland and New Smyrna.
- LL No, no not that one, the one, right on the fairgrounds there's a two way...

RG Uh huh.

LL He went right across that road there was a blue sign, I don't remember what the words of it said.

RG Uh huh.

- LL They both went around the back, made a right into it there was a gate it was empty. The first officer got gas he pushed the buttons, left, once he, because what I don't understand if there was two pumps why didn't they get gas, why didn't he get gas on each pump if there's two pumps? Why would he wait?
- RG One's diesel and one's...

LL Oh ok that's probably (unintelligible). So as soon as that cop took off and turned the corner, he made sure he was gone.

RG Uh huh.

- LL That's when he pulled me out of the vehicle and he started pumping his gas.
- RG Ok it's Wednesday, mid week, I take it that this location is what do you know where the pumps are right there across from...

IL I've only been there one time.

LL 10:01(Unintelligible) pumps by the (unintelligible)

RG Is it a weigh station for the refuse or is it vehicle maintenance?

IL I'm not sure what's all back there. The pumps is (inaudible) back there.

RG What kind of trucks did you see?

LL I could have sworn it was by the old, I don't remember TG Lee, I was so nervous.

TG Lee where it goes where the um, Brighthouse cable used to be back there somewhere.

RG Across from the fairgrounds?

LL No it wasn't that way, that was the way that we were coming from.

RG That's 472.

LL That was when the other guy had brought me here.

RG Ok now when you left the fairgrounds.

LL There was a lot of people in the fairgrounds now they're having an affair, a big affair a lot of people.

RG Well they're having the.

LL It was right across the street.

- RG They're having the flea market, it's a Wednesday flea market farmers market whatever you call it.
- LL Right.
- RG Now where the pumps were you didn't see any trucks? County trucks?
- LL I believe I did see trucks, I did see trucks and fencing but on the other side on the left hand side.
- RG They weren't moving?
- LL No, there was nobody around there was no people there was no one.
- RG Ok when you left the fairgrounds what route did they take to come to the jail?
- LL He made a right to the jail. I really don't remember I was really nervous I wasn't looking which way he left.
- RG Got on the interstate?
- LL No he didn't.
- RG He didn't take I-4?
- LL Take I-4? I don't remember I'm really not too sure I'm not thinking I was so nervous I kept my head down the whole time. He was talking to me a lot, a lot, a

lot, a lot. Yeah we got here, when we got here, did he take I-4? I don't remember getting on I-4, no not at all. Someway somehow I don't remember getting on I-4. RG The reason I say that is because it's a 20 minute drive.

- LL No he didn't get on I-4 he went thru streets I believe because I don't remember being on that interstate, I would have known.
- RG This is very important. The reason I ask, you're familiar with GPS?

LL Yeah.

RG The GPS gives us start time, down time and route.

LL Right.

RG Ok, so what it is I believe the other deputy, can you describe the other deputy I'm trying to figure out which one took you what he looked like.

LL He was young.

RG Young.

LL Um, long kinda face.

RG Is he fatter than me?

- LL No, thinner, like him.
- RG He's thinner than me?
- IL Yeah just a little bit.
- LL Yeah a little bit!
- IL Just remember that.

RG Thanks, thanks a lot! Ok, you're scoring points with me, ok, alright um...

LL When he walked away I looked at his name badge I think it said Bradford or something like that, Watford.

RG Ok, basically you get arrested at about 7:30 this morning does that sound right? LL Right.

- RG Scene secure. Well they probably secured you at 7:30 they called a different time for that you're in custody, and then you're probably there how long do you think you're at your house with him doing paperwork?
- LL My kids left at um, lets see 8:30, I remember I was there from 7:45 till 8:40 in front of my house because I kept looking at his computer.

- RG You could read his computer from the back seat?
- LL Uh huh, everything.
- RG Alright, do you remember the deputies name did you ever hear his name?
- LL Of the first one?
- RG Second one.
- LL I believe his name was Bradford or Watford.
- RG And you said that the guy who took you was already waiting at the fairgrounds?
- LL Uh huh, yeah he was waiting.
- RG How long was he in the lock up down here with you before they let him out the door?
- LL He wasn't there very long. He must, he came in, dropped me and stood there about 10 minutes and left, not even.
- RG Well that didn't turn out very well. I basically before I ran out I tried to get an idea of what was going on and I went ahead and printed up a map.
- LL Ok.
- RG I just don't think it came out very well because it kind of cuts it off. But once you leave from the fairgrounds you come out here to I-4, take I-4 to 92 in to the jail. Or you'd have to cut all the way back thru town all the way thru to 92 and then
 - down.
- LL Where's the fairgrounds at?
- RG Right here at 44, East New York Ave is Hwy 44.
- LL Uh huh, uh huh, yeah he didn't go that way.
- RG 44 and I-4. Now this way is about 40 miles.

LL Uh huh.

- RG Now do you remember...
- LL No he didn't go that back way.
- RG So you didn't remember a big lake? So you probably took the interstate.
- LL He did take us that way yeah.
- RG So he did take the interstate?
- LL Yeah that's the way he went.

RG Ok.

- LL I just was so nervous I had my head down I wasn't even looking. But all I know is that from that route we came from the gas pumps we came straight here.
- RG Ok the next question is very important. It determines whether, it's noisy as shit out there. Um, he touched your breast.
- LL Yes.
- RG Are you comfortable talking to me?
- LL Yes.
- RG Ok good. He touches your breast.
- LL Right, yes he did.
- RG And when he has, you turned around basically with your hands on the car almost like a search incident to arrest ok.
- LL Right.
- RG Which we would do for checking you for weapons, drugs, anything else you're not supposed to bring out here.
- LL Right but I had already been arrested.
- RG Ok, you've already been arrested.
- LL Uh huh.

RG Let me tell you how it works though. Each deputy along the line from the arresting deputy, I may turn you over, lets say I arrest you.

LL Uh huh.

RG And lets say I turn you over to Inv. Lamee. He is trained, no matter how much he trusts me; he is trained to search you again.

LL Right.

RG And then the prisoner transport unit which is the deputy that is being accused of this, he is supposed to search you again.

LL Yes.

RG Should he have taken your cuffs off? Hell no. Should he have searched you again in the presence, the way it's supposed to be done he should have searched you again in the presence of the first deputy.

LL Right, that's what I think.

RG Um, those are policy issues. We're looking at criminal issues here. Now when he turns you around he's gone ahead and taken your cuffs from the back...

LL Uh huh.

RG ... to the front. And then he takes them off again or he leaves them off?

LL Leaves them off.

- RG Ok so when he uncuffs your back he lets you sit there with your cuffs off now he's completely taken the cuffs off now?
- LL Yeah he told me to relax myself.
- RG So you're free of both of them?
- LL He is letting me do whatever I want with my hands, he's telling me "relax your

hands, move your wrists around, take it easy" this that and that's what I did. And I stood there and waited.

RG Ok. So and then he before you get back in the car he goes ahead and he's searching you down again, he's taking liberties.

- LL No when he, when he took my cuffs off he gave me a minute to loosen up my hands and he waited a little bit and I noticed he was like looking at me and he says "turn around" so I said "ok" so he said "when you turn around put your hands above, on top of the car" I said "ok"
- RG And how tall are you?

LL I'm 5' 7"

RG So you're having to reach up top of the car?

- LL Yeah I was right on top.
- RG Ok so you're at the door, you're...
- LL I'm at the back door right out the back door the door's still open.

RG Ok go ahead.

- LL And I had my hands up like this and he just told me spread my legs just a little bit he didn't say a lot so I went like that and when I was like that that's when he (unintelligible 19:53) I didn't hear, I didn't see, he wasn't doing anything I thought maybe he was filling up the pump and that's when he started.
- RG Ok. So we assume that...
- LL And he didn't go down my legs.
- RG We assume that if he gassed up he's gassing up as he's doing this.
- LL Yeah.

RG How long do you think from the deputy taking off, i.e. the witness we'll call him

to you getting your cuffs put back on on the front?

LL Completely?

RG Uh huh. To hitting the road.

LL Maybe about a good 10 minutes 5 to 10 minutes.

RG How long do you think we've been here talking?

LL About 5 to 10 minutes.

RG Lets see. Well that doesn't help me. It starts backwards and works forward so I

don't know, since I don't start, but I can check that.

LL Well it took him enough time to feel...

RG So 68:11...

LL ...me from here to here.

RG Ok did he ever put his hands in your pants?

LL No but he did put his hands between my pants.

RG Ok did he ever, damn how do I word this? Did he ever...

LL He tapped me like this on the back.

RG Did he ever touch your privates without a barrier of clothing between?

LL No.

RG Ok.

LL Everything was done with my clothes on.

RG Did you tell him to stop?

LL Well I was going to when he did because I was already starting to notice when he got to here and he got in between my legs and he went like that I popped up a

little bit and I looked at him like hey! And then he let go and then that's when he handcuffed me and put me back in the car and started talking nice to me.

RG Were you stiffing up?

LL Yeah I stiffened up.

RG So he should have sensed that you were not compliant.

LL When he touched my bottom.

RG Ok.

LL Like the top I didn't think anything of I thought that was normal ok but when he started squeezing and I said hmm, this one is doing something to me. Now when he went down and he started getting the whole jiggy jiggy thing I know he was going for the middle and he did. He actually this is me, these are my two cheeks,

this is my middle and he went like this to me...and then with the right hand he went...

RG No I'm not going to use you, um...

LL Not really hard, he didn't do it really hard.

RG Sometimes when I have a battery...

LL He did it like.

RG He was being gentle.

LL Yeah he didn't want me to realize what he was, or think what...

RG Do you think he was getting excited?

LL Yeah I do. I think he was getting excited the minute he told me to get out of his car.

RG Did you notice if that pumps there also have cameras?

LL I hope they do.

RG But did you notice I mean?

LL I didn't look.

- RG Because I don't want to trip somebody up instead of asking the question.
- LL Because I was facing to the, I was facing towards the woods the pumps were behind me and then there was, yeah there was trucks to the right that I do remember but in front of me there was more gravel than woods.

RG Ok.

LL But there was no people, it was really lonely.

IL (inaudible)

RG Alright. Did you say you pulled all the activities?

IL (inaudible)

RG Did anybody else come in to gas up while you were there?

LL No one. No one at all came in. It was just the two of us.

RG Let me ask you this.

LL Ok.

RG Is there any, first off let me tell you. I don't like when cops get falsely accused,

hear me out first.

LL I will.

RG What I hate second, I hate dirty cops. You ask 90% of the cops out there and

they'll tell you it's the worst thing, a dirty cop.

LL I know.

RG So what I need to ask you ok, because I've never had any negative contact with

this deputy.

LL Ok.

RG Ok, and I'm assuming we're talking about the same deputy ok?

LL Alright.

RG If I don't have any images out there, close your eyes and think. Did you see any

other vehicles...

LL I did.

RG ... come into that complex.

LL Oh come in to the complex?

RG Something with a body behind it. You know drivers.

LL There was trucks on the right I believe there was white trucks with the rig.

RG On the road?

LL It was one truck with a rig and it had a, um, stairs that go up.

RG Ok how long have you lived in Deltona?

LL 10 years.

RG So you lived there when it was county?

LL Uh huh.

RG Before it had the city of Deltona.

LL Right.

RG You know what the county trucks look like and stuff. White with a little round

sticker.

LL Right.

RG You didn't see any of those being driven?

LL Nothing, there was no one around there really wasn't.

RG Did you drive thru gates?

LL Yes.

RG Ok.

- LL Yes we went thru gate.
- RG Because everything, everything gas wise is automated so I can see if he gassed up.

LL Yeah he did.

RG I'll see if the other deputy gassed up which he did.

LL They did.

- RG I'll be going thru all that.
- LL And the, the gate was open.
- RG Ok. Another issue that we have, now this whole thing takes 5-10 minutes.

LL Right.

RG It's a 14.5 mile drive, let me not misquote myself here. 14.5 miles, 19 minute drive so probably really only 15 minutes, because we're talking 75.

LL Yeah.

RG If, do you remember him talking on the radio?

LL Only when I was coming in.

RG Coming into here?

LL Coming into I think he was talking on the phone, I think something about a female deputy, a female to him was told to him we're going to meet a female deputy something like that. A female, I'm bringing in a female and that's all I heard.

RG Ok. Alright, what's your bond set at do you know?

LL (inaudible)

RG They're doing DV aren't they?

LL Yeah.

RG You have to see the judge first.

LL I saw him.

RG You already did?

LL Uh huh.

RG What did he do?

LL Go home on my own recognance.

RG Ok so when we get done you'll be probably setting up to get your property back.

LL I hope so because I'm ready to go.

RG Who's picking you up?

LL I couldn't make a collect call thru the phones. They wouldn't let me call, I mean I

couldn't call.

RG I think that the pre-trial release people...

LL Please...

RG ...will make calls for you.

LL Ok.

RG A lot of people have a problem with the phones not accepting collect calls.

LL Right.

RG Ok. What we're looking at here if charges are developed, we'll take care of the criminal part.

LL Ok.

RG Now what we have here is basically lewd and lascivious.

LL Right.

RG We don't have a sexual battery.

LL Uh huh.

RG Difference being sexual battery has to be some type of penetration.

LL Right.

RG Um, actually let me look that up some more, touching of that area and stuff. May as well look, the laws change every year. And what will happen and you'll probably be contacted later.

RG How do we go about contacting you later?

LL At the same address and same phone number, I'm always that's been my home phone and address for years.

RG Ok? In his mind he might be thinking he hasn't done anything wrong ok?

RG If, chances are you may have an injunction that you know a judge is going to put a no contact order with your parents because of what's happened...

LL No, I don't have that.

RG ... at which time. You don't? May I see your paperwork?

LL Sure.

RG This is what they've just given you?

LL Yeah.

LL Yeah.

RG Circuit pre-trial supervision order, the victim is (father's name deleted) your father?

LL (deleted medications history).

RG And what's that for sweetie.

RG Ok have you ever been diagnosed with paranoid schizophrenia?

RG No, have you ever been diagnosed with attention deficit disorder?

LL No I only have menieres disease which comes from the ear which causes vertigo.

RG Ok well vertigo just means you can't (unintelligible) hardly, you'd get dizzy and

fall right?

LL Yes.

RG Ok, you may have peaceful non violent ok, so you're gonna be unless you, something else happens between you and your father or you and your mother you can be contacted at (deleted address).

LL Yes.

RG What's your phone number?

LL 386-xxx-xxxx (deleted phone number)

RG Can you document those contact numbers and such?

RG What's the report there we have?

IL This is from the jail.

RG Jail, putting things together. Ok this is, is this your cell phone?

LL That's the house phone I don't carry a cell phone.

RG You don't carry a cell phone?

LL My daughter, my daughter carries a phone.

RG How old is she?

LL 16.

RG 16?

LL Uh huh.

RG She doesn't know any of this yet right?

LL No, nothing.

RG Ok. You have a card, you have cards with you?

IL No.

RG (unintelligible) card, realtor's card, doctor's card, some partner you are you didn't

remind me to bring my cards with me.

- IL I might have one actually.
- RG This is going to reflect in your evaluation.

IL Here.

RG And we did draw a case number right?

IL Yep.

RG That's his name.

LL Ok.

RG Just ignore that, I'll put my name on here too ok?

RG Since I have a longer more dignified name than his I have to go two lines ok?
