Good afternoon Special Agent Kriegsman,

I am writing this request to you today based on the fact that the Port Orange Police Department, under former Chief Thomas Grimaldi, refused to conduct an investigation on the suspected exploitation of David Fouts by his adult children. In my email correspondence with Chief Grimaldi, he claimed the reason the Department would not

investigate the exploitation of David Fouts that occurred within the jurisdiction of Port Orange was that FDLE had already conducted the investigation and found no evidence. The only two investigations I was aware of were OR-14-0156 (part 1 and 2). To be thorough I requested via a public records request asking for the FDLE investigation into the exploitation of David Fouts by his adult children from the City. I was provided with OR-14-0156 (part 1 and 2). An in depth review of the FDLE investigation indicated no mention of investigating whether or not there was any exploitation of David Fouts by his adult children. The scope of these two investigations was clearly limited to forgery and perjury with Captain Kilpatrick as the subject of the investigation.

In an effort to make sure that my reporting of a suspected felony exploitation of a vulnerable adult was intentionally not being investigated I wanted to ensure that your agency had not in fact conducted an investigation into the exploitation of David Fouts. I am formally requesting any investigations (investigative narrative) conducted by FDLE regarding the exploitation of David Fouts by his adult children (Kevin and Alexa Fouts). If no record exists please advise. Thank you in advance for your time and assistance.
